Admissions into Post Graduate Medical and Dental Degree/Diploma Courses for the academic year 2022-23 in the State of A.P.

Inviting online application forms and Uploading of scanned documents for Verification.

Online Application forms are invited from the eligible candidates for admissions into Post Graduate Medical and Dental Degree/Diploma courses under State Quota/Competent Authority Quota seats for the academic year 2022-23 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada and Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati.

1. **ELIGIBILITY**:

- I. Candidates should have passed MBBS/BDS Degree examination from a recognized Medical college/Dental college/University.
- II. Candidates should have secured the cut off scores in NEET PG-2022/NEET MDS-2022.
- III. The candidates should complete their internship by
 - For PG (Medical) Courses 31-05-2022
 - For PG (Dental) Courses 31-03-2022
- IV. The candidate should fulfill the local area status as mentioned in the Prospectus.

2. Service Candidates for PG Medical/Dental:

As per G.O.Ms.No.150, dt.11-12-2021 of HM&FW(C1) Dept., Government of A.P, the following are the rules for implementing reservations in case of In-service candidates:

- Out of 50% of the seats in State Government quota, 30% of clinical & 50% of nonclinical seats will be exclusively allocated to in service candidates serving in Government Health Institutions in the State of Andhra Pradesh.
- The Penalty of indemnity bond shall be @Rs.15 lakh per year for non-rendering services after completion of PG Medical/Dental course for in-service candidates.
- In case of an In-service candidate, in the event she/he leaves the course before its completion or the competent authority concludes that the In-service candidate has not shown sufficient progress in the studies or has failed to complete the course in proper time or fails to resume duty even after the expiry of the termination of the period of deputation or at any time within a period of 10 years after the completion of the higher studies, it shall be lawful to the Government to make recovery of the amount (including pay and allowances, stipend, DA, tuition fee etc., along with penalty and applicable interest) spent on higher studies or specialized training from the salary of the candidate.

As per G.O Ms.No.206, dt.11-08-2022 of HM & FW (C1) Dept., Government of AP, the following rules are followed:

- In Tribal areas: Minimum 2 (two) years of regular and continuous service in PHCs/CHCs/Area Hospitals/District Hospitals/Sample Survey cum assessment units/Leprosy temporary hospitalization wards & any Tribal Institute recognized by Government of Andhra Pradesh.
- In Rural areas: Minimum 3 (three) years of regular and continuous service in PHCs/CHCs/Area Hospitals/District Hospitals/MCH/Sample Survey cum assessment units/Leprosy Control Units/Leprosy temporary hospitalization wards/Mobile Medical Units & any Rural Institute recognized by Government of Andhra Pradesh.
- Minimum 6 (six) years of continuous regular service in AP Medical&Health Services/APVVP/AP Insurance Medical Services/University of Health Sciences.
- After completion of specialization, the in-service doctors to be available to serve in Government facilities in the same area (Tribal/Rural/Continuous regular service) from where the reservation was sought, to a minimum of six (6) years, subject to the availability of vacancies in respective specialities, through a bond.

Note: service rendered up to **31-05-2022** will be considered.

3. Application, Registration and Processing Fee:

- 1. OC & BC Candidates ₹.7,080/- (6,000/- + 1,080/- GST 18%) (Registration fee ₹. 3,500/- + 630/- GST 18% & Processing fee ₹.2,500/- + 450/- GST 18%).
- 2. SC & ST Candidates ₹.5,900/- (5,000/- + 900/- GST 18% (Registration fee ₹. 3,000/- + 540/- GST 18% & Processing fee ₹.2,000/- + 360/- GST 18%).

Verification Fee: In addition to the above said Registration & Processing fee:

- 1. The candidates who acquired their MBBS Degree outside the AP/TS State shall pay Rs.3,540/- (i.e., Rs.3,000/- + 540/- GST 18%)
- 2. The candidates who acquired their MBBS Degree in Abroad/Foreign Country shall pay Rs.8,260/- (i.e., Rs.7,000/- + 1,260/- GST 18%)

Note:- Fee once paid will not be refunded (or) adjusted under any circumstances.

4. Procedure of filling online application form and payment of fee through online.:

- a. The fee can be paid through Debit card / Credit card or Net Banking.
- b. Read the Notification, Prospectus / Regulations carefully regarding eligibility under local and non-local areas.
- c. The Registration number which will be sent to the registered mobile number after entering the basic details, should be noted for further use. The Registration number should be kept confidential and should not be disclosed to others.
- d. The candidates should fill in all the correct details in the online application form and shall upload all the **scanned Original documents** including the certificates which are mandatory.
- e. The following Certificates are required to complete the online application process. The certificates are to be scanned and kept ready to upload. Application fee has to be paid through online.

5. Instructions to the candidates:-

- a. The candidates are advised to download and read the Prospectus of the course and instructions for filling Online Application available in the University Website http://ntruhs.ap.nic.in before filling the online Application.
- b. The process of admissions into PG Medical/Dental Degree/Diploma Courses will be in accordance with the Orders issued from time to time by NMC, New Delhi and Govt. of A.P.

Note: The orders of Govt. of Andhra Pradesh if any received after the Notification will also be implemented from time to time.

- c. Scrutiny of uploaded documents/data will be conducted by the Officials of the University and other Officials from the concerned Departments. After the scrutiny of scanned documents then provisional merit list will be released and then after final merit list will be released.
- d. No separate notification will be given for verification of Original certificates.
- e. The candidates claiming reservation under PwD category are advised to watch the University website for further notifications and they must be physically present before the Medical Board constituted by Dr.NTR UHS, Vijayawada.
- f. The On-line application form with the following lacunae will be rejected automatically. No communication will be sent in this regard.
 - i. If any of the mandatory certificates are not uploaded.
 - ii. Applications with incomplete details / photo and signature.
 - iii. If any of the uploaded certificates are invisible/not properly uploaded.
 - iv. If the certificates are not properly scanned due to which the eligibility criteria cannot be determined.
- g. The candidate should produce the Printout of the filled in Online application form, Provisional verification form and all Original certificates along with One set of self-attested Copies to the Principal of the allotted college at the time of joining for final verification. In case of any discrepancy, the Provisional allotment order will be cancelled without any notice. The candidates are informed not to send the print out of application form to the University.
- h. Candidates admission is strictly provisional. The mere fact that the Merit position issued to him/her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the online application are accepted as true and correct. If any in-eligible candidate is present in the Merit position shall not be eligible for admission.
- i. If the information furnished by candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken. If the certificates produced by any candidate are found to be fake/false/forged at any stage of verification or admission, the University has every right to cancel the seat / admission of such candidate without any notice. In case of discrepancy in the downloaded provisional verification form, the same shall be brought to the notice of the University immediately.
- j. Candidates are informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action shall be initiated as per Rules.
- k. Area wise seat matrix will be displayed in the University Website for the information of the students.
- 1. Subsequent notifications with regard to the counseling/allotments will be notified on the University website only. Visit the University website http://ntruhs.ap.nic.in regularly for subsequent notifications/instructions/allotments till the completion of admission process. No individual intimation will be sent in this regard.
