**REGULATIONS:**

1. The following regulations shall apply for admission into M.Sc., (Nursing) courses available in the Colleges in Andhra Pradesh for the academic year 2023-24.
2. **Number of Seats:** The number of colleges and seats for admission into first year M.Sc., (Nursing) courses for the academic year 2023-24 Annexure VII.

**Note: a) In case any new Colleges/Courses are affiliated to the University for starting the M.Sc., (Nursing) Courses for the academic year 2023-24, those seats will also be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.**

- b) Some of the Colleges have given willingness to admit both male and Female candidates and the seats for male candidates will be allotted as per rules.
- c) The selections will be made to the above colleges subject to affiliation for the academic year 2023-24.
- d) As per G.O.Ms.No.338, HM & FW Dept., dated 16-08-2008, if sanctioned intake capacity is odd number, equal seats will go to management quota and Competent Authority Quota and odd seat will be rotated between the management quota and Competent Authority quota year after year.
- e) The seat matrix will be displayed at the time of counseling.

**3. ELIGIBILITY:**

3.1 The Candidates should be Indian National and should satisfy Local or Non-Local status as per G.O.P. 646, Education Dept., dated 10-07-1979 and must satisfy the eligibility criteria as noted below:

S.No		Eligibility Status
a)	Age:	Both the Service and Non-service candidates should not have completed 45 years of age as on 31 <sup>st</sup> December of the year of admission. For candidates belonging to SC and ST's the maximum age limit shall be 48 years.
b)	Sex	Both women and men candidates are eligible to apply for the M.Sc (Nursing) as per GO .Ms. No. 77, HM & FW (K1) Dept, dated 13.06.2013. Regarding male candidate, admission will be as per G.O.Ms.No.79, HM & FW (K1) Dept, dated 17.06.2013.
c)	Educational Qualification	The candidate should have passed B.Sc., (Nursing) /B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) from an Institution which is recognized by the Indian Nursing Council with minimum of 55% aggregate marks and 5% relaxation of marks for SC and ST candidates.

d)	Merit list	<p>a. The selection of Candidate will be made by the selection committee as per the merit list.</p> <p>b. The merit list will be prepared basing on the marks obtained in B.Sc(N)/ B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) group subjects (all subjects) up to two decimal places excluding Computer sciences and English marks.</p> <p>c. <b><u>As the Merit list will be prepared basing on Group subjects, the candidates while filling up of Online application, shall enter the total marks excluding English marks &amp; Computer Science Marks as the case may be.</u></b></p> <p>d. In case of equality aggregate marks, age shall be taken into consideration and older candidates shall be given higher places in the merit list.</p>
e)	Registration with Nursing Council:	<p>Candidate should be a Registered Nurse and Registered Midwife of Indian Nursing Council / State Nursing Council for Service and Non--Service candidates.</p> <ul style="list-style-type: none"> <li>• In case of B.Sc., (N) candidates, those who registered in Nursing council prior to 31.10.2022 are only eligible. Those who registered after 31.10.2022 are not eligible for this academic year 2023-24.</li> <li>• In case of Post B.Sc., (N) candidates those who registered in Nursing council prior to 31.10.2023 are only eligible. Those who registered after 31.10.2023 are not eligible for this academic year 2023-24.</li> </ul>
f)	<p><b>Experience:</b> 1. <u>For Service Candidates:</u></p>	<p>Should be a regular employee of the Government of AP/Telangana as per the para 12 of AP Education Institutes (Regulations of Admissions) order 1974 (AP Medical &amp; Health Services and AP Vaidya Vidhana Parishad / Telangana Vaidya Vidhana Parishad) and should have put in not less than 5 years of Service in the said Dept., in any capacity in Nursing as on <b><u>31-10-2023.</u></b></p>
	2. <u>For Regular Candidates (Non Service candidates):</u>	<p><b>a)</b> Minimum one year of work experience after Registration of B.Sc., (Nursing) Degree in Nursing council as on <b><u>31-10-2023</u></b> is <b>required</b>. That means the candidates who registered in Nursing council as on 31.10.2022 are only eligible and those who registered in Nursing council after 31.10.2022 are not eligible as they will not complete one year experience by 31.10.2023.</p> <p><b>b)</b> Minimum one year of work experience prior or after Registration of Post Basic B.Sc., (Nursing) courses as on <b><u>31-10-2023.</u></b></p> <p><b>Note:</b> Experience Certificate once submitted is final. No alterations/ no Revised service certificate will be accepted after submission of application. The candidates who have not acquired relevant service and not submitted requisite service certificate, such applications will be rejected and no further correspondence will be entertained. Therefore, candidates are advised to check the application before submitting.</p>
g)	Physical fitness	The candidate shall be medically fit.

h)	<p>i. The candidates who qualified Post Basic B.Sc., (Nursing) from IGNOU through distance education are also eligible, <u>if the study centre is recognized by Indian Nursing Council.</u></p> <p>ii. The candidates, who completed Post Basic B.Sc., (Nursing) from any IGNOU study centers can make application for admission into M.Sc., (N) course provided they have taken admission in IGNOU study centers prior to year 2012. The students who have undergone P.B.B.Sc.,(N) course from IGNOU after this date are eligible for admission into M.Sc.(N) only if the study centers are recognized by IGNOU.</p>

#### 4. SERVICE QUOTA:

As per the G O. M S. No. 156, dated. 08.12.2016 of HM & FW (E), Dept., Govt. of AP, Velagapudi, Andhra Pradesh, 40% of seats out of total number of seats available at Sri Padmavathamma Government College of Nursing, Tirupati, and 40% of seats available at Govt. College of Nursing, Kurnool as per G.O.M.S No.86, dt. 07.08.2019 will be allotted for service candidates.

- 4.1 The quota for in-service Nursing Personnel admitted to M.Sc., (N) course in Sri Padmavathamma Government College of Nursing, Tirupati and Government College of Nursing, Kurnool shall be allowed up to 40% and the period of their study shall be treated as "Deputation". The selected candidates should submit orders of deputation from their respective state Government.
- 4.2 The period of required service in the Government for making application to the M.Sc., (Nursing) course is (5) years.
- 4.3 In the event of leaving the studies during the course period (or) in case of failure to serve the Government for (5) years after completion of the M.Sc., (Nursing) course, the individual has to pay an amount of Rs. 2,00,000/- (Rupees two lakhs only) besides refund of the amount received as salary up-to the date, to the Government.

#### 5. RESERVATIONS:

##### Reservation for Scheduled Castes (S.C.) and Scheduled Tribes (S.T.):

**A) Out of the seats available for admission by the University, 15% seats shall be reserved for candidates belonging to SC, 6% of seats shall be reserved for candidates belonging to Scheduled Tribes in each local area.**

- i) In the event that if any seats reserved for S.T. not being filled up, they will be open to the candidates belonging to the Scheduled Castes and vice-versa.
- ii) In the event of the candidates from the SC and ST are not being available, these seats shall be allotted to the candidates under open competition.
- iii) Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Andhra Pradesh only which are specified by the Govt. of A.P from time to time shall be considered

## **B) RESERVATION FOR BACKWARD CLASSES:**

29% of the available seats for admission in each local area by the University for shall be reserved for candidates belonging to Backward Classes as follows:

BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E\*-4% (\* Subject to further orders of the Government of A.P. / High Court).

If qualified candidates belonging to Back Ward Class of particular group are not available, the leftover seats can be adjusted for the candidates of next group. If qualified candidates belonging to Back Ward Classes are not available to fill up the 29% seats reserved for them, the left-over seats shall be treated as Open Competition seats and shall be filled up with candidates by merit.

### **5.2. SOCIAL STATUS CERTIFICATE:**

The candidates belonging to Scheduled Castes, Scheduled Tribes and Backward Classes shall furnish a certificate in the prescribed proforma in support of their claims. The social status of Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be Scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997.

The candidates are informed that they will not be considered for the caste claimed by them unless they upload the latest **Integrated Community Certificate**, prescribed by the Government and issued by the Revenue Authorities (Vide G.O.Ms.No.58, Social Welfare (J) Department, dated. 12-05-1997) with barcode. (Annexure-II)

**Note :-** The Social Reservation provided for BC's SCs, ST's in the ratio of 29%,15% and 6% respectively shall be vertical reservation.

### **5.2.(I) RESERVATION UNDER PwD CATAGORY:**

Out of the available seats for admission, 5% shall be reserved for the Physically Handicapped (PwD) in each category of OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board to be constituted by Dr. YSR UHS. The candidate shall submit a PwD certificate issued by a Medical Board, comprising of at least one Expert/Specialist from the specialty of Orthopedics of Medical Board and obtain a valid disability certificate from the Medical Board having been issued within three months prior to presenting his application for seeking admission in any medical course by claiming the benefit of reservation.

### **5.3 RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES:**

5.3.1 Admission to 85% of Non-Statewide seats in each course of study shall be reserved in favour of the local candidates in relation to the local area. While determining 85% in favour of local candidate any fraction of a seat shall be counted as one as per the presidential order. The procedure as provided in A.P. Educational Institutions (Regulation of Admission) Order, 1974 as amended from time to time and the procedure indicated in Annexure-III of G.O.P. No.646 Education, dated 10-07-1979 as amended shall be followed in selecting the candidates. The remaining 15% Seats are unreserved seats.

#### **5.4 LOCAL AREA:**

- 5.4.1 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as local area in respect of the Andhra University and Nagarjuna University area for the purpose of admission.
- 5.4.2 The part of the State comprising the Districts of Adilabad, Hyderabad (including twin cities) Rangareddy, Karimnagar, Khammam, Medak, Mahaboobnagar, Nalgonda, Nizamabad and Warangal shall be regarded as local area in respect of Osmania University and Kakatiya University area for the purpose of admission.
- 5.4.3 The part of the State comprising the Districts of Ananthapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as local area in respect of S.V. University/S.K. University area for the purpose of admission.
- 5.4.4 Local status certificate issued by MRO for claiming as AP local as per Circular Nos. 4136/SPF&MC/2015-5, dated.08.08.2016 and 4136/SPF&MC/2015-13, dt.20.11.2017

#### **5.5 LOCAL CANDIDATES:**

5.5.1 A Candidate for admission shall be regarded as local candidate in relation to a Local area

i) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which she appeared or as the case may be first appeared in relevant qualifying examination.

or

ii) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which she appeared or as the case may be first appeared for the relevant qualifying examination, she has not studied in Educational Institutions, if she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which she appeared or as the case may be first appeared.

5.5.2. A candidate for admission to any course of study who is not regarded as a local candidate under sub-regulation 5.5.1 above in relation to any local area shall

i) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to;

a) Such local area where she has studied for the maximum period out of the said period of 7 years.

b) Where the period of her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods

or

ii) If during the whole or any part of the seven consecutive academic years ending with academic year in which she appeared or as the case may be first appeared for relevant qualifying examination, she has not studied in the educational institution in any local area, but she has resided in the state during the whole of the said period of 7 years be regarded as a local candidate in relation to

a) Such local area where he/she has studied for the maximum period out of the said period of 7 years.

or

b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

**EXPLANATION:** (for purpose of this sub-regulation)

i) "Educational Institution" means a University or any Educational Institution recognized by the State Government, a University or any other competent authority.

ii) "Relevant qualifying examination in relation to admission to any course of study" means the examination, a pass in which is the minimum educational qualification for admission to such course of study.

NOTE: The relevant qualifying examination for admission to M.Sc.,(Nursing) courses is B.Sc.,(Nursing) examination. The question whether the candidate is a local candidate or not will be determined with reference to her first appearance in the Final B.Sc.,(Nursing) examination.

iii) In reckoning the consecutive academic year during which a candidate has studied any period of interruption of his/her study by reasons of his/her failure to pass any examination and any period of his/her study in a statewide University or a statewide educational institution shall be disregarded.

iv) The question whether any candidate for admission to any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his/her parent or guardian.

**5.6** While determining under sub-regulation 5.3.1 the number of seats to be reserved in favour of local candidates, any fraction of seat shall be counted as one, provided that there shall be one unreserved seat.

**5.7** If a local candidate in respect of a local area is not available to fill any seats reserved or allocated in favour of local candidate in respect of that local area such seats shall be filled in as if it had not been reserved.

Those who did not qualify as local candidate under sub-regulation 5.5.1 (i) or 5.5.2 (i) but claim to qualify by virtue of residence shall produce a certificate issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer independent charge of subtaluk/Mandal in the form annexed to G.O.P.No.628, Education, dated 25-7-1974 appended as Annexure – I

5.8 The applicant who claims to be local candidate with reference to sub-regulation 5.5.1 (i) or 5.5.2 (i) shall produce in the form of study certificate/certificates issued by the Head of the Educational Institution / Institutions concerned indicating the details of the year or years in which the candidate has studied in educational institution in such local area for a period of not less than 4/7 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first

5.9 The following categories are eligible to apply for admission to the 15% of unreserved seats.

5.9.1 All candidates defined under Regulation - 5.5.

5.9.2 Candidates who have resided in the state for total period of ten years excluding period of study outside the State, or either of those parents have resided in the State for a total period of ten years excluding period of employment outside the state.

5.9.3 Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi - Public Institutions in the State.

5.9.4 Candidates, who are spouses of those in employment of this State or Central Government Public Sector Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or a University or other competent authority and similar other quasi Government institutions within the State.

5.9.5 Candidates who are employed in the State Government undertakings, Public Sector corporations, Local Bodies, Universities and other similar quasi-Public institutions within the State.

5.9.6 Candidates who are spouses of the local candidates as per Regulation - 5.5.

**N.B.:** Relevant certificates must be attached to the application in respect of their claim, in respect of residence. The certificate should be obtained from the Revenue authorities not below the rank of Mandal Revenue Officer/Tahsildar.

## 6. DURATION OF THE COURSE:

The duration of the course shall be two years.

7.2 The candidate should fill the online application form available in the Website with the data required-for and upload the scanned Certificates/Documents in support of their claim

through internet. The online application form can be filled through any computer with internet connection (home/internet cafe/net center). The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates ready to enter the correct data and uploading of the scanned copies of certificates/documents, photo and signature after payment of fee through online.



## 18. POWERS OF THE HEAD OF THE INSTITUTION:

18.1 Notwithstanding anything contained in these regulations, the Head of the Institution may, at any time either su-moto or on an application made by any person, after due and proper enquiry, if she is satisfied that the candidate has furnished incorrect information or enclosed false certificates or fraudulently obtained admission, may, for the reasons to be recorded in writing, by order, cancel her admission, provided that no such admission shall be cancelled without giving a reasonable opportunity for showing cause as to why her admission should not be cancelled.

18.2 Against any such order of the Head of the Institution an appeal shall be with the Registrar of the University.

## 19. POWERS OF THE UNIVERSITY:

The University may either su-moto or on application made to them call for to examine the records relating to any selection or admission or cancellation thereof, made by the concerned authority for the purpose of satisfying themselves as to the correctness, regularity or propriety of such order in relation thereto as they deem fit, including cancellation of the selection already published or admission already made provided that the University may, before cancelling such selection or admission give an opportunity to the authority and to the person effected to show-cause against such cancellation.

**20. FINALITY OF SELECTION:**

All selections made under these rules shall be subject to any general rules or orders that may be made by the Dr. YSR University of Health Sciences/ Government of AP from time to time.

**21. DEPUTATION:**

Regular in-service candidates of Andhra Pradesh Medical and Health Services shall obtain deputation orders from the Government.

**22. BOND TO SERVE THE EMPLOYER/GOVERNMENT:**

All in-service candidates of Medical & Health Dept., on admission have to execute a bond on a non judicial stamp paper worth of Rs.100/- (Rupees hundred only) embodying the conditions of training and agreeing to serve the Employer/State Government for a period of at least 5 years on successful completion of the course, in any capacity as the Government may consider suitable and in default they shall be Rs.2,00,000/- (Rupees two lakhs only) besides refund of the amount received as salary up to the date to the Government as prescribed in Annexure - III.

**23. Break of study and re-admission:**

**DEFINITIONS:**

- i. Break of study means any absence more than 3 months during the course of study.
- ii. 3 months for this purpose is a period of 90 days (ninety days) to be recorded from the date of absence irrespective of the number of days in one calendar month.
- iii. For all practical purpose only two types of break of study is allowed.
  - a. Less than 3 months of break (as per definition)
  - b. More than 3 months of break but less than the twice the number of years of study of a particular course.  
Ex: For MBBS/BDS twice the number of years of study is 9 years  
For B.Sc., (Nursing) / Physiotherapy is 8 years.
- iv. If the candidate is on Break of study for two spells in an academic year of a particular course the candidate is deemed to have been discharged from the course of study. **One cannot apply for condonation of the break.**

i. **Only two spells of break of study** for the entire duration of the course is permitted. During second spell of break of study even if the break of study is less than **90** days, permission must be obtained from the university and that spell of Break shall also be counted as second spell of break.

ii. For less than three months of break, the Principal/ Dean of the college can permit to rejoin in to the course under intimation to the university.

iii. If the break of study is more than three months the candidate has to apply to the university through the Principal/Dean of the college. The University can give permission to the candidate to complete the course within **twice the years of the study** of the particular course.

Example 1: B.Sc., Nursing student discontinues after 2 years of study and wants to join the course after 2 years of absence from study may be permitted to rejoin into the course since the candidate has 2 years of study to complete. If the candidate discontinues the course after 2 years of the study and wants to continue after 5 years of absence the candidate will not be permitted to continue the course since student will be finishing only after twice the number of years of the course (2 years of study + 5 years of absence + remaining 2 years of the study) makes the student study for 9 years whereas according to the regulation students should not exceed twice the number of years of study in 8 years.

Example 2: MBBS Student discontinue after 3 years of study want to join the course after 3 years of absence from study may be permitted to join into the course since the candidate have 1 ½ year of study to complete. If the candidate discontinue the course after the 3 years of the study wants to continue after 5 years absence, the candidate will not be permitted to continue the course since, will be finishing only after twice the number of years of the course.

- i) The period of break of study of the candidate for re-admission of the course shall be calculated from the date of first discontinuance of the course.
- ii) All the Post Graduate students have to execute a declaration at the time of registration with this University in this regard in the prescribed form as in Annexure-I.
- iii) The Principal /Dean of the college concerned shall permit any candidate who is absent for less than three months during the course of study to rejoin the course under intimation to this university. It is the responsibility of the Dean / Principal of the college concerned to ensure that a copy of the order of permission granted by them under intimation to the Vice Chancellor Dr. YSR UHS.

The candidate may be permitted by the Principal/Dean to rejoin in the course of study in which he/she discontinued the course for three months and shall be admitted to the examination after fulfillment of the regulation of this university of the course concerned.

- (iv) The candidate having a break of study for more than three (3) months and above but less than twice the years of the course shall apply of rejoining the course in the prescribed form as in Annexure II by remitting the stipulated fee for condonation of Break of study to the Registrar of this university through the Dean/Principal of the concerned college for issue of necessary permission to rejoin the Course. The concerned Dean / Principal of the college shall not permit any candidate with a Break of Study as stipulated above to rejoin the course without obtaining the prior permission from this University.

If any candidate is permitted by the Dean/Principal of the college concerned without the prior permission from this University, to rejoin the course after the break of study the period of such study shall not be considered as a recognized study and the candidate shall not be permitted to write the University examinations based on such study period.

- (v) In the case of Post-Graduate study where there is no theory examinations at the end of 2nd year of study and the candidate has to submit only dissertation for evaluation and could not submit the same at the end of 2nd year of study as prescribed in the Regulations shall apply to the University for permission to submit the same within a period of one year from the date of completion of the 2nd year period of study.

#### 24.1 AGREEMENT BOND/Discontinuation of course:

(a) All the candidates joining the M.Sc., (Nursing) course shall execute a bond on nonjudicial stamp paper of value of Rs100/- as prescribed in Annexure II to the regulations to ensure completion of the prescribed period of study. In case, if any candidate wish to discontinue their course due to personnel reasons should pay of Rs.29,500/- including GST@18% i.e. 25000+4500 (Rupees Twenty Nine Thousand Five Hundred only) in the form of DD making in favour of the Registrar, Dr. YSR University of Health Sciences, Vijayawada. On receipt of the representation of candidate which forwarded by Principal along with DD, the University shall issue discontinuation orders after due procedures. The Principal of the respective Nursing College shall relieve the candidate on receipt of the discontinuation orders from University.

#### 25. LEAVE:

Each year students will be permitted to avail 30 days leave. No Post Graduate is allowed to go on leave more than 8 days at a stretch. In case the absence of the candidate availing Medical Leave / Maternity Leave / Any other Leave or unauthorized absence is beyond 30 days in a year the study period of the candidate will be extended to the extent of such period. No other leave is permitted.

#### 26. UNIFORM:

All the candidates are expected to wear the Uniform on duty prescribed by the respective College

#### 27. COURSE OF STUDY:

The candidates admitted into M. Sc (Nursing) course shall pursue the study in accordance with the syllabus prescribed by the Academic Senate of University.

#### 28. EXAMINATIONS:

The candidates shall have to appear for such examinations as prescribed by the University from time to time.
