In this regard you are hereby requested to submit your letter of interest to take up below required item for the following specification duly submitting the required documents for scrutiny of your credentials on or before 16.06.2023 in a sealed cover addressed to "The Registrar, Dr. YSR University of Health Sciences, Vijayawada – 520008".

Specification

Providing 100 KWp capacity Solar System (CAPEX mode) including cost of additional cables, MCCBs, Net metering, Civil works, Conveyance and all labour charges, fixing net metering with remote monitoring system including all applicable taxes and commissioning for erection etc., complete finished item of work with 10 years (5 + 5) warranty with maintenance for system and 25 years warranty with maintenance for panels

TENDRER

TERMS & CONDITIONS

- 1. The agency shall be given assurance to generate not less than 432 units on average per day for 100 KWP.
- 2. The Supplier who applies for this tender has to furnish the declaration that they have not been black listed in any of the organizations. Any wrong declaration in this regard which comes to the notice at a later date will disqualify them from tendering in future in University and the tenders so received shall be automatically rejected.
- 3. The agency shall satisfy themselves about the site conditions before submission of EOI for erection of solar system at Dr. YSR University of Health Sciences, Vijayawada. The agency is at liberty to visit the site conditions during office hours.
- 4. No supplier shall be allowed at any time on any ground what so ever to claim revision or modification in the prices quoted by him, Conditions such as Subject to Availability Supplies will be made as and when supplies are received etc., will not be considered under any circumstances.
- 5. In the event of any dispute arising out of the tenders, such dispute would be subject to the jurisdiction of the civil courts at Vijayawada, only
- 6. Security and insurance i.e., from loss / damage / theft or rain etc., shall be at the risk of the agency
- 7. All the materials are to be approved by the competent authority before they are delivered to Dr. YSR UHS. The materials should be as per Specifications. Any rejected materials are to be removed immediately
- 8. Payment will be made after successful completion of work and on certification of the competent authority.
- 9. The rate quoted should be inclusive of transportation labor charges, etc. and inclusive of all taxes. Further, authorities cannot issue statutory forms like Form C or Form D etc. and this should be taken into account by the supplier while quoting the rates to concerned authorities.
- 10. Negotiations will be made in case of necessity, with the lowest selected tenderer /tenderers and in this regard the decision of concerned authorities shall be final and binding on the suppliers without any recourse.
- 11. The tender accepting authority reserves the right either to reject any or all tenders without assigning any reason. In this regard the decision of concerned authorities is final and binding on the tenderer without any recourse. Further, it is understood by both the parties to the tender and is specifically accepted by the tenderer when the tenderer files the tender before concerned authorities the acceptance or rejection of the tender by concerned authorities, or methodology adopted by University in short listing the companies for providing service or supply of material/materials or etc., shall not become a cause of action or ground to initiate any legal action before any Court or Courts of Law for obtaining any order, Injection, Direction etc., from the Hon'ble court or Courts to stall the proceedings in Dr. YSR UHS, Vijayawada .

- 12. concerned authorities reserves the right to accept or reject any tender and to cancel the tender process and reject all tenders at any time prior to the award of contract without thereby incurring any liability to the affected tenderer or any obligations to inform the affected tenderers, the grounds of acceptance or rejection.
- 13. concerned authorities reserves the right to charge penalty as decided withhold payment for any under quality material supplied by the tenderer without prejudice to its other rights. In this regard, the decision of Registrar is final.
- 14. The prices quoted shall be fixed from the date of submission of tender to the date of completion of the contract of contract in all respects. ANY REQUESTS FOR REVISION IN THE RATE OR RATES BY THE SUPPLIER SHALL NOT BE ENTERTAINED DURING THE RATE CONTRACT PERIOD.
- 15. Penal clauses of the supplier whatsoever like payment of interest on delayed payment of bills etc. shall not be acceptable to University.
- 16. For breach of any of the above tender conditions by the approved tenderer, the E.M.D. and Security Deposit are liable to be forfeited duly blacklisting the Firm. Further, Non-performance of any of the contract provisions to the satisfaction of Dr. YSR UHS, Vijayawada will disqualify the tenderer to participate in the tenders for the next five (5) years, by disabling the digital certificate.
- 17. The successful tenderer shall be required to execute agreement. The Signatory should produce documentary evidence of empowering him to do so, if called upon at any time during the contract period. In case of change in the Authorized signatory it is binding on the supplier to inform the changes to the Dr. YSR UHS, Vijayawada.
- 18. The successful tenderer should execute an agreement on non-judicial stamp paper worth Rs.100/- agreeing to all the conditions of the contract. If the successful tenderer fails to execute the agreement within the time specified or withdraw the tender after the intimation of the acceptance of his tender by concerned authorities or he is unable to undertake the contract due to any other reason, his contract will be cancelled and his E.M.D. shall be forfeited and he will also be liable for all damages sustained by the concerned authorities by reason of breach such as failure to supply/delayed supply including the liabilities to pay differences between the prices accepted by him and those ultimately paid for the procurement of the commodity. Such damages shall be assessed by the concerned authorities whose decision shall be final and shall be binding on the supplier.
- 19. The University reserves the right to terminate / amend / modify the contract without assigning any reason or advance notice to the tenderer/Supplier. Similarly, the terms of the tender may be amended/modified by University if necessary, to ensure competitiveness and quality of procurement / service.
- 20.SUB-CONTRACTING: The contract supply awarded should be executed by the successful Tenderer/ bidder only and sub-contract of supply is not permitted.

TENDRER

- 21. The successful tenderer shall able to remit an amount up to 5% of the value of the contract. The amount equivalent to 5% of the value of the contract shall be termed as Security Deposit and will be retained by the University as security deposit until successful completion of work and the Security Deposit will be released after completion of liability period.
- 22. Prices quoted should be quoted inclusive of all taxes, transportation and labor charges etc.,
- 23. Deductions: Income Tax and if any other taxes would be deducted from the bill as per the Government norms
- 24. Transportation and labor should be arranged on their own. Damages, breakages etc., in transportation at the responsibility of the agency.
- 25. Penalty: In case of default by successful bidder, the Registrar, Dr. YSR UHS, Vijayawada his option has right to impose the penalties that may be deemed fit to recover from the bidder and amount equivalent to that incurred without prejudice to his other rights including the right to cancel the order without pre-notice, forfeit the security deposit or recover for damages for breach of contract.
- 26. The payment will be released on satisfactory certification of concerned authorities, after completion of work.
- 27. The technical specifications as per Ministry of New and Renewable Energy, Govt. of India, New Delhi specification and NREDCAP and configuration must be in accordance to the specifications stated in Annexure
- 28.Samples may be submitted for approval before deliveries are made.
- 29. On receipt of the amount towards security deposit, then the authorities shall issue a purchase order setting forth the conditions and terms with date of delivery etc., by Registered Post with Acknowledgement Due.
- 30. The authorities on receipt of consignment shall verify and set forth defective supplies, if any, in writing to the contractor within reasonable time from the date of receipt of supplies.
- 31. The works to be made as per schedule given in the agreement.
- 32. Work should be made in accordance with specifications and as per approved sample.
- 33. The work shall commence within 21 (Twenty One) days after issue of work orders else non-refundable penalty of 2% on total contract value per week would be levied to a maximum 6% on total contract value.
- 34.All the materials are to be approved by the competent authority before they are delivered to Dr. YSR UHS. The materials should be as per Specifications. Any rejected materials are to be removed immediately.

35. The agency has to pay FSD @ 5% of the contract value from the selected agency at the time of concluding Agreement and the same will be released after successful completion of work or as directed by NREDCAP whichever is later
