In continuation of earlier notifications, dated 20.12.2024, 30.12.2024, this University hereby notify the MOP-UP Round of web-based counselling for M.Sc.(N) and MPT courses for the academic year 2024-25 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who were present in the Merit list notified in the website on 15.02.2025 for MPT courses and final Merit list of M.Sc(N) courses on 25.03.2025 are only eligible to exercise their options as per the seat matrix displayed on the website https://drntr.uhsap.in

 - <u>UNIVERSITY FEE:</u> Candidates who are allotted a seat, have to pay Rs.12,900/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).
 - TUTION FEE: 1. Govt. Colleges: As fixed by the Government of Andhra Pradesh.
 - 2. Private Colleges: Tuition fee structure to be payable for the Competent Authority Quota seats in Private Unaided Non-Minority Nursing & Physiotherapy Colleges.

Instructions to Candidates:

- 1. All the eligible candidates who are present in the Merit lists notified in the website on **15.02.2025** for MPT courses & on **25.03.2025** for M.Sc(N) courses and who are not covered under point 2 below are only eligible to exercise their options for the vacant seat and as per seat matrix displayed on the **website** https://drntr.uhsap.in
- 2. The candidates who were allotted seat in Phase-I & Phase-II/Final counseling are not eligible to participate in this MOUPUP Round Counseling.
- 3. Fresh options will be obtained from all the eligible candidates.
- 4. Vacancy position is displayed on University website for the information of the students to exercise their options.

- 5. The candidates who get allotment in this MOPUP Round Counseling should join compulsorily in the allotted college.
- 6. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
- 7. Candidates will receive the allotment order after allotment of seat. The candidates are also instructed to visit the website:

for status of allotment.

- 8. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
- 9. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- 10. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.
- 11. The University fee once paid shall not be refunded under any circumstances.
- 12. If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay an amount of Rs. 25000/-+4500/-@18% GST (Rupees Twenty Nine Thousand Five Hundred only) in the form of DD drawn in favour of the Registrar, Dr.NTR University of Health Sciences, A.P., Vijayawada
