ADVISORY TO ASPIRANTS OF MEDICAL / DENTAL ADMISSIONS, 2025

BEWARE OF TOUTS, BROKERS OR MIDDLEMEN

Few persons may approach you saying they have known Government Officials, Political leaders and authorities / staff in Dr. N.T.R. University of Health Sciences duly showing contact numbers of University Officials, who guarantee Medical / Dental seats through unfair means during counselling or after counselling which is far from truth. Candidates and parents are requested not to trust any of such persons. For any information regarding counselling, please get in touch with the University official website only (<https://drntr.uhsap.in>).

Counselling for all Medical / Dental seats under State Quota are conducted and allotted through online mode only as per the existing rules and in the ambit of the State Government, as follows:

✓ **For Competent Authority (Convener) Quota seats**

Allotment of seats is purely based on Merit (NEET Rank), Reservations and Onetime Options exercised by the eligible candidates of respective category.

✓ **For Management Quota (B-Category and NRI Quota) seats**

Allotment of seats is purely based on Merit (NEET Rank) and Phase-wise Options exercised by the eligible candidates of respective Quota.

Certain Consultants / Touts / Youtubers / WhatsApp messages or any social media net works will mislead students and parents with false claims of admission, direct admission offer, and low fees — **only to ruin students medical career later.**

- Never trust any agency / consultant / broker / youtuber/ WhatsApp or any social media networks that promises admission without NEET.
- University Officials never demand cash or any other favours under any circumstances.
- Do not believe such misleading news.
- The responsibility of verifying the authenticity of any information lies entirely with the student / parent.

The medical aspirants and their families are strongly advised to stay vigilant, as the same is essential to protect oneself.

Certain signs of a Fake MBBS / BDS Consultancy / Agency / Touts / Youtubers / WhatsApp messages

1. They Promise Guaranteed MBBS Seats Without NEET

NEET (National Eligibility cum Entrance Test) is mandatory for MBBS admission in India. Any consultancy claiming you can get a seat without clearing NEET / low rank / score is either misinformed or trying to scam you. The National Medical Commission, New Delhi strictly mandates **NEET** as the only entry point to medical /dental courses.

2. They Ask for Part or Full Payment Upfront

Fake agents /consultants / touts / youtubers / WhatsApp group often demand Part or 100% payment upfront, usually in cash or to personal bank accounts. Once the money is transferred, they disappear.

Tip Never trust such type of actions.

3. No Physical Office or Verified Address

Many fake MBBS consultancies operate through social media or messaging apps, without a verified office or website. They avoid face-to-face meetings and insist on remote communication to keep their identity hidden.

4. They Offer Fake Allotment Letters

Another common trick is showing a fake seat allotment letter to build trust. These documents often bear official-looking seals or logos but are completely fabricated.

Tip: Cross-check allotment details through the official University website only. No consultancy has the authority to issue seat allotments.

 **Believing such type of actions, is at their own risk only.**


5. What to Do If You Suspect a Fraud?

- File a police complaint immediately.
- Report the fraud to authorities concerned or cybercrime portals.
- Share your experience online to alert other students also.

Candidates should not share their credentials i.e. User ID, Password, OTPs etc. during counselling, with anyone.

Stay informed, stay alert, and only trust information posted in the University official website(s) towards your medical admission journey. Don't let fraudsters stand between you and your dream of becoming a doctor.

Once again, it is reiterated that the University will make all admissions through online counselling only in a fair and transparent manner duly issuing notifications from time to time through the University Website.

 **No need to approach any person or agency / consultant. Simply candidates can go through the University Official Website(s) only as specified the official notification and the Prospectus which will be available on the official website, as and when released.**
