**NOTIFICATION FOR ONLINE APPLICATION AFTER REDUCTION OF CUT-OFF SCORE
FOR STRAY VACANCY ROUND**

**Inviting Online application forms and Uploading of Original scanned documents for
Verification**

1. In view of Revised Cut-off Scores of NEET MDS-2025 after lowering of qualifying percentiles released by NBE, New Delhi notification dated 14-08-2025 issued in accordance with the Ministry of Health & Family welfare, Govt. of India Letter No.V.12025/84/2024-DE, dated 10-08-2025, Dr. NTR UHS invites Online applications from the eligible candidates for admission into vacant/un-filled seats of Post Graduate Dental Degree/Diploma Courses under Competent Authority Quota seats in Government and Private un-aided Non-Minority Dental Colleges in the State of Andhra Pradesh for the academic year 2025-26.
2. **Candidates who have already applied and are listed in the MQ Merit List do not need to reapply. However, they can modify their S2/S3 choices and upload any necessary documents. All other application requirements notified in the earlier Notifications/Prospectus, dt.03-07-2025 shall remain unchanged.**
3. Candidates from other States and Union Territories must check their eligibility by reading Prospectus, dt.03-07-2025.
4. **Total number of vacant seats available for this phase of counselling is Annexed.**
5. **Not Reported Seats of Phase-III (Mop Up) if any, will also be considered in this Phase in addition to the vacant seats available for this phase of counselling.**
6. For other eligibility conditions, registration fee, counselling rules and procedure to submit the online application **please download and read the Prospectus and User Manual** displayed on the University website.
7. Candidates are advised to visit the University website for all further notifications/latest updates/circulars/allotments on MDS Admissions till the closure of admissions. No individual communications will be sent.

INSTRUCTIONS

- Fresh registrations and fresh choice filling for Final Stray Vacancy Round. The choices filled during earlier phases will not be considered for allotment in Stray Vacancy Round. Candidate whose names already present in the Merit list and not holding any seat are also eligible for Stray vacancy **provided they satisfy the eligibility conditions of Stray vacancy round** and hence they need not apply again for Stray vacancy notification.

- For freshly registered candidates the Competent Authority has decided to collect a Refundable Security Deposit Amount of ₹3,00,000/- (Rupees Three lakh only) through online mode to avoid seat blocking. Other details will be notified in the Web Option notification of that Phase.
- The choices filled during Phase-III (Mop Up) will not be considered for allotment in Stray Vacancy Round.

8. Security Deposit:

To prevent seat blocking and ensure that valuable seats are effectively utilized during the Stray Vacancy Round, the Competent Authority has decided to collect a *refundable security deposit* of ₹3,00,000/- (Rupees Three lakhs only) through online payment. This applies to candidates who are in the Merit List under the Competent Authority Quota and intend to participate in the Stray Vacancy round of counselling, subject to the following conditions:

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Stray Vacancy Round or in subsequent stray rounds, if any, **will be forfeited** and such candidates **shall be debarred** from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year.
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate **after closure of admissions**.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate **after closure of admissions**.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time)

Note: Candidates who have paid the security deposit during the Phase-III (Mop Up) round and were not allotted any seat will be eligible to exercise web options in the Stray Vacancy Round without having to pay the security deposit again.

9. Eligible candidates:

- a) The candidates who have not been allotted in Phase 1, Phase 2, Phase 3 of counselling.
- b) The candidates who have been allotted, but not joined in Phase 1, Phase 2 of State Quota and All India Quota are eligible to participate in this counselling.

10. Not Eligible Candidates:

- a) The candidates who are holding MDS seat in Round 1, Round 2 and Round 3 (Mop Up) of State Counselling are not eligible to participate in Stray round of counselling.
- b) The candidate who is holding a seat allotted in Round 1 & Round 2 and Round 3 in All India Quota/Deemed universities (conducted by MCC/DGHS).
- c) The candidates who have been allotted in stray round of Competent Authority Quota of the AP State are not eligible to participate in State MQ Stray Round of counselling.
- d) A candidate allotted a seat in Phase 3 (Mop up) of State counselling and not joined the seat cannot participate in further rounds of State Counselling of both CQ & MQ.
- e) The candidates who have been allotted in stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Stray Round of counselling.

11. **If a candidate is allotted a seat in Stray Vacancy round, he/she has to compulsorily report & join the allotted seat/college else the Security Deposit will be forfeited and he/she shall be debarred from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year.**

21. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-MDS-2025 Rank.
22. **Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counselling.** No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
23. The Candidates are hereby informed that if they have secured admission in Dental colleges of other States, joined the course and if they are involved in blocking of the seats the University will initiate legal action and same will be informed to the DCI, New Delhi.
24. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
