PG (DENTAL) STRAY VACANCY ROUND-1 COUNSELLING (WEBOPTIONS) FOR MANAGEMENT QUOTA SEATS AFTER LOWERING OF CUT-OFF SCORE – 2025-26

In continuation to this Office Notification, dt.18-08-2025 & 29-08-2025, Notification for exercising web options for admissions into Post Graduate Dental Degree/Diploma Courses against Stray Vacancy Round-1 for the academic year 2025-26 under Management Quota Post Graduate Dental Degree / Diploma courses, in Private Un-aided Non-minority Dental Colleges affiliated to Dr. NTR UHS (available seats at the end of Stray vacancy round)

#### **Security Deposit Amount:**

To prevent seat blocking and ensure that valuable seats are effectively utilized during the Stray Vacancy Round-1, the Competent Authority has decided to collect a *refundable security deposit* of ₹3,00,000/- (Rupees three lakhs only) through online payment. This applies to candidates who are in the Merit List under the Management Quota and intend to participate in the Stray Vacancy round-1 of counselling, subject to the following conditions:

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Stray Vacancy Round-1 will be forfeited and such candidates shall be debarred from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year.
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate **after closure of admissions**.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate **after closure of admissions**.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time)

**Note**: Candidates who have paid the security deposit during the Phase-III (Mop Up)/Stray round and not allotted any seat will be eligible to exercise web options in the Stray Vacancy Round without having to pay the security deposit again.

### Web Options:

Eligible candidates will have to exercise fresh web options for Stray Vacancy Round-1.

Candidates participating in Stray Vacancy Round-1 will have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

"I agree to participate in the Stray Vacancy Round-1 of NEET-MDS Counselling, 2025. I affirm that I fulfill the eligibility criteria as mentioned in the Notification dated 18.08.2025 for Stray Vacancy Round-1 of NEET MDS 2025.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Stray Vacancy Round-1, I will join the allotted seat. If, due to any reason I do not join the allotted seat my refundable security deposit will be forfeited along with debarment from A.P State Counselling for One (1) academic year i.e., 2026-27 and any action including legal may be taken by the Competent Authority."

#### **INSTRUCTIONS**

- 1. Eligible candidates whose names are in the Consolidated Provisional Final Merit Position notified in the University Website on 29-08-2025 are only eligible to exercise web options as per the above dates.
- 2. All the available vacancies of S1A & S1B seats are treated as S1 seats and all the candidates are eligible for all S1 seats as per Merit.

# 3. The following candidates are not eligible to exercise options under this Notification:

- a) The candidates who are holding PG Dental seat in Phase 1, Phase 2, Phase 3 (Mop Up) and Stray vacancy round of State Counselling are not eligible to participate in Stray round-1 of counselling.
- b) The candidate who is holding a seat allotted in Round 1 & Round 2, Round 3 and Stray round in All India Quota/Deemed universities (conducted by MCC/DGHS) and other State Counselling are not eligible to participate in AP State (CQ & MQ) Stray Round-1 of counselling.
- c) The candidates who have been allotted in stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State (CQ & MQ) Stray Round-1 of counselling.
- d) Allotted candidates of Phase-III (Mop Up) & Stray Vacancy Round of both CQ & MQ are not eligible for this stray vacancy round-1.
- e) The candidates who have been allotted in Stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Stray Round-1 of counselling regardless of whether they applied or chose options in that round. Such names will be deleted before processing allotments for Stray Vacancy round-1.
- f) The Candidates who have been allotted seats in the CQ Stray Round-1 will not be eligible for the MQ Stray Round-1, regardless of whether they applied or chose options in that round. Such names will be deleted before processing allotments for Stray Vacancy round-1.

- 4. If a candidate is allotted a seat in Stray round-1, he/she has to **compulsorily** report & join the allotted seat/college else he/she **shall be debarred** from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year.
- 5. Vacant seats for Stray Vacancy round-1 are Annexed for this Notification. Hence, the candidates are therefore advised to exercise options for the seats in the colleges as per the available vacancies as per their priority if they are really interested to join the Seat.
- 6. Candidate can download the provisional allotment order on payment of University fee of Rs.49,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
- 7. The University fee once paid shall not be refunded under any circumstances.
- 8. The allotted candidates shall report at the allotted college immediately in view of MCC, New Delhi schedule. Hence, candidates are advised to keep in touch with University website for information on Stray allotments.
- 9. TUITION FEE: Tuition fee structure for the current academic year 2025-26 will be as decided by the Govt. of Andhra Pradesh, subject to the outcome of W.P.Nos.32975, 33162 & 35090 of 2022.
