The Notification is issued for registration of eligible candidates to appear for MDS (PG Dental) Part I, Part II Degree/Diploma Regular Theory Examinations are scheduled to be held from **04.11.2025**.

I - ELIGIBILITY CRITERIA:

MDS PART – I EXAMINATIONS:

1. The candidates those who are admitted into the 1st year MDS course whose admissions are approved by the University during the academic year **2024-25** in the PG Dental Colleges affiliated to Dr. NTR University of Health Sciences and completed their study period of One year after admission and put in a minimum attendance of 80% are eligible to appear for **MDS Part – I** Examinations in November, 2025.
2. The candidates those who have appeared for **MDS Part- I** examinations held in December, 2024 (or) prior examinations but failed in the said examinations, are also eligible to appear for MDS Examinations in November, 2025. These candidates are eligible to apply failed subject (Basic science).

MDS PART – II (PG DENTAL DEGREE/DIPLOMA) EXAMINATIONS:

The **PG Dental Degree course** candidates (2022-23 batch) who have completed 3 Academic Years of study period and passed the subject (Basic science) of **MDS Part – I** and minimum attendance of 80% (during each academic year) are eligible to apply for appearing **MDS Part – II** Examination.

1. The candidates those who have appeared **MDS Part- II** examinations held in December, 2024 (or) prior examinations, but failed, are also eligible to appear for the ensuing examinations.

2. The candidates who are admitted into the **PG Dental Diploma course** whose admissions are approved by the University during the academic year **2023-24** in the Dental Colleges affiliated to Dr. NTR University of Health Sciences and completed their study period of 2 years after admission and put in a minimum attendance of 80% (during each academic year) are eligible to appear for **PG Dental Diploma Examinations** in November, 2025.
3. The candidates those who have appeared MDS Degree/ Diploma Final year examinations held in December, 2024 (or) prior examinations, but failed, are also eligible to appear for the ensuing examinations.
4. **The candidates who will complete this course of study period by 30.11.2025**, are also eligible to apply. Hence, the Principals are directed to verify the cutoff date before entering data in the Medhas Portal of the University.
5. The candidates shall have to pass the part- I examinations at least 6 months prior to the final Part - II exams with required attendance of 80% in each year.
6. The candidates should have submitted dissertations within the time schedule fixed by the University as already notified.
7. **The study period of those candidates who availed maternity leave upto 120 days (04 months) will be extended to the extent of maternity leave availed. They will be eligible to appear for the Examination only after completion of three years study period in MDS course as per Dr. NTR UHS Regulations.**
8. **The duration of the study period of candidates extendable in case of availment of Medical Leave/ Maternity Leave/ any other Leave/ absence beyond 30 days in each year.**
9. The Principal concerned should submit course period completion certificate of the students.

Note: Hall Tickets to the candidates for MDS Part- II will be issued only if their dissertations are approved.

II - Digital Valuation:

In view of Digital Valuation of PG Dental Degree/ Diploma answer scripts a single 68 pages OMR answer book with 64 writable pages will be issued to the candidates appearing for November, 2025 Examinations and no additional answer book will be issued to the candidates. The candidates should answer all the question in the single answer book of 64 writable pages only.

III - Criteria for Evaluation of PG Degree & Diploma Courses:

As per DCI Regulations the minimum pass marks are as follows:

- 50% marks to secure in Part - I theory paper i.e., 50/100
- 50% marks aggregate in Part - II theory all the three papers i.e., 150/300
- **MDS Degree/Diploma** Practical/Clinical marks for 200 & Viva Voce marks for 100, passing minimum for Practical / Clinical including Viva voce for 150/300.
- **No grace mark is permitted in MDS Degree/Diploma examination either for theory or for practical.**
- **After computation and declaration of results, under no circumstances, revaluation is permitted.**

Note: The Principal is informed to fix an earlier date for collection of examination fee and entering data in portal well in advance before cutoff date given above.

V. "The Principals of Dental Colleges are informed to upload the details of The students who are eligible for appearing for PG Dental Degree/ Diploma examinations in November, 2025 in MEDHAS Portal i.e., <http://drntruhs.nic.in/medhas> institution **on or before 04.10.2025 for issue of E- Hall Tickets."**

VI. Therefore, the Principals are advised to collect and remit the Examinations fee through online payment mode at <https://drntruhs.uhsap.in/epay/> by **06.10.2025** and send the same to the University along with exam material (student details, fee, attendance statement, freezed copy etc.) and printout of data which is uploaded in Medhas Portal to reach by **07.10.2025.**

VII. **The following copies of certificates shall be enclosed along with the application.**

- a) Evidence of the date of birth (SSC or its equivalent Examination Certificate) attested Xerox copy only.
- b) Print copy of uploaded student data
- c) Two Testimonials from any two Lecturers of the college concerned.
- d) Attendance / Eligibility Certificate from the Principal
- e) The Candidates who are from outside the state should submit their Migration Certificate.
- f) Copy of BDS Original Degree certificate (Attested Xerox copy only).
- g) Copy to Part-I Marks Memo by the students those who are appearing the MDS Part II Exams only.

NOTE:

1. Unless these certificates are enclosed with the application, the application will not be considered and there will not be any further correspondence with the candidate.
2. Application with incomplete details/photo & signature will not be accepted.
3. The referred candidates have to enclose a copy of their previous Exam's Hall Ticket and also copies of their PG Degree permanent certificates once again, without fail.

Kindly arrange to check the applications whether they are in order, whether all columns are filled by the students with required information and send them to the University with your counter signature on the application form.

VIII. INSTRUCTIONS TO THE PRINCIPALS:

1. The principals are informed to verify the eligibility of the students before submitting the data on the Portal.
2. If any indelible student details furnished in the Medhas Portal, the Principal is solely held responsible for that.

Principals are requested to furnish the advance amount required. If previous advance is not settled, fresh advance will not be sanctioned.
