In continuation to this Office notification dt. 26-07-2025, Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-I of counselling for admission into Management (Category B1, B2 & Category C (NRI)) Quota seats of BDS course under Dr. NTR UHS for the academic year 2025-26:

All the candidates whose names are present in the Final Merit Position of Management Quota displayed on 22-08-2025 and Addendum, if any in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website <https://dntr.uhsap.in>

University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card /Credit Card / Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

Tuition Fee:

- Tuition fee for the academic year 2025-26 will be as per the orders of the Govt. of Andhra Pradesh, and subject to the outcome of W.P.Nos.32975, 33162 & 35090 of 2022.
- The following is the tuition fee for the academic year 2024-25 as per G.O.Ms.No.503, HM & FW (C1) Dept., Dt.06.08.2024 in respect of the Category-B & C (NRI) seats in Private Un-aided Minority and Non-Minority Dental Colleges in Andhra Pradesh
- The total fee shall be collected for a period of 4 years as per regulations of Dental Council of India and year-wise fee shall be collected in the beginning of each year.

Instructions to the Candidates:-

- Candidates are advised to go through the Prospectus /Regulations of Dr. NTR UHS available on website before exercising web options. Also requested to go through the “Information on Counselling Procedure” placed on 23-08-2025.
- The number of seats available under Management Quota Category B1, B2 & Category C (NRI) in Private Unaided Non-Minority Dental Colleges is given at Annexure-I.
- Only Muslim minority candidates are eligible to exercise web options for Management quota seats in Un-aided Private Minority Dental college.** If Muslim Minority Candidates are not available, the seats will be allotted to Non-Minority Candidates in the Stray Round of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Dental College.
- The allotments will be as per merit and the prioritised options exercised by the candidates.
- Options:**
 - The eligible candidates present in the Provisional Final Merit list displayed on 22-08-2025 should exercise options.
 - A candidate has to exercise options for the interested dental colleges in the order of priority.
 - Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
 - The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - Candidates are instructed to take the printout of the saved options.
- Candidates have to exercise options for B category and if eligible for C Category (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
- Candidates will receive the message regarding allotment of seat, if seat is allotted.
- Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.

9. Selected candidates have to report to the Principal of the allotted college before the last date and time for joining as specified on the allotment letter with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.
10. Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges relevant documents as per Prospectus.
11. B1 seats will be filled FIRST in a college based on options by order of merit from the merit list displayed under these regulations - Candidates from all over the country and A.P are eligible
12. B2 seats - Local Candidates of Andhra Pradesh are only eligible and will be filled after exhaustion of B1 Seats in a college as per prioritized options and by order of merit from the merit list displayed under these regulations
13. NRI seats – Candidates opted as NRI as per Merit list are only eligible.
14. The candidates who do not report at the allotted college in the 1st phase counselling, will be allowed to participate in the 2nd Phase counselling and particular Not Reported seat of Phase – I MQ shall not be available for that candidate to exercise web options in Phase-II MQ counselling.
15. Next rounds of counselling (exercising web options) will be conducted for:
 - a. Unfilled seats in phase – 1.
 - b. Not reported / Not joined seats after Phase-1
 - c. Resultant vacancies due to sliding of candidates from one college to another college during Phase-II counselling.
