to the University is 23.10.2025 with a fee of 3000/-**

The following guidelines and instructions should be followed in submitting Dissertations which are to be sent for Evaluation to the Examiners.

- a. The principals are informed to direct the eligible candidates who have to appear for MD (Homeo.,) and MD (Ay) part-II examinations to submit the dissertations in soft copy (CD) in PDF format to the University for sending the same to the external examiners for Evaluation as per NCH & NCISM regulations.
- b. The candidates whose topics were approved earlier need not submit again.
- c. The candidates have to submit two more soft copies of the Dissertations to the principals, which are to be retained by the HoD's/college officers for evaluation by the concerned internal examiners.

MODE OF PAYMENT:

1. The principals are advised to collect and remit the dissertation fee of all the students through online payment mode by clicking the below link <https://drntr.uhsap.in/epay> by entering the amount to be paid.
2. While doing the payment the respective one should fill all columns, and brief about the payment in the Remarks column.
3. The principal is requested to submit the receipts obtained after completion of the online payment should submit to the University along with the material without fail.
4. The payments paid after the due date shall not be accepted under any circumstances.
5. The Dissertations received after the above specified date will not be accepted and the candidate will not be allowed to **December,2025** Examinations.
6. Therefore, the Principals are requested to arrange to send the Dissertations to the University on **or before 23.10.2025 without fail.**
7. **“As per NCH & NCIM Regulations, the candidate shall be allowed to appear for Part-II examination after the examiners accept the dissertation, whose dissertation has not been accepted by the examiners will not be allowed for the Part-II Examination.”**
8. The principals are requested to send the soft Copies of the Dissertations submitted by all the candidates through a special Messenger only duly sending the details of the candidates in the enclosed proforma.
