UNDER CATEGORY – “C” / NRI QUOTA IN**

- 1) New Government Medical Colleges permitted from the academic year 2023-24 onwards;
- 2) Private Un-aided Non-Minority and Minority Medical Colleges and Dental Colleges affiliated to Dr. NTRUHS; and
- 3) Sri Padmavathi Medical College for Women (Under SVIMS), Tirupati.

In continuation to this Office Notification dt:26-07-2025 & Notice dt:02-09-2025, it is hereby informed that the Candidates who are found in the Management Quota Final Merit List registered for Category-B1 /B2 seats only [not registered under Category-C(NRI)] and wish to apply for Category-C(NRI) seats after Phase-II can now upload relevant / valid documents as notified in the Prospectus /Regulations through their respective login ID's as per the following schedule with Late Fee.
