Notification for exercising Web Options for the 1st Phase of web-based counselling for admission into B.Sc. (Nursing) 4-YD Course under Competent Authority Quota seats for the Academic Year 2025-26.

In continuation to the Provisional Final Merit List displayed on 18.10.2025, the University hereby notify the 1st phase of web-based counselling for Admission into B.Sc. (Nursing) 4-YD Course for the seats available under Competent Authority Quota including Special Category, i.e., PwBD in Government Nursing colleges and Private Non-Minority and Minority Nursing Colleges for the academic year 2025-26.

All the Eligible candidates who got their uploaded copies of certificates verified and whose names are present in the Provisional Final Merit List displayed on 18.10.2025 can exercise their Web Options.

Instructions to candidates:

1. Candidates are advised to read the regulations and prospectus of Dr. NTR UHS available on Website carefully before exercising web options.
2. Candidates can exercise web options through <https://apuhs-ugadmissions.aptonline.in/UGNRFY/Home/StudentLogin> from home or any other place having internet facility. Use only system with Internet Explorer versions 11 or above. DO NOT USE TABS OR MOBILES TO EXERCISE WEB OPTIONS.
3. Candidates can exercise options to all colleges to which they are eligible. The allotment of seats will be as per the order of priorities/options given by the candidate. There is no limit for the number of options.

The seats in Minority Nursing colleges affiliated to University for the academic year 2025-26, if any, will be allotted to respective Minority Candidates.

4. Candidate can exercise web options from any place having internet facility. One Time Password will be sent to the registered mobile number at the time of saving Web options.
 - I) Selected Options can be slided either up or down, added and deleted.
 - II) Web options opted must be saved by the candidate.
 - III) Web options once submitted cannot be edited.
 - IV) Web options saved but not submitted until the cut-off date and time will be Auto submitted.
5. Candidates are instructed to take a print-out of saved options.

7. The allotment of seats is as per the following Government Orders :

All unfilled seats under PwBD quota will be converted and added to respective categories, since the seats under special category are Horizontal Reservation.

8. (a) Candidates have to check website <https://drntr.uhsap.in> for allotment of seats after closure of date of exercising options for status of allotment.
 - (b) Candidates will receive the message to their registered mobile after allotment of seat, if seat is allotted. The candidates are instructed to visit the Website: <https://drntr.uhsap.in> for status of allotment after closure of Web Options.
 - (c) No individual communication will be sent to the candidates. Candidates are advised to check the university website <https://drntr.uhsap.in> from time to time for all further notifications for exercising web-options, list of allotted candidates, instructions, etc.,
- 9 Candidate has to download the allotment letter by paying the University Fee through payment gateway.

1. University Fee:

₹. 5,600/- (Rupees Five thousand Six hundred only). The Selected Candidates have to pay non-refundable University fee through payment gateway using online payment method (Debit Card/Credit Card/Internet Banking) and applicable bank charges for downloading allotment order.

2. Tuition Fee:

As fixed by the Government for Government colleges/unaided Non-minority and Minority colleges:

10. Reporting at the allotted college:

Candidate has to take print-out of allotment order. Check their allotment and report to the Principal of respective college before the date specified on the allotment letter.

- 11.1. The selected candidates shall report to the Principal with all original certificates, allotment order and Provisional Verification form, pay the College fee before the last date and time at the allotted college as mentioned in the allotment letter.
- 11.2. Verification of Original Certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.

12. The University Fee once paid shall not be refunded under any circumstances.
13. Next rounds of counseling will be conducted for :
- a. Leftover seats in Phase - I
 - b. Not reported / Not joined seats
 - c. Seats added, if any
14. **If not allotted any seat in Phase-I:**
Candidates who have not been allotted any seat in the Phase-I of counselling will be considered for available vacancies in Phase-II of counselling with fresh Options.
15. **If not reported at the allotted college:**
The candidates who do not report at the allotted college in the Phase-I counselling, will be allowed to participate in the Phase-II counselling with fresh options, provided that the candidates have no right to claim earlier Phase-I allotted seat again under Phase-II counselling.
16. If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order alongwith Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
17. Candidates getting upgraded in Phase-II of Counselling will not have any claim on previous allotments, i.e., Phase-I seat as the vacancies resulting from upgradation are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.
