MANAGEMENT (CATEGORY B1, B2 & CATEGORY C (NRI)) QUOTA SEATS
FOR THE ACADEMIC YEAR 2025-26**

In continuation to this Office notification dt. 08.10.2025, Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising **Web Options for Phase-II** of counselling for admission into **Management (category B1, B2 & category C (NRI)) Quota** seats of BDS course under Dr. NTR UHS for the academic year 2025-26:

All the candidates whose names are present in the Final Merit Position displayed on 22-08-2025 in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website.

University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

Tuition Fee:

- Tuition fee for the academic year 2025-26 will be as per the orders of the Govt. of Andhra Pradesh, and subject to the outcome of W.P.Nos.32975, 33162 & 35090 of 2022.
- The following is the tuition fee for the academic year 2024-25 as per G.O.Ms.No.503, HM & FW (C1) Dept., Dt.06.08.2024 in respect of the Category-B & C (NRI) seats in Private Un-aided Minority and Non-Minority Dental Colleges in Andhra Pradesh
- The total fee shall be collected for a period of 4 years as per regulations of Dental Council of India and year-wise fee shall be collected in the beginning of each year.

NOTE : Candidates those who were allotted a seat in the Phase-I under Management Quota and paid University fee need not pay again, if there is a change in the seat allotment as per the fresh options. However, they should download the allotment order and report at the newly allotted college with Custodian Certificate issued by the earlier college under Dr. NTRUHS.

Instructions to the Candidates:-

1. Candidates are advised to go through the prospectus for the regulations of Dr. NTR UHS available on website before exercising web options.
2. The number of seats available under Management Quota Category B1, B2 & Category C (NRI) in Private Unaided Non-Minority and Minority Dental Colleges is given at Annexure-I.
3. The allotments will be as per the prioritised options exercised by the candidates.
4. Only Muslim minority candidates are eligible to exercise web options for Management quota seats in Un-aided Private Minority Dental colleges.
5. If Muslim Minority Candidates are not available, the seats will be allotted to Non- Minority Candidates in the Stray Vacancy Round of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Dental Colleges.
6. The candidates who have joined in BDS Course under Management Quota in earlier counsellings of Dr. NTRUHS are also eligible for exercising options in this Phase-II of counselling, if they wish to slide to other college or to another category. The candidates are also eligible to slide from category 'C' to category 'B'.
7. The candidates who have not reported at the allotted college in the 1st phase counselling under the notification dated.08-10-2025, will be allowed to participate in the Phase-II counselling. However, the candidate is not eligible to opt for that particular seat not reported under Phase-I, again under Phase-II of Counselling.
8. **Options:**
 - a. The eligible candidates present in the Provisional Final Merit list displayed on 22-08-2025 should exercise options.
 - b. A candidate has to exercise options for the interested Dental colleges in the order of priority.
 - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and email at the time of entering and submitting web options.
 - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - e. Candidates are instructed to take the printout of the saved options.
9. Candidates have to exercise options for Category - B seats and if eligible for Category - C (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
10. Candidates will receive the message regarding allotment of seat, if seat is allotted.
11. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
12. Selected candidates have to report to the Principal of the allotted college before the last date and time for joining as specified on the allotment order with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.

13. If the joined candidate of Phase-I slides to other college during Phase-II of counselling, the original certificates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with custodian certificate issued by the previous college under Dr. NTR UHS and to pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
14. Candidates allotted seat under NRI Quota should produce the relevant sponsorship Declaration from NRI in Original along with supporting documents as specified in the Prospectus, at respective colleges.
15. Next phase for Phase-III counselling (exercising web options) will be conducted for:
 - a. Unfilled seats in Phase – II.
 - b. Not reported / Not joined seats after Phase-II.
 - c. Arising vacancies during process of Phase-III Counselling.
16. The University fee once paid shall not be refunded or adjusted to a future date under any circumstances.
17. Decision of Competent Authority is final.
18. Dr. NTR University of Health Sciences does not entertain or support seat blocking/ cancellation of BDS seats.
19. In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
