In view of the above and in continuation to this Office notifications dt.17-11-2025, Dr. NTR UHS, Vijayawada hereby notifies the following schedule for exercising **Web Options for STRAY ROUND-II** of counselling for admissions into MBBS course for the academic year 2025-26 under Management Quota.

The eligible candidates who are willing and interested to opt for the above vacancies only can exercise web options as per the above schedule subject to the conditions laid down in the information on Counselling Procedure notified on 23-08-2025.

1) **SECURITY DEPOSIT:**

As already notified, the eligible candidates who are willing to participate in Phase-III counselling under Management Quota have to pay a **Refundable Security Deposit Amount of Rs.3,00,000/-(Rupees three lakhs only)** through online mode before exercising web options, subject to the conditions:

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Phase-III, if any, will be forfeited.
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).
 - **NOTE**: 1) The candidates who have already paid security deposit and were not allotted seat under Phase-III MQ need not pay again, such candidates can exercise web options under this notification.
 - List of eligible and not eligible candidates for refund of Security Deposit will be displayed in the University website after closure of Admissions only.

2) University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

3. Instructions to the Candidates:-

- 1. Candidates are advised to go through the prospectus / regulations of Dr. NTR UHS available on website before exercising web options.
- 2. The allotments will be as per the prioritised options exercised by the candidates.
- 3. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Stray Vacancy Round of Counselling.

4. Options:

- a. Subject to payment of security deposit amount, the eligible candidates who are aspiring to join under Management Quota under this phase have to exercise prioritised web options as per the schedule notified.
- b. A candidate has to exercise options for the interested medical colleges in the order of priority.
- c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and email at the time of entering and submitting web options.
- d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
- e. Candidates are instructed to take the printout of the saved options.
- 5. Candidates have to exercise options for Category C (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
- 6. <u>IMPORTANT NOTE</u>: if a candidate allotted a seat in Phase-III CQ / MQ and Stray Round of CQ/ MQ of Dr. NTR UHS, is not eligible to participate in Stray Round-II of Management Quota regardless of whether they applied or chose options. Such names will be deleted before processing allotments for this Phase.

Further, the candidates whose names were shared by MCC as per Notices dated.28-10-2025 & 15-11-2025 are not eligible to participate in Stray Round of counselling under this Notification.

- 7. Candidates will receive the message regarding allotment of seat, if seat is allotted.
- 8. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
- 9. Candidates who are allotted seat in Stray Round of counselling have to report to the allotted college **compulsorily** with all original certificates provisional allotment order, copy of final application, and pay the tuition fee and college fee. Such candidate cannot resign the seat allotted.
- 10. No candidate is permitted to withdraw from the course till closure of the admissions.

- 11. <u>Candidates allotted seat under NRI Quota should produce the relevant sponsorship Declaration from NRI in Original along with supporting documents as specified in the Prospectus, at respective colleges.</u>
- 12. The University fee once paid shall not be refunded or adjusted to a future date under any circumstances.
- 13. Decision of Competent Authority is final.
- 14. Dr. NTR University of Health Sciences does not entertain or support seat blocking/ cancellation of MBBS seats.
- 15. In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
