



**NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-III COUNSELLING FOR  
ADMISSION INTO BDS COURSE UNDER MANAGEMENT QUOTA, 2025-26**

Keeping in view of the extension of Schedule for BDS course, 2025-26 notified on 08-12-2025 by the Medical Counselling Committee (MCC), O/o DGHS, Govt of India, New Delhi, Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising **Web Options for Phase-III** of counselling for admissions into **BDS course under Management Quota** for the academic year 2025-26.

All the candidates whose names are present in the Final Merit Position displayed on 22-08-2025 and subsequent eligible lists notified on 19-09-2025, 01-10-2025 & 24-10-2025 in the University Website are only eligible to exercise web options as per the above schedule subject to the conditions laid down in the information on Counselling Procedure notified on 23-08-2025.

**1) SECURITY DEPOSIT:**

As already notified, the eligible candidates who are willing to participate in Phase-III counselling under Management Quota have to pay a **Refundable Security Deposit Amount of Rs.2,00,000/- (Rupees two lakhs only)** through online mode before exercising web options, subject to the following conditions:

- Refundable Security Deposit of candidates who do not join the seats allotted to them in Phase-III, if any, will be forfeited.**
- If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- Also, the Security Deposit will be forfeited, if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).**

**NOTE:** List of eligible and not eligible candidates for refund of Security Deposit will be displayed in the University website after closure of Admissions only.

**2) University Fee:**

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

**NOTE :** Candidates those who were allotted a seat in the Phase-I or Phase-II under Management Quota and paid University fee need not pay again, if there is a change in the seat allotment under same category as per the fresh options. However, they should download the allotment order and report at the newly allotted college with Custodian Certificate issued by the earlier college under Dr. NTRUHS.

### 3) Tuition Fee:

### **Instructions to the Candidates:-**

- Candidates are advised to go through the prospectus for the regulations of Dr. NTR UHS available on website before exercising web options.
- The number of seats available under Management Quota Category B1, B2 & Category C (NRI) in Private Unaided Non-Minority and Minority Medical Colleges is given at Annexure-I.
- The allotments will be as per the prioritised options exercised by the candidates.
- Only Muslim minority candidates are eligible to exercise web options for Management quota seats in Un-aided Private Minority Dental college.
- If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Stray Vacancy Round of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Dental Colleges.
- The candidates who have joined in BDS Course under Management Quota in earlier counsellings of Dr. NTRUHS are also eligible for exercising options in this Phase-III of counselling, if they wish to slide to other college or to another category. The candidates are also eligible to slide from category 'C' to category 'B'.
- The candidates who have not reported at the allotted college in the Phase-I or Phase-II counselling will be allowed to participate in the Phase-III counselling. However, the candidate is not eligible to opt for that particular not reported seat under Phase-I or Phase-II again under Phase-III of Counselling.
- There will be no sliding or Free Exit after Phase-III of counselling.**

9. **Options:**

- a. Subject to payment of security deposit amount, the eligible candidates who are aspiring to join under Management Quota under this phase have to exercise prioritised web options as per the schedule notified.
  - b. A candidate has to exercise options for the interested Dental colleges in the order of priority.
  - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and email at the time of entering and submitting web options.
  - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
  - e. Candidates are instructed to take the printout of the saved options.
10. Candidates have to exercise options for category - B seats and if eligible for Category - C (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
11. **IMPORTANT NOTE: if a candidate allotted a seat in Phase-III of Competent Authority Quota of Dr. NTR UHS, is not eligible to participate in Phase-III of Management Quota regardless of whether they applied or chose options. Such names will be deleted before processing allotments for this Phase.**
12. Candidates will receive the message regarding allotment of seat, if seat is allotted.
13. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
14. Candidates who are allotted seat in Phase-III (Mop-up round) of counselling have to report to the allotted college **compulsorily** with custodian under Dr NTR UHS or with all original certificates (freshly allotted), provisional allotment order, copy of final application, and pay the tuition fee and college fee. Such candidate cannot resign the seat allotted.
15. If the joined candidate of Phase-I or Phase-II slides to other college during Phase-III of counselling, the original certificates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with custodian certificate issued by the previous college under Dr. NTR UHS and to pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
16. **After completion of Phase-III counseling, no candidate is permitted to withdraw from the course till closure of the admissions.**
17. Candidates allotted seat under NRI Quota should produce the relevant sponsorship Declaration from NRI in Original along with supporting documents as specified in the Prospectus, at respective colleges.
18. **Subject to availability of seats, next phase for Stray Round of Counselling (exercising web options) will be conducted for:**
- a. Unfilled seats in Phase – III, if any
  - b. Not reported / Not joined seats after Phase-III, if any
- NOTE:** Eligibility and other conditions for Stray Round of Counselling, please refer “Information on Counselling Procedure notified on 23-08-2025”.
19. The University fee once paid shall not be refunded or adjusted to a future date under any circumstances.
20. Decision of Competent Authority is final.
21. Dr. NTR University of Health Sciences does not entertain or support seat blocking/ cancellation of BDS seats. In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
