

Notification for exercising web options for **Stray Vacancy Round** of web-based counseling for admission into **B.Sc. (Nursing) 4 Year Degree Course** under **Competent Authority Quota** Seats for the academic year 2025-26.

In continuation to the earlier notification dated 27.11.2025 and after completion of Phase-III Counselling, the University hereby notifies the following in connection with **Stray Vacancy Round** of web-based counselling for **admission into B.Sc.(Nursing) 4 YD course under Competent Authority Quota** seats in Government, Private Un-aided Non-Minority & Minority Nursing Colleges affiliated to the University for the academic year 2025-26 for the seats which are unfilled under Phase-III and also fallen vacant due to non-reporting after Phase-III of counselling.

**I) Who are eligible for Stray Vacancy Round?**

- All the eligible candidates who are in the Merit list notified in the website on **18.10.2025 and 27-11-2025 and not admitted in the course under CQ are only** eligible to exercise their options.
- Stray Vacancy Round of counselling will be conducted with fresh options for the available seats after completion of Phase-III counselling.
- Candidates who are **NOT** holding any seat of B.Sc. (Nursing) under Competent Authority Quota are only eligible to exercise web options.
- Candidates allotted seats under Phase-I/II of Management Quota are also eligible to exercise web option under this phase subject to the condition that the candidate is already found in the Merit List of Competent Authority Quota.

**II) Who are NOT eligible for Stray Vacancy Round?**

- The Candidates **who are holding a seat under Competent Authority Quota are not eligible** to Participate in Stray Vacancy Round of counselling.
- The Candidates admitted under Competent Authority Quota upto Phase-III are not eligible to Participate in Stray Vacancy Round of counselling.
- The process of conversion of vacant seats to other categories as per the rules was already completed in the last round of 3<sup>rd</sup> Phase counselling as notified and allotted the seats to eligible candidates by merit as per the exercised web options in the said final phase of counselling. Therefore, all the seats remain unfilled in 3<sup>rd</sup> phase are converted as **Open-Unreserved** and made available for filling in the stray round.

NOTE:- If any vacancy arises due to cancellation of seat before processing of allotments will also be filled.

**General Instructions:**

1. Other conditions specified in notification dated 26.08.2025 remain the same.
2. **Important Note:** Candidates are informed to exercise their options cautiously for interested colleges as per their choice in the preferential order, irrespective of vacancies. No limit for exercising options. The candidates are once again informed not to share their Login details, OTPs with any other persons. The University will process the seat allotments as per the web options exercised from the candidate's login. The candidate is totally responsible for the web options exercised from their login.
3. Candidates will receive the message to their registered mobile after allotment of seat, if seat is allotted. Allotted candidates have to download the provisional allotment order from their login by paying the Non-refundable University fee Rs.5,600/- through online and report to the Principal of allotted college before the last date mentioned in the order.
4. As per the G.O.Ms. No.148, HM & FW Dept., Dt:13-11-2025, all the Unfilled Competent Authority Quota seats after the Stray Round 1 counseling and also vacancies, if any, due to non-joining by candidates at allotted colleges in the Stray Round 1 shall be converted and added to the respective college Management quota vacant seats and will be filled in the subsequent counselling conducted for Management Quota seats.
