**Eligibility to appear for MD (Ay) Second SummativeAssessment regular examinations:**

1. The candidates admitted for the academic year 2024-25, whose admissions are approved by the University and completed study period with minimum **80% attendance** in each subject and minimum **60% Semester Grade Point Average (SGPA) in the Second semester** are eligible to appear for theexaminations in **JANUARY,2026**subject to the course regulations.
2. And the candidates who quailed forfirst Semester Examinations held in **JULY,2025** are eligible to write**MD(Ay) SECOND SUMMATIVE ASSESSMENT** Examinations scheduled to held in **JANUARY,2026.**


