NOTICE TO THE CANDIDATES FOR SPECIAL STRAY VACANCY ROUND OF WEB-BASED COUNSELING FOR ADMISSION INTO MBBS COURSE UNDER MANAGEMENT QUOTA SEATS FOR THE ACADEMIC YEAR 2025-26

Keeping in view of the NEET-UG Special Round Schedule- 2025 notified on 17.12.2025 by the Medical Counselling Committee (MCC), O/o DGHS, Ministry of Health & Family Welfare Dept., Govt. of India, the Competent Authority for admissions under State Quota has decided to conduct Special Stray Vacancy Round of web-based Counselling for admission into MBBS Course under the Management Quota seats for the academic year 2025-26.

In view of the above and in exercise of powers conferred under the Regulation of Admissions into Under Graduate Medical & Dental Professional Courses applicable to Un-aided Minority / Non-Minority Professional Institutions in the State of Andhra Pradesh, the Competent Authority hereby notify the following schedule and rules in connection with <a href="Special Stray Vacancy Round of web-based Counselling for the available unfilled vacancies and vacancies due to not joined after Stray Round -III of MBBS course under Category -C (NRI) of Management Quota for the academic year 2025-26:-

1) **SECURITY DEPOSIT:**

As already notified, the eligible candidates who are willing to participate in Special Stray Vacancy Round of counselling under Management Quota have to pay a **Refundable Security Deposit Amount of Rs.3,00,000/- (Rupees three lakhs only)** through online mode before exercising web options, subject to the conditions:

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Special Stray Vacancy Round, if any, will be forfeited.
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).

2) Web Options:

Eligible candidates will have to exercise fresh web options for Special Stray Vacancy Round as per the seat matrix displayed in the University website. Web options exercised earlier will be treated as 'Null & Void'.

Candidates participating in Special Stray Vacancy Round will have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

"I agree to participate in the Special Stray Vacancy Round of Dr. NTRUHS. I affirm that I am not holding any seat in the previous rounds of NEET UG Counselling, 2025 of All India Quota/State Quota.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round, I will join the allotted seat. If, due to anyreason I do not join the allotted seat my refundable security deposit will be forfeited and any action including legal may be taken by the Competent Authority."

3) General Instructions:

1. Eligible Candidates

- No Fresh registration will be allowed for Special Stray Vacancy Round.
- Eligible candidates who are already found in the Final Merit Position under Management Quota displayed on 19-09-2025, 01-10-2025, 24-10-2025, 17-11-2025 & 20-11-2025 are eligible to participate in the Special Stray Vacancy Round, provided that the candidates should not hold any seat in the previous phases of Counselling of All India Quota / State Quota / Deemed University.
- Eligible candidates have to exercise web options for Special Stray Vacancy Round as per the Schedule notified and as per their priorities. The allotments will be as per the prioritized options exercised by the candidates.

2. Not Eligible Candidates:

- a. Candidate who is not found in the Final Merit List of Management Quota of Dr. NTR University of Health Sciences, A.P., Vijayawada
- b. Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling/ Deemed University.
- c. Candidates found in the list shared by Medical Counselling Committee (MCC) after Special Stray Vacancy Round.
- 3. Candidates will receive the message regarding allotment of seats, if seat is allotted.
- 4. Candidates who are allotted seat under Special Stray Vacancy Round of counselling have to report to the allotted college **COMPULSORILY** with all original certificates, provisional allotment order, copy of final application and pay the tuition fee, college fee, such candidate cannot resign the seat allotted.
- 5. The University fee once paid shall not be refunded / adjusted to future date under any circumstances.
- 6. Dr. NTR University of Health Sciences does not entertain or support seat blocking / cancellation of MBBS seats.
- 7. In case any student is involved in seat blocking, legal action will be initiated against such candidate as per rules.
- 8. Decision of the Competent Authority is final in all aspects.
