Notification for exercising **Web Options** for 3<sup>rd</sup> & Final Phase web-based counselling for admission into **B.Sc. (Nursing) 4-YD Course** under **Management Quota seats** for the Academic Year 2025-26.

In continuation to the Provisional Final Eligible List for admission into **B.Sc. (Nursing) 4-YD course under Management Quota** displayed on 28.11.2025 and 29.12.2025, this University hereby notifies the **3<sup>rd</sup> & Final Phase web-based counselling** to fill up the vacant seats available under **Management Quota (MQ)** and **also the unfilled Competent Authority quota seats after stray round counselling converted as Management Quota** as per G.O.Ms.No.148, dt. 13.11.2025, HM & FW (C2) Department in the Private Non-Minority / Minority Nursing colleges affiliated to the University for the year 2025-26:-

Instructions to Candidates:

- The candidates, whose names are present in the Provisional Final Eligible List after verification of Uploaded/Scanned Original Certificates displayed on 28.11.2025 and 29.12.2025, are only eligible to exercise Web Options. The APNCET-2025 candidates will be given priority and for the leftover seats, the NEET appeared candidates will be considered.
- Candidates are advised to exercise web options as per their choice irrespective of the vacancies.

Important Note:

Candidates are informed to exercise their options cautiously for interested colleges only as per their choice in the preferential order, irrespective of vacancies. No limit for exercising options. The candidates are once again informed not to share their Login details, OTPs with any other persons. The University will process the seat allotments as per the prioritised web options exercised by the candidates through their login IDs. The candidates are totally responsible for the web options exercised from their login.

- The candidates, who secured admission under Phase - 1 or Phase - 2 counselling of Management Quota Seats and wish to change their college as per their choice, can exercise their web options as per the above schedule. The candidates who have not joined in the colleges allotted and also not allotted any seat during the Phase -1 or Phase- 2 counselling can also exercise web options under this notification.

Not Eligible:

All the candidates admitted under Competent Authority Quota upto Stray vacancy round are not eligible to participate under this notification.

- The 3<sup>rd</sup> and Final phase of counselling will be conducted for the following vacancies:

6. Candidates while giving options should note that the seats vacated by the candidates already admitted under Phase-1 or Phase-2 counselling and now slide to other college as per their choice and the vacated seats, if any will also be added & allotted simultaneously during this counselling. **In such case, the earlier joined seat of Phase-1 or Phase-2 will be cancelled automatically and the candidates have no right to claim the same.**
7. The candidates allotted seat in 3<sup>rd</sup> & Final Phase of counselling have to join **COMPULSORILY** in the allotted college.
8. While allotting the seats, preference will be given to Chistian Minority candidates in respect of Minority Seats in College of Nursing, CMC, Vellore, Chittoor campus. If, no eligible Minority candidate, the leftover seats will be converted and allotted to Non-Minority candidates by order of merit in 3<sup>rd</sup> and final phase.
9. Male candidates will be allotted seats, by merit/web options, in the colleges which have given consent to admit.
10. Other conditions specified in notification dated.20.11.2025 remain the same.

**Note:** Candidates are informed to exercise options for all colleges as per their choice in the preferential order irrespective of vacancies. No limit for exercising options.

### **11. Reporting at the allotted college:**

- a. Verification of Original Certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
- b. If the joined candidates of Phase-I or II slides to other college during 3<sup>rd</sup> & Final Phase of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along-with Custodian Certificate issued by the previous college under Dr NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
- c. Candidates getting slid in 3<sup>rd</sup> & Final Phase of Counselling will not have any claim on previous allotments, i.e., Phase-I or II seat as the resultant vacancies due to sliding are filled within this phase by the next eligible candidate in the merit list.
- d. Candidates are advised to refer the Notification No. 4073/EA4/B.Sc. (Nursing) 4-YDC/MQ/2025-26, dated 20-11-2025 issued earlier for eligibility criteria and any other details before exercising web options.
- e. Candidates can exercise options to all colleges to which they are eligible. The allotment of seats will be as per the order of priorities/options given by the candidate. There is no limit for the number of options.
- f. Candidates are instructed to **take a print-out of saved options.**
- g. Candidates will receive the message to their registered mobile after allotment of seat, if seat is allotted. The candidates are instructed to visit the Website: <https://drntr.uhsap.in> for status of allotment after closure of Web Options for downloading the Allotment Order and report at the allotted college within the time given.
- h. The college Principal / College Admission Committee shall verify the original certificates at the time of admission, if any discrepancy / false information found, necessary action will be taken on such students as the University is allotting the seat basing on the uploaded scanned documents without verification of originals.

12. **University Fee: ₹.5,600/- (Rupees Five thousand Six hundred only).** The Selected Candidates have to pay **non-refundable University fee** through payment gateway using online payment method (Debit Card / Credit Card / Internet Banking) and applicable bank charges for downloading allotment order.

The University Fee once paid shall not be refunded under any circumstances.
