In continuation to this office notification dt:26-12-2025, the Competent Authority has decided to call for new online applications from the eligible and interested candidates for admission into BDS Course, 2025-26 under Category- C(NRI) seats available in NIMRA Institute of Dental Sciences, Ibrahimpatnam, NTR District as per the following schedule:

**2) ELIGIBLE CANDIDATES:**

All the candidates whose names are present in the Final Merit Position displayed on 22-08-2025 and subsequent eligible lists under Management Quota notified in the University Website and **NOT HOLDING** any seat (MBBS / BDS both under State Quota or All India Quota) are only eligible to exercise web options as per the above schedule subject to the conditions laid down in the information on Counselling Procedure notified on 23-08-2025.

**3) NOT ELIGIBLE:**

- i. Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling/ Deemed University.
- ii. Candidates allotted BDS seats under Special Stray Vacancy Round of Competent Authority Quota, Dr. NTR UHS, Vijayawada.
- iii. Candidates found in the list shared by Medical Counselling Committee (MCC) after Special Stray Vacancy Round.

**4) SECURITY DEPOSIT:**

As already notified, the eligible candidates who are willing to participate in Special Stray Round of counselling under Management Quota have to pay a Refundable Security Deposit Amount of Rs.2,00,000/- (Rupees two lakhs only) through online mode before exercising web options, subject to the following conditions:

- i. **Refundable Security Deposit of candidates who do not join the seats allotted to them under this Phase, if any, will be forfeited.**
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iv. Also, the Security Deposit will be forfeited, if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).
- v. The candidates who have paid Security Deposit of Rs. 3,00,000/- for MBBS course as per notification dt:26-12-2025 and not allotted any seat can also exercise web options for BDS course without payment of Rs.2,00,000/-.

**5) University Fee:**

The selected candidates have to download the allotment order by paying the **University fee of Rs. 40,100/-** through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and should report compulsorily to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

**6) For eligibility and other details, candidates are advised to go through the Prospectus / Regulations of Dr. NTR UHS available on website before exercising web options.**

**7) The allotments will be based on merit as per NEET UG-2025 Rank.**

**8) INSTRUCTIONS TO THE CANDIDATES:**

1. Other terms and conditions will remain same as per the University notice dt:22-12-2025.
2. The Application submitted for Competent Authority (Convenor) Quota seats **WILL NOT BE** considered for Management Quota seats.
3. The online application must be filled from a desktop or laptop with internet connection.
4. The Application and Processing fee including verification fee including late fees, if any once paid will not be refunded or adjusted to a further date. **The fee is non-refundable. Hence, interested candidates are advised to check their eligibility before applying.**
5. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2025 Rank.
6. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.

7. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
8. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
9. Candidates will receive the message regarding allotment of seats, if seat is allotted.
