- a. Service rendered up to **16.04.2025** shall be considered for In-service candidates.
- b. The Penalty of indemnity bond shall be as per G.O.Ms.No.85, HM&FW (C1) Dept., dt.20-07-2024., Govt. of AP as mentioned below:

“The University shall cancel the DNB Degree of the candidate and the penalty of indemnity bond shall be Rs.50 Lakhs for non-rendering of services after completion of such course for In-service candidates as stated in sub-rule (f) (c) of Rule 1.”

4. As per G.O Ms.No.85, dt.20-07-2024 of HM & FW (C1) Dept., Government of AP and amended as per G.O.Ms.No.143, dt. 31-10-2025 of HM & FW (C1) Dept., Government of AP the following rules shall be followed **subject to any modifications as notified by the Government from time to time and court directions if any:**

Definition of In-service candidate:

- i. Minimum 2 (Two) years of regular service in any Health facilities located in tribal areas of Andhra Pradesh.
- ii. Minimum 3 (Three) years of regular service in any Health facilities located in rural areas of Andhra Pradesh.

iii. Minimum 6 (six) years of regular service in any Health facilities located in urban areas/combinations of service in Tribal/Rural/Urban areas in Andhra Pradesh.

Provided that un-authorized absence or absence due to leave without allowance (including leave on medical grounds) will not be counted for the purpose of calculating in the minimum service.

iv. Upper Age: Candidate should not have completed **50 years of age as on the date of NEET PG Examination notification i.e., 16-04-2025 for admission into P.G. Degree/DNB courses.**

NOTE: Candidates born on or before 16-04-1975 are not eligible.

6. Procedure of filling online application form and payment of fee through online:

- a. The fee can be paid through Debit card / Credit card or Net Banking.
- b. Read the Notification, Prospectus / Regulations carefully regarding eligibility under local and non-local areas.
- c. The Registration number which will be sent to the registered mobile number after entering the basic details, should be noted for further use. The Registration number should be kept confidential and should not be disclosed to others.
- d. The candidates should fill - in all the correct details in the online application form and shall upload all the Scanned Original documents including the certificates which are mandatory.
- e. Annexure-IVA & Annexure-IVB as per the PG Medical Competent Authority Prospectus 2025-26 duly authorized by the respective Appointing Authority only shall be uploaded by In-Service candidates.
- f. The certificates are to be scanned and kept ready to upload. Application fee has to be paid through online.

7. Provisional Final Merit list will be released after verification of all uploaded certificates and Service (Annexure-IVA & IVB) confirmation by the respective Appointing Authority. 9. INSTRUCTIONS TO THE CANDIDATES: -

- a. The process of admissions into DNB seats will be in accordance with the Orders issued from time to time by NMC, New Delhi and Govt. of A.P.

Note: The orders of Govt. of Andhra Pradesh if any received after the Notification will also be implemented from time to time.

- b. Scrutiny of uploaded documents/data will be conducted by the Officials of the University and other Officials from the concerned Departments. After the scrutiny of scanned documents then provisional merit list will be released and then after final merit list will be released.

- c. No separate notification will be given for verification of Original certificates.

- d. The On-line application form with the following lacunae will be rejected automatically. No communication will be sent in this regard.

- i. If any of the mandatory certificates are not uploaded.
- ii. Applications with incomplete details/photo and signature.
- iii. If any of the uploaded certificates are invisible/not properly uploaded.
- iv. If the certificates are not properly scanned due to which the eligibility criteria cannot be determined.

- e. The candidate should produce the Printout of the filled in Online application form, Provisional verification form and all Original certificates along with One set of self-attested Copies to the Principal of the allotted college at the time of joining for final verification. In case of any discrepancy, the Provisional allotment order will be cancelled without any notice. The candidates are informed not to send the print out of application form to the University.

- f. Candidates admission is strictly provisional. The mere fact that the Merit position issued to him/her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the online application are accepted as true and correct. If any in-eligible candidate is present in the Merit position shall not be eligible for admission.

- g. If the information furnished by candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken. If the certificates produced by any candidate are found to be fake/false/forged at any stage of verification or admission, the University has every right to cancel the seat / admission of such candidate without any notice. In case of discrepancy in the downloaded provisional verification form, the same shall be brought to the notice of the University immediately.

- h. Candidates are informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action shall be initiated as per Rules.
- i. Area wise seat matrix will be displayed in the University Website for the information of the students.
