#### **Who are Eligible to Participate in Special Stray Vacancy Round**

1. Candidates who are not holding any type of seat of BHMS/BAMS/BUMS of Central quota or State quota are only eligible to apply under this notification.
2. All the eligible candidates who are in the Merit list notified in the website on **10.10.2025** eligible to exercise their options.

#### **Who are Not Eligible to Participate in Special Stray Vacancy Round**

3. The Candidates who are holding seat of Central quota or State quota are not eligible to Participate in Special Stray Vacancy Round of counselling.
4. The Candidates who are allotted seat in any Phase of Counseling are not eligible to Participate in Special Stray Vacancy Round of counselling.
5. Candidates whose names are found in the Final list of In-eligible candidates notified by AACCC, New Delhi, Vide Ref. 1/1/2025-AACCC, dt.17.10.2025 , 08.11.2025 & 20.11.2025 and if any, notified before allotments of SVR-I are not eligible to participate under this notification & further Phases of UG AYUSH Counselling.
6. As the seats are precious in nature, the not reported candidates if any, will be recommended to the NCISM, New Delhi for debarment from NEET UG -2026. Hence, the candidates are requested to be cautious while opting under this notification.

#### **General Instructions:**

1. The seats that are vacant due to non-reporting after Stray Vacancy Round-2 will be filled in this round.
2. **If the candidate is allotted a seat under this notification, he / she has to report in the allotted college compulsorily.**
3. If they are not interested to join any course or college then they are advised not to exercise options for the same.

4. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
5. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
