### **NOTIFICATION FOR EXAMINATION OF PERSONS REGISTERED UNDER (PwBD) QUOTA DUE TO LOWERING OF CUT-OFF PERCENTILES**

In continuation to this Office notification dated 13-01-2026, and also this Office Notice, dt. 17-01-2026, it is hereby informed that the following candidates who have registered under Persons with Disabilities (PwBD) Quota shall appear before University Medical Board with all original certificates and medical records pertaining to the disability along with a recent passport size photo at **10.00 AM on 29-01-2026 & 30-01-2026** (as per List enclosed). The candidates who do not attend before the University Medical Board on the scheduled date will not be considered for admission under Persons with Disabilities (PwBD) Quota.

As per the NMC interim guidelines dated 15/10/2025 on assessment method for granting admission in Post Graduate courses to PwBD candidates for the Academic Year 2025-26 which is displayed in University website on **18-10-2025, the PwBD candidates must submit:**

1. A valid UDID card issued by a designated medical authority under Ministry of Social Justice and Empowerment (MoSJE).
2. Self-Certified affidavits in the format provided under **Schedule -I**
3. The candidate will have to attend the Medical Board at **10.00 AM on 29-01-2026 & 30-01-2026** (as per List enclosed) for verification of their self-declaration affidavit.
4. Accordingly, all the PwBD candidates are requested to appear before the Medical Board along with the **assistive devices they intend to use** for overcoming the functional limitations while pursuing the course, as declared in their Self-Declared Affidavit. Attendance as per the schedule is mandatory.
5. Please note that the **responsibility to demonstrate functional capability using the assistive devices rests solely with the candidates**, and the University Medical Board will **not provide any assistive devices**.
