Please upload all the following documents **in a "SINGLE PDF" format (as showed in Annexure – I)**, in the order of the following sequence:

- a) Letter of the Principal on the College Letter head. It must contain details of the Locations/ Phone Number/ Email/ name of the Principal.
- b) Receipts of payment of Affiliation/ Inspection Fee
- c) All Government Orders (G.O.s) issued by the Government of Andhra Pradesh.
- d) Letter of Permissions & Letter of renewal permissions issued by the APNMC for the academic year 2026-27.
- e) Permissions issued by the INC, New Delhi during the years 2025/ 2026.
- f) Affiliation Orders issued by the University for the Academic Year 2025-26.
- g) Faculty list as per INC New Guidelines along with undertaking signed by the Principal.
- h) Latest Clinical Permissions issued by the DME/ DSH, A.P for Govt. Hospitals/ Competent Authority for Private Hospitals for the academic year 2026-27.
- i) No Dues Certificate issued by the NTRMEDNET for the academic Year 2026-27.
- j) **Principal's signature along with official seal is must on every page submitted by the College.**

- Note:**
1. All the Nursing Colleges should submit Clinical Permission Letters from concerned departments i.e., DME/ DSH, Govt. of AP in respect of Government Hospitals as affiliated Hospitals
 2. Letter of Permissions/ Renewal Letter of Permissions issued by the APNMC, Vijayawada must be submitted within the stipulated time frame
 3. Principals will be held responsible for ensuring timely submission of the required documents & failure to submit these letters on time will result in "Non-Processing of Applications" without any notice by the University as these are the mandated documents for the processing of Affiliations to the Nursing Institutes
