1. College Login:

- The College must update the following details of the student in the **College Login**:
 - Date of Birth (DOB)
 - Email ID
 - Phone Number
 - Details of the Dissertation

Note:

- Only after this update can students proceed with creating their login.
 - After approval of the Principal of the concerned colleges only student login will be opened.

2. Student Login Creation:

Visit the **Student Portal Login Page** → Select **Create New Login** option.

1. Enter **USN (Unique Student Number)** and the **Registered Email ID**.
 - The system will send an **OTP** to the registered email.
2. Enter the **OTP** for verification.
3. Set a **new password** of choice.
4. Login using **USN + Password**.
5. Upload the Dissertation along with Plagiarism certificate.
6. Payment of fee.

3. College has to verify the uploaded Dissertation and fee payment particulars and approve the details at college level by Guide and Principal.
