**Prospectus for admissions into "Post Graduate Dental Degree / Diploma Courses under Competent Authority Quota for the academic year 2026-27"**

**REGULATIONS:**

The following are the Regulations for admission into the Competent Authority Quota (CQ)/State quota (SQ) seats of all Post Graduate Dental Degree/Diploma Courses in all the Dental Colleges affiliated to Dr. NTR UHS for the academic year 2026-27.

**1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:**

- a. Government Dental Colleges: 50% of the total available seats are in State quota under Competent Authority. 50% of seats are surrendered to AIQ which are filled by MCC, New Delhi.
- b. Private Un-Aided Non- Minority Dental Colleges: 50% of the total available seats are in Competent Authority Quota. Remaining 50% are under Management Quota(MQ).
- c. Provided that the candidates who got registered as Persons of Indian Origin (PIO) / Overseas Citizen of India (OCI) Cardholders on or after 04.03.2021 are eligible for admission only against any Non-Resident Indian seat or any supernumerary seat; and shall not be eligible for admission against any seat reserved exclusively for Indian Citizens.
- d. The details of the seats available under Competent Authority quota for the year 2026-27 will be displayed in the University website before the start of web counseling.
- e. As per NMC Letter No.N-P018(20)/5/2023-PGMEB-NMC/044351, dt.24-07-2023 all the State Counselling agencies shall make necessary arrangements for conducting the counselling in Online mode, for all the rounds including Stray vacancy round in Private Dental Colleges, from the academic year 2023-24. No, College/Institute should conduct the counselling, including the Stray vacancy round, in physical mode.
- f. **As per G.O.Ms.No 85, HM & FW (C1) Dept., dt.20-07-2024, the Govt. of A.P has dispensed with In-Service quota in PG Dental Courses from the academic year 2024-25.**

**2. ELIGIBILITY: THE CANDIDATES WHO FULFILLED THE FOLLOWING CRITERIA ARE ELIGIBLE:**

- 2.1 The applicant for admission to the PG Dental Degree/Diploma courses must have a B.D.S. Degree (Bachelor of Dental Surgery) from a recognized Dental college/University.
- 2.2 The candidates should have secured the following cutoff scores and above in NEET MDS-2026

- 2.3 Candidates should have completed internship by **31-05-2026**.
- 2.4 The candidate shall produce certificate of registration with Dental Council of India / Any State Dental Council.

### **3. TUITION FEE STRUCTURE:**

**8.5 Tuition fee for the current academic year 2026-27 will be as decided by the Govt. of A.P., subject to the outcome of W.P.Nos.32975, 33162 & 35090 of 2022. For previous fee structure Refer point 8.7**

### **4. ALLOTMENT OF SEATS:**

- 4.1
- a. As per G.O.Ms.No.86, HM&FW (C1) Dept., dt.20-07-2024, the Govt. of A.P. issued orders to de-notify Government Dental College & Hospital, Vijayawada as a state wide Institution and reclassify it as a Non-Statewide Institution from the academic year 2024-25 and to fall under the jurisdiction of Andhra University (AU).
  - b. All the affiliated dental colleges in the State of A.P. are non-statewide from the year 2024-25.
- 4.2 The Courses available at Private un-aided Non-Minority Dental Colleges are Non - Statewide. Selection procedure for Competent Authority Quota seats shall be regulated as per the procedure envisaged in Annexure III of G.O.P.No.646, Education Dept., dated. 10.07.1979.

### **5. RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES:**

Admission to 85% of the seats shall be reserved in favour of the local candidates of AU & SVU Regions in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order, 1974 for Non-State wide courses as given in Annexure-III of GO (P) No. 646, Edu. (W1) Department, dt.10-7-1979.

- 5.1 As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.

- ***Candidates of OU local area are not eligible for MDS seats in the State of Andhra Pradesh.***
- ***Candidates of OU Local area with AP Domicile(APNL) are eligible for APUR seats in the State of Andhra Pradesh.***
- ***Non-Local(NL) Candidates are not eligible for MDS Local seats in the State of Andhra Pradesh.***
- ***NL Candidates with AP Domicile(APNL) are eligible for APUR seats in the State of Andhra Pradesh.***



## 5.2 LOCAL AREA :

As per G.O.Ms.No.95, dt. 20-07-2026 of HM & FW (C1) Dept., Govt. of A.P., the interim arrangements notified vide G.O.Ms.No.83, HM&FW (C1) Department, dated 23.07.2025 for the Academic Year 2026-27 are as follows:

- 5.2.1 **Andhra University Area:** The part of the State comprising the erstwhile Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area for the purposes of admission to the Andhra University, (Nagarjuna University) and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.
- 5.2.2 **Sri Venkateswara University Area:** The part of the State comprising the erstwhile Districts of Anantapur, Kadapa, Kurnool, Chittoor and Nellore shall be regarded as local area for the purposes of admission to Sri Venkateshwara University and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

## 5.3 LOCAL CANDIDATES:

- 5.3.1 A candidate for admission shall be regarded as local candidate in relation to a local area.
- i) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in relevant qualifying examination.
- or
- ii) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.
- 5.3.2 For candidates who have taken admission before 2024-25 and completed BDS Degree from State Wide College:  
A candidate for admission to any course of study who is not regarded as a local candidate under sub-regulation (5.2.1) in relation to any local area shall
- i) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to:
- a) Such local area where he/she has studied for the maximum period out of the said period of 7 years.

- b) Where the period of his/her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods.

or

- ii) If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to

- a) Such local area where he/she has resided for the maximum period out of the said period of 7 years.

or

- b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

or

- c) Local status certificate issued by MRO for claiming as AP local as per Circular Nos.4136/SPF&MC/2015-5, dated.08.08.2016 and 4136/SPF&MC/2015-13, dt. 20.11.2017.

**EXPLANATION:**

- (for purpose of this sub-regulation)
- i) Educational Institution" means a University or any Educational Institution recognized by the State Government, a University or any other Competent Authority.
- ii) Relevant qualifying examination in relation to admission to any course of study means the examination, a pass in which is the minimum educational qualification for admission to such course of study.

**NOTE:**

The relevant qualifying examination for admission into MDS courses is BDS examination. The question whether the candidate is a local candidate or not will be determined with reference to his/her first appearance in the Final BDS examination.

- iii) a) In reckoning the consecutive academic years during which a candidate has studied any period of interruption of his/her study by reasons of his/her failure to pass any examination and any period of his/her study in a Statewide University or a Statewide Educational Institution shall be disregarded.
- b) The local/non local status of candidates who have taken admission before 2024-25 and passed BDS from Govt. Dental College, Vijayawada, Govt.Dental College, Hyderabad and Army College of Dental Sciences, Secunderabad will be decided basing on their study period prior to their admission into BDS course. The question whether any candidate for admission into any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his/her parent or guardian.
- c) Candidates admitted into BDS course at Government Dental College, Vijayawada and Government Dental College, Hyderabad under OU quota shall not be considered as a Local candidates.



**5.4** While determining the number of seats to be reserved in favour of local candidates under regulation (4), any fraction of seat shall be counted as one, provided that there shall be one unreserved seat.

**5.5** If a local candidate in respect of a local area is not available to fill any seats reserved or allocated in favour of local candidate in respect of that local area such seats shall be filled in as if it had not been reserved.

**5.6** The applicant who claims to be local candidate with reference to sub-regulation 5.2.1 or 5.2.2 shall produce in the form of study certificate/certificates issued by the Head of the Educational Institution/Institutions concerned indicating the details of the year or years in which the candidate has studied in educational institution in such local area for a period of not less than 4/7 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the Final BDS examination.

Those who did not qualify as local candidate under sub-regulation 5.2.1 and 5.2.2 but claim to qualify by virtue of residence shall produce a certificate issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer independent charge of Subtaluk / Mandal in the form annexed to G.O.P.No.628, Education dated 25-7-1974.

**5.7** The following categories are eligible to apply for admission to the remaining 15% of Unreserved seats.

**5.7.1** As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.

- a) All the candidates eligible to be declared as local candidates of two local areas of State of Andhra Pradesh.
- b) Candidates who have resided in the State of Andhra Pradesh for a total period of 10 years excluding periods of study outside the State or either of whose parent have resided in the State of Andhra Pradesh for a total period of ten years excluding period of employment outside the State.
- c) Candidates who are children of parents who are in employment of the State of Andhra Pradesh or Central Government, Public Sector Corporations, Local Bodies, Universities and Educational Institutions other similar quasi Public Institutions within the State of Andhra Pradesh.
- d) Candidates who are spouses of those in the employment of the State of Andhra Pradesh or Central Government, public sector corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University or other Competent Authority and similar quasi Government Institutions within the State of Andhra Pradesh.”

**NOTE: Relevant scanned original certificates must be uploaded along with application in respect of their claim for 15% Unreserved seats. In respect of proof of 10 years residence, the certificate should be obtained from the Revenue Authorities and the issuing Officer shall not be below the rank of Mandal Revenue Officer / Tahsildar**

## **6. RESERVATIONS:**

6.1 Seats of Post Graduate Dental Degree and Diploma Courses are reserved for SC, ST and BC and BC sub groups as detailed below, which are called vertical reservations

6.2 As per Memo No.2825083/C1/2025, dt.23-05-2025 of HM&FW (C1) Dept., Govt. of AP the reservations provided to the three groups of Scheduled Castes shall be within fifteen (15%) of reservation prescribed to Scheduled Castes as follows:-

6.3 As per Memo No.2832690/C1/2025, dt.15-07-2025 of HM&FW (C1) Dept., Govt. of AP the implementation of SC sub-classification when availability of seats are less, has been examined in consultation with Social welfare Department and Government after careful examination of the matter, hereby clarify that:

- 1) When particular seat is not available, the rules with regard to sub-classification specify that if Group-I eligible candidates for admission is not available it shall be filled in by the candidate belonging to Group-II and so on and so forth.
- 2) In cases where the availability of seats is limited/less, the Competent authority for admissions may take appropriate administrative decisions regarding net group adjustments among the sub-groups of Schedules Castes (SCs). This should be done by duly following the established procedure for net group adjustments as is practiced among the Backward Classes (BC) sub-groups. Such decisions must be placed before the selection committee for admissions, by justified reasons taking the spirit of sub-classification of Scheduled Castes.

#### **6.4 CERTIFICATION OF CASTE:**

- 1) As per Memo No.2832690/C1/2025, dt.21-07-2025 of HM&FW (C1) Dept., Govt. of AP the **latest Online Caste certificates issued by the Government of A.P will only be considered for admissions.**
- 2) Scheduled Caste, Scheduled Tribe and Backward Class candidates shall in support of their claim, have to furnish latest Integrated Caste Certificate (Online) with Barcode obtained from Government of AP in the prescribed form issued by the Concerned Authority. If the certificate is not in the prescribed form, candidates will not be considered for selection under the reserved quota.
- 3) Latest Permanent caste certificate online (issued by Competent Authority of Govt. of Andhra Pradesh only). Caste certificates of other States will not be accepted & in such cases the applied candidate will be considered under General category only.
- 4) Candidates claiming reservations under SC/ST/BC categories shall submit a permanent social status certificate mentioning the sub- caste in case of Scheduled Castes/ Backward Castes and sub-tribe or sub-group (in case of Scheduled Tribes) issued by the Competent Authority of Government of Andhra Pradesh only. The social status of SC/ST/BC candidates shall be subject to the scrutiny as per G.O.Ms.No.58 SW (J) Dept. Dt 12-5-97 & as per G.O.Ms.No.7, Social Welfare (CV), dt.18-04-2025.

#### **7. RESERVATIONS UNDER PwBD CATEGORY:**

- 1) There will be 5% Horizontal reservations for PwBD candidates
- 2) The guidelines of Govt. of India and regulations of National Medical Council shall be observed in making admissions under PwBD category.
- 3) The candidates seeking the benefit of reservation under PwBD category should enclose permanent UDID card issued by the Department of Empowerment of Persons with Disabilities (Divyangjan) (DEPwD), Ministry of Social Justice and Empowerment, GoI.
- 4) Self-certified affidavit declaring his or her functional abilities in the format specified in Schedule-I which shall be verified by Medical Assessment Board during the course of assessment.
- 5) Self-Certification Affidavit (Appendix-A) and Affidavit specific to the candidate's disability category, in the prescribed format of NMC as provided in Appendix-B to F.
- 6) The candidates who applied and qualified under PwBD category in NEET MDS – 2026 are only eligible to participate under PwBD category in State Quota seats.
- 7) The Medical Board constituted by the University will scrutinize/verify the disability certificates as per the NMC Guidelines regarding admission of students with “Specified Disabilities” under the Rights of Persons with Disabilities Act, 2016 with respect to admission in Post-graduate Courses.

**9. MERIT LISTS:**

- The merit position of the candidates applied shall be determined basing on NEET-MDS-2026 Ranks and as per their eligibility.
- After completion of the verification of data and certificates uploaded by the candidates, the University will release final merit position of the candidates eligible for exercising Web options.
- Candidates who are included in the final merit list will only be eligible for exercising Web Options.

Further, the Orders, if any, as amended from time to time by the Government of Andhra Pradesh/Dental Council of India/Government of India are applicable.

**11. ADMISSION RULES:**

- 11.1** The cutoff date for reporting at the allotted college by the selected candidates will be communicated in the allotment order.
- 11.2** All the candidates joining the Post Graduate Dental Degree/ Diploma courses should execute bond on a stamped paper of ₹.100/- value as prescribed in Annexure-III to the effect that he / she will complete the prescribed period of training in the event of leaving the course, the candidate has to pay ₹.3,00,000/- to the University and shall also refund the amount received as stipend up to that date to the Government as notified by the University from time to time.

- 11.3** Discontinuation from the course shall be permitted only after completion/closure of the counselling process as per the schedule notified by the Medical Counselling Committee (MCC). Accordingly, candidates shall not be permitted to discontinue the course during any ongoing phase or in the middle of the counselling process for the respective academic year. As per G.O.Ms.No.67, HM&FW (C1) Department dated 21-04-2017, candidates have to pay the discontinuation penalty of ₹. 3,00,000/- and they will be debarred for three years for admission into Post Graduate Dental Degree/Diploma courses at the colleges in the State of Andhra Pradesh for admission into PG Dental courses subject to receipt of orders from the Government if any and as notified by the University from time to time.
- 11.4 SECURITY DEPOSIT:** It is decided to collect a Refundable Security Deposit Amount of ₹.50,000/- (Rupees Three lakh only) through online mode from the candidates who wishes to participate in Phase-III (Mop Up) and subsequent Phases of Counselling to avoid seat blocking. Other details will be notified in the Web Option notification of that Phase
- 11.5 ATTENDANCE:** Candidates selected for the various courses should be the whole time students. The candidate is required to put in a minimum of 80% attendance during each calendar year for being eligible to appear for the examination. In a year all 365 days will be considered as working days and students should get 80% attendance each year separately to get eligibility for appearing for University exams. The remaining days of absence (including maternity leave) will be considered for extension.
- 11.6 LEAVE:** Students will be permitted to avail 30 days of leave per year. No Post Graduate is allowed to go on leave more than 8 days at a stretch. In case the absence of the candidate availing Medical Leave / Maternity Leave / Any other Leave is beyond 30 days in a year, the study period of the candidate will be extended to the extent of such period.
- 11.7 MATERNITY LEAVE:** Women students can avail maternity leave up to 180 days only once in their MDS course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examination till the completion of study period as per DCI Regulations (Duration of course).
- 11.8 BREAK OF STUDY AND RE-ADMISSION:** If a student is absent continuously for a period of 91 days or more and seeks permission to attend the course, his / her application in prescribed format vide Annexures V & VI by paying requisite fee in favour of Registrar, Dr NTR University of Health Sciences payable at Vijayawada shall be forwarded to the Registrar, Dr.NTR University of Health Sciences with the recommendation of the Dean/Principal. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfill the conditions, they may submit applications through the Dean/Principal of the College by paying the fee. **A maximum of two spells of break of study is allowed during the entire period of course including the spells of break of study sanctioned by the Principal of the college. As per DCI Regulations a candidate has to complete the course including passing the final University examination within twice the duration of the course i.e., 6 years from the date of admission to course. Re-admission is not permitted if the candidate cannot complete the course within twice the duration of the course.**

**11.9 PRIVATE PRACTICE:** No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or Central or Quasi Government or Private organizations during the period of Post Graduation study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

**12. COLLEGE REGULATIONS:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under no circumstances they should have any correspondence with the higher authorities directly without routing through proper channel.

**13. CLOSURE OF ADMISSIONS:**

13.1 The admissions shall be closed on the date notified by the MCC/DCI, New Delhi.

13.2 Any vacancy as on the date (or) after the date of closure of admissions shall not be filled. They will not be carried forward to the next year as per the directions of Supreme Court of India.

**14. COMMENCEMENT OF THE COURSE:**

The course shall commence as per the schedule notified.

**15. DURATION OF COURSE:**

The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years from the date of commencement of the course including University Examinations. In case of students having a recognized two year Post Graduate Diploma course in a subject selected for PG Degree in the same subject, then the period of training including the period of examination, shall be two years. If the break of study is more than three months the candidate has to apply (vide Annexure-VI) to the University through the Principal/Dean of the college. The University can give permission to the candidate to complete the course as per Rules based on evidences produced by the candidate for the break of study.

**16. BASIC COURSE IN BIOMEDICAL RESEARCH (BCBR) BY POSTGRADUATE DENTAL STUDENTS**

**1. MANDATORY COMPLETION BY POSTGRADUATE STUDENTS:**

As per NDC circular dated 29.07.2026, all postgraduate (MDS) students admitted from the Academic Session 2026-27 onwards shall successfully complete the Basic Course in Biomedical Research (BCBR) offered through the ICMR-National Institute of Epidemiology (NIE) online learning platform. The course shall be completed during the before submission of Synopsis of thesis of the postgraduate programme.

**2. ELIGIBILITY FOR UNIVERSITY EXAMINATION:**

Successful completion of the BCBR course and submission of the course completion certificate shall be a mandatory prerequisite for appearing in the first year MDS University Examination.

## **17. DISSERTATION:**

The Post Graduates who are admitted in Degree / Diploma Courses must register the topic of their dissertation with the University within six months of commencement of the course and approval of the University should be obtained.

The dissertation should be submitted within 2 ½ years of commencement of the Course. In case of the candidates who are granted exemption of one year of study period of degree course, the dissertation should be submitted within 1 ½ years of commencement of the course. If the above schedule is not followed the period of Post Graduation will be extended by six months.

- The UGC Notification, dt.23-07-2018 published in the Gazette of India regarding “Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions, Regulations 2018” are in force from the academic year 2021-22.

**18.** Paper Presentation/Paper publication should be as per DCI Regulations.

## **19. MIGRATION AND TRANSFER OF CANDIDATES:**

Migration / Transfer / Mutual transfer of Post Graduate students from one Dental college to another Dental College, from one course to another course and from Degree to Diploma and vice versa is not allowed under any circumstances.

## **20. POWERS OF PRINCIPALS:**

Notwithstanding anything contained in these regulations, the Principals of Dental Colleges in the State may at any time before completion of the post graduate course either on their own or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and on personal hearing, order, cancellation of admission to the 1<sup>st</sup> year Post Graduate Degree / Diploma course if in the documents attached thereto or in the Statements made either before the authority in charge of admission or the Principals or in any other manner. Against any such order of the Principal, an appeal shall lie with the Registrar, Dr. NTR University of Health Sciences, A.P. Vijayawada.

## **21. POWERS OF DR. NTR UNIVERSITY OF HEALTH SCIENCES:**

Dr. NTR University of Health Sciences, Vijayawada may either suo moto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation thereto as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. Dr. NTR UHS has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake/false/forged.

**Note: If a candidate is found to have submitted false information such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be initiated by the University as per rules.**

## **22. RAGGING:-**

The candidates who join MDS Courses should not indulge in any kind of agitation / strike / ragging activity inside / outside the college campus during the course of study. The candidates if found to take part in any such activities mentioned above will be expelled from the course / college at any part of the course of study and legal proceedings / criminal action will be initiated against them. A copy of the National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021 is also available in University website for information.

- 23.** The candidates applying for MDS Degree Course for the academic year 2026-27 are deemed to have read the contents in the Prospectus and agree with all conditions / clauses and will not have the right to challenge any of the clauses contained in the Prospectus and agree that the same is binding upon them.

### **FREQUENTLY ASKED QUESTIONS (FAQs)**

**Q. No. 1: When will PG(Dental) Allotments start for State Quota (also called Competent Authority Quota) seats?**

**Ans:** The schedule will be as per MCC/DCI, New Delhi guidelines and you have to visit University Website <https://drntr.uhsap.in/index/> regularly for updates.

**Q. No. 2: Is a candidate required to report to any center for online Registration and Web options?**

**Ans:** The entire process is online only. Not required to report at any center for Registration and Web options.

**Q.No.3. Is one online application sufficient for both Competent Authority Quota(CQ) and Management Quota (MQ) seats?**

**Ans:** Separate applications are required to be submitted for CQ and MQ seats. Visit University website for CQ and MQ Notifications.

**Q.No.4: What is the cut-off date of Internship?**

**Ans:** 30<sup>th</sup> June 2025 is the cut-off date for Internship.

**Q. No. 5: What is the mode of reporting at the allotted college. Do I have to report personally at the allotted College?**

**Ans:** The allotted candidate has to download the allotment letter by paying Rs.23,600/- through online mode. Candidates who are allotted seats should physically report at the allotted colleges along with all **Original Certificates, allotment letter and Provisional Verification Form**, pay the college fee on or before the last date mentioned in the Allotment letter.

**Q.No.6: What is the process of Web options?**

**Ans:** A candidate has to opt for the interested specialties and colleges before commencement of each phase of counselling as and when the Notification is released by Dr. NTR UHS, Vijayawada.

**Q. No. 7: Is there any restriction for filling the number of web options?.**

**Ans:** One candidate can give any number of web options. However, the candidates are advised to exercise web options for the course in which they are genuinely interested to join.

**Q. No.8: Is it necessary to join in allotted seat of Phase-I or Phase-II to get chance to participate in Phase-II or Phase-III?**

**Ans:** If a candidate does not report at the allotted institute in Phase-I and/or Phase-II, this will be considered as 'Free Exit' (**this facility is available only in Phase-I & Phase II**). Candidates who have not joined the Phase-I and/or Phase-II allotted seat may participate again in Phase-II and/or Phase-III. If satisfied with the allotted seat in Phase-I and/or Phase-II, it is not required to participate in further rounds. Rules on Exit option will be issued in detail in the Notification. Candidates shall go through the Notification carefully.

**However, if a candidate has not joined/reported in the allotted seat of Phase-I/Phase-II or resigned from the joined seat of Phase-I/Phase-II, then that particular seat shall not be available for that candidate to exercise web options in Phase-III/Mop Up counselling.**

**Q. No. 9: Will I get any personal intimation regarding schedules and allotments?**

**Ans:** No. The candidates have to visit University website regularly for notifications/schedules.

**Q. No. 10: Can I modify my web options during the choice submission for counseling?**

**Ans:** Yes, you can modify, add or delete your web options before you submit your web options. However, once web options are submitted, they cannot be modified later under any circumstances.

**Q. No. 11: I have not submitted my web options before the time specified in counseling schedule, what will happen to my web options?**

**Ans:** The web options already saved by you will be considered automatically and the web options cannot be altered/modified/changed.

**Q.No.12: Who are eligible for exercising web options in Phase-III(Mop Up)?**

**Ans:**

- a) Candidates who participated in Phase-I and/or Phase-II, but did not allotted seat in the Phase-I and/or Phase-II.

**Q.No.15: What is MRC (Explain with example)?**

Ans: Meritorious Reserved Candidate-MRC

**Example:**

- In a particular college MDS (Conservative Dentistry) seat is under “Open Category” in the seat matrix and a SC candidate is allotted that Open Category MDS (Conservative Dentistry) seat in Open Round Counselling of Phase-I as per his/her web options and NEET -MDS Rank merit order of the candidate. Now this candidate is shown as **Meritorious Reserved Candidate (MRC)**.
- The same SC candidate has slid to MD (Prosthodontics) SC category seat in the same college or another college during the Category Round of Phase-I Counselling **conducted on the same day**, then that MD (Conservative Dentistry) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.

- c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation
- d) G.Os governing MRC and other regulations:

**Q.No.16: Who are eligible/not eligible for Stray Vacancy Round if conducted as per MCC, New Delhi Schedule?**

**Eligible candidates:**

- a) The candidates who have not been allotted in Phase 1, Phase 2, Phase 3 of counselling.
- b) The candidates who have been allotted, but not joined in Phase 1, Phase 2 of State Quota and All India Quota are eligible to participate in this counselling.
- c) A Candidate who has not registered and not choice locked in the Phase 1 or Phase 2 or Phase 3(Mop up) ONLINE COUNSELLING will be permitted to attend Stray Round of ONLINE COUNSELLING

**Not Eligible Candidates:**

- a) The candidates who are holding MDS seat in Round 1, Round 2 and Round 3 (Mop Up) of State Counselling are not eligible to participate in Stray round of counselling.
- b) The candidate who is holding a seat allotted in Round 1 & Round 2 and Round 3 in All India Quota/Deemed universities(conducted by MCC/DGHS).
- c) The candidates who have been allotted in stray round of All India Quota/Deemed universities(conducted by MCC/DGHS) are not eligible to participate in State Stray Round of counselling.
- d) A candidate allotted a seat in Phase 3 (Mop up) of State counselling and not joined the seat cannot participate in further rounds of State Counselling.
