Notification for Free EXIT from the Phase -II reported / joined college

1. In continuation to this office earlier notice dated.21-09-2026, Reported/Joined candidates of Phase-II are permitted to exit from the reported seat on or before **05.00 PM on 30-09-2026** and shall submit their requests to the Principal concerned.
2. Such candidates **will not be eligible for further rounds of Competent Authority Quota counselling.** However, such candidates can join in MQ Phase-II of Dr.NTR UHS, Vijayawada, if seat is allotted.
3. **In view of the above, candidates are advised to take informed / calculated decision before availing “Free Exit” facility under this notice, as the candidate who avail Free Exit will not be eligible for further phase (s) of counselling under Competent Authority Quota, 2026-27.**
4. The Principals shall accept the Free EXIT requests from the candidates in the enclosed format and shall return original certificates and entire Tuition fee and other fees, if any, to the candidates immediately and freeze the latest data by **09.00 PM on 30-09-2026.** **Thereafter, no candidate will be permitted to withdraw from the joined seat under Phase-I Counselling.**
5. Candidates who have resigned from the Phase-II reported/joined seat before the said date will be considered as not reported/not joined and such vacated seats will be filled in Phase-III counselling as per rules.
6. After the said date, all Phase-II reported/joined candidates will be considered as a part of Phase-III and the Phase-III rules will apply on them as applicable for Phase-III of counselling as per the procedure notified.
7. Phase-II Reported candidates who have not opted to exit from the Phase-II reported seat are eligible for exercising Web Options for Phase-III of counselling as per their choice in the order of priority of counselling as per the procedure notified.
8. The candidates who have not reported at the Phase-II allotted college are eligible to exercise Web Options in Phase-III for all other colleges except the college which he/she has not joined.
