# NOTIFICATION CALLING FOR APPLICATIONS FROM THE ELIGIBLE CANDIDATES FOR FILLING UP OF STRAY VACANCIES AGAINST THE VACANT SEATS IN CATEGORY – A, IF ANY (DUE TO NON-REPORTING) AND UNFILLED SEATS IN CATEGORY – B & C (NRI)

Applications are invited from the eligible interested candidates who secured the cutoff score and more in NEET UG 2022 and **who have not applied earlier** to the University for Competent Authority Quota and Management Quota seats in BDS Course in the Private Un-aided Non-Minority Dental Colleges, to fill up Stray Vacancies against the vacant seats in Category – A, if any arises due to non-reporting and unfilled vacant seats in Category – B & C (NRI) under Management Quota in Private Un-aided Non-Minority Dental Colleges after mop-up rounds of counseling.

NEET Cutoff Score for Under Graduate Medical courses:

### Instructions:-

- 1. The eligible candidates who have not joined in any Medical/Dental College(s) and fulfilled the eligibility criteria as per the Dental Council of India (DCI) regulations shall submit their application through Google Forms by clicking the Link <a href="https://forms.gle/RenJz95ToxpqEtXB9">https://forms.gle/RenJz95ToxpqEtXB9</a>
- 2. Please refer the Prospectus/Regulations for MBBS/BDS courses, 2022-23 under Competent Authority Quota and Management Quota for detailed eligibility criteria notified in the University website (http://ntruhs.ap.nic.in) on 12.10.2022 and 26.10.2022 respectively including Addendums & Corrigendums.
- 3. As per the orders dated.22.07.2022 of the Hon'ble Supreme Court of India in Contempt Petition (C) No.289 of 2022 and as per the Notice 12021/01/2022-MEC, dt.12-07-2022 of DGHS, Ministry of Health & Family Welfare, Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards.
- 4. Further, the joined candidates in MBBS/BDS courses upto Mop-up rounds are not eligible to claim seat in BDS course against Stray Vacancies.

- 5. List of copies to be submitted along with the application are as follows:
  - a. NEET UG 2022 score card
  - b. SSC or equivalent or DOB certificate
  - c. Intermediate (10+2)
  - d. Community Certificate issued by Competent Authority, if applicable (To verify the eligible cutoff score)
  - e. PwD certificate issued by Competent Authority, if applicable (To verify the eligible cutoff score)
- 6. Last date of submission of applications on or before 02.00 PM on 23.12.2022.
- 7. The applications received after the scheduled date and time will not be considered.
- 8. The list of college wise vacancies under Category B & Category C (NRI) after mop-up rounds in BDS course under Management Quota is enclosed as Annexure-I.
- 9. Stray vacancies will be filled by the Principals concerned after verifying the eligibility of the candidates.
- 10. The list of applied candidates will be displayed on University website on **23.12.2022**.
- 11. The candidates shall approach the Principals of the respective colleges.
- 12. The admissions into BDS course for the academic year 2022-23 shall be closed on 28th December, 2022 as per the schedule of NMC, as such no admissions shall be made after the closure of schedule.
- 13. As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions, in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee of Rs.1,00,000/for BDS plus GST as applicable to the University by way of demand draft drawn in favour of the Registrar, Dr. YSR University of Health Sciences, payable at Vijayawada.

**Note**: The requests received directly from the candidates for withdrawal from BDS course will not be entertained under any circumstances. Any request shall be routed through Principal concerned only as per the G.O.Ms.No.72, HM & FW (C1) Dept, dated.15-07-2019.
