Notification for exercising web options for 2nd / Final Phase of web based counseling for admission into All India Quota seats in Private Un-aided Non-Minority BHMS Colleges under Dr. YSR UHS for the academic year 2022-23.

In continuation to this office notification dated 03.02.2023, Dr. YSR UHS Vijayawada hereby notifies the schedule for exercising web options for 2nd/Final Phase of Web based counselling for admission into All India Quota seats in Private Un-aided Non-Minority Homoeopathy colleges in BHMS course for the academic year 2022-23.

All seats are in open in nature and there is no requirement for any domicile certificate. The seat allocation will be done as per the directions issued by the Ministry of AYUSH, New Delhi, vide F.No.L-14030/119/2022-EP-1, dt.12.10.2022 & F.No.L-14030/852022-EP-1, dated 27.10.2022.

UNIVERSITY FEE: Candidates to whom allotment message is given have to pay Rs.8600/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).

TUITION FEE FOR BHMS COURSE: The selected candidates have to pay tuition fee of Rs.22,000/- per year for admission into AIQ seats in Private BHMS Course in Un-aided, Non-Minority Homoeopathy Colleges as per orders of Government of Andhra Pradesh G.O.Ms.No.159 HM& FW (C2) Dept., dt.23.12.2020 & G.O.Ms.No.14 HM& FW (C1) Dept., dt.09.02.2021.

Note: Ministry of AYUSH, NCISM, New Delhi has not granted permission to Sri Adi Siva Sadguru Ali Saheb Sivaaryula Ayurvedic Medical college & Research Centre, Guntakal for the academic year 2022-23. Hence, this college is not included for Private AIQ Counselling as per the orders of Hon'ble High Court of A.P. in I.A.No.1/2022 in W.P.No.41459/2022, dated 24.01.2023.

Instructions to the candidates:-

1.	<p>a. There are two rounds of counselling for All India Quota seats and after 2nd round, if AIQ seats are not filled, these seats will be converted into the state quota seats and will be filled up as per state Government rules.</p> <p>b. The Round 2 admitted candidates of AIQ Private UG Counselling can withdraw/surrender their admitted seat only on a specific date to be notified by Dr. YSR UHS, Vijayawada.</p> <p>c. After the said period, candidates will not be allowed to Withdraw/Surrender their admitted seat of Round-2. If they do so, they will be ineligible for any further AYUSH counselling conducted by Central/State/UT.</p>
2.	All AIQ UG seats of Private Un-aided, Non-Minority Colleges of BHMS course are open in nature.
3.	There is no requirement for any domicile certificate for allotment of seat in AIQ UG seats private Ayurveda & Homoeo Institutes.
4.	Eligible candidates as per Provisional Final Merit position displayed on 04.02.2023 are only eligible for exercising web options in AIQ Private Un-aided BHMS Colleges in AP.
5.	<p><u>Options:</u></p> <p>a. Fresh options will be obtained from all the eligible candidates.</p> <p>b. A candidate has to exercise options for the interested colleges in the order of priority.</p> <p>c. There is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for available colleges if the candidates are interested to join as per eligibility.</p> <p>d. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.</p> <p>e. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.</p> <p>f. Candidates are instructed to take the print out of the saved options.</p>
6.	The allotment of seats is as per NEET UG Rank-2022, merit list and order of priority of colleges. Allotment letters will be released to the candidates, if seat is allotted.
7.	Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website: http://ugayushaiq.ntruhsadmissions.com/ for status of allotment.
8.	The selected candidates can download the provisional allotment order on payment of University Registration Fee through payment gateway and report to the Principal of the allotted college on or before the date specified in the allotment order.
9.	The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.

10.	The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr. YSR UHS) during subsequent phases of counselling, the original certificates will be sent to the college concerned by the college where the candidate has slide.
11.	Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final counselling, but should download the allotted order if there is a change in Phase-II/Final counselling. Vacancies available for this Phase - II of counselling. Vacancy position is displayed on University website for the information of the students to exercise their options.
12.	The University fee and other fee once paid shall not be refunded under any circumstance.
13.	Candidates who have joined All India Quota Seats under Govt./Govt. Aided/CU/NI/Deemed Universities are not allowed to participate in counselling for admission to UG (BHMS/BAMS/BUMS) courses under State Quota/UT Quota/Institutional Quota/Central Pool Quota/AIQ (Private institute) etc., for academic year 2022-23 as notified by the AACCC dated 19.12.2022, 30.12.2022, 11.01.2023 & 19.02.2023.
