REGULATIONS FOR ADMISSION INTO BNYS COURSE UNDER COMPETENT AUTHORITY
QUOTA SEATS FOR THE ACADEMIC YEAR 2023-24.

PROSPECTUS/REGULATIONS:

The following are the Regulations for admission into BNYS Course in Naturopathy and Yogic Sciences Colleges affiliated to Dr. YSR UHS Vijayawada under Competent Authority Quota seats in Private Un-aided Non-Minority Naturopathy and Yogic Medical Colleges in the state of Andhra Pradesh for the academic year 2023-2024.

1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:

1.1 CATEGORIZATION OF SEATS IS AS FOLLOWS:

- 50% of total seats are meant for Competent Authority Quota.
- Remaining 50% of seats are meant for Management Quota.

1.2 Number of seats in BNYS Course for the academic year 2023-24 are as follows:

Note: The no. of seats in Competent Authority Quota seats in private Medical colleges is as per Govt. orders of Andhra Pradesh.

1.3 In case any new colleges are affiliated / seats are enhanced for the Academic Year 2023-24, those seats will also be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.

2. Eligibility:

The candidates should be of Indian Nationality or persons of Indian origin (P.I.O) / Overseas Citizen of India (OCI) card holders and should satisfy the local or non-local status in Andhra Pradesh (Residence requirement) as laid down in Andhra Pradesh educational institutions (Regulations of admissions) order, 1974. Selection will be done as per the procedure laid down in the G.O.P.No.646, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education (EC2) Department, dated. 18.05.2009. G.O.Ms.No.131, HM&FW(R2) Dept., dt.25.04.2008 as amended in G.O.Ms.No.8, HM&FW(F2) Dept., dt.29.01.2021.

Age: Candidates should have completed the age of 17 years as on the 31st December 2023.

Note: a. A person born on 1st January of a year will complete one year on 31st December of the same year.

b. Age shall be calculated on the basis of date of birth as indicated in the Board of Secondary School Certificate examination or equivalent examination.

c. Candidates born on or after 02-01-2007 are not eligible.

2.2 Minimum Educational Qualification:

- a. The candidate must have passed intermediate (10+2) or its equivalent examination recognized by the concerned State Government and Education Board with the subjects of Physics, Chemistry, Biology and English individually and must have obtained minimum of **50%** marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of general category and **40%** Marks in the case of the Scheduled Castes, Scheduled Tribes and Backward Classes.
- b. 10+2 passed out from recognized board under AISSCE/ CBSE/ ICSE/SSCE/ HSCE/NIOS/APOSS or other equivalent Board with Physics, Chemistry and Biology.

2.3 Students shall be medically fit.

2.4 Students shall be admitted once in a year.

2.5 **DURATION OF COURSE:** The duration of BNYS course is 5 ½ academic years including 1 (one) year Compulsory Rotatory Internship.

2.7 ELIGIBILITY CONDITIONS IN RESPECT OF CANDIDATES WHOSE DOMICILE OF ANDHRA PRADESH / TELANGANA.

2.7.1 The candidate shall satisfy Local / Non local status as per G.O.No.646 Edn. (W1) department dated 10-07-1979 and Presidential order. The procedure indicated in the above G.O for selection of candidates as amended in G.O.Ms.No.42, Higher Education (EC2) Dept., dated 18-05-2009 shall be followed.

The Non local candidates are eligible for 15% unreserved seats only. The local candidates are also eligible for 15% unreserved seats.

2.7.2 The verification fee and registration fee once paid will not be refunded or adjusted to a future date. Therefore, candidates are advised to check eligibility conditions thoroughly before applying for Competent Authority seats.

3. RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES

3.1 Admission to 85% of the seats shall be reserved in favour of the local candidates in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order, 1974 for Non-State-Wide courses as given in Annexure-III of GO (P) No. 646, Edu. (W1) Department, dt.10-7-1979.

3.2 LOCAL AREA:

3.2.1 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area for the purpose of admission to the Andhra University, ******(Nagarjuna University) and to any other education institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

3.2.2 The part of the State comprising the Districts of Adilabad, Hyderabad, Rangareddy, Karimnagar, Khammam, Mahaboobnagar, Medak, Nalgonda, Nizamabad and Warangal shall be regarded as local area for the purpose of admission to the Osmania University, ** (the Kakatiya University) and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

3.2.3 The part of the State comprising the Districts of Ananthapur, Kadapa, Kurnool, Chittoor and Nellore shall be regarded as local area for the purpose of admission to Sri Venkateswara University and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

3.3 LOCAL CANDIDATES:

3.3.1 A Candidate for admission shall be regarded as local candidate in relation to a local area.

i) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in relevant qualifying examination. (or)

ii) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.

(or)

iii) Local Status Certificate issued by MRO for claiming as AP local as per Circular Nos. 4136/SPF&MC/2015-5, dated.08.08.2016, 4136/SPF&MC/2015-13, dated. 20.11.2017 & G.O.Ms.No.129, dt: 28-10-2019 of General Administration Dept.

3.3.2 A candidate who is not regarded as a local candidate under sub-regulation (3.3.1) Above in relation to any local area shall.

i) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to:

a) Such local area where he/she has studied for the maximum period out of the said period of 7 years.

(or)

b) Where the period of his/her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods.

ii) If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to:

a) Such local area where he/she has resided for the maximum period out of the said period of 7 years.

(or)

b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

3.4 The following categories of candidates are eligible under 15% of the available seats, i.e. Un-reserved, in terms of the Presidential order:

- (i) All local candidates defined in the Presidential order,
- (ii) Candidates who have resided in the State for a total period of ten years excluding periods of study outside -the State or either of whose parents have resided in the State for a total period of ten years excluding periods of employment outside the State;
- (iii) Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporation Local Bodies, Universities and other similar quasi-Public Institution within the State; and
- (iv) Candidates who are spouses of those in the employment of the State or Central Government Public Sector Corporations, Local Bodies Universities and educational institutions recognized by the Government or a University or Other competent authority and similar other quasi-Government institutions within the State.

N.B.: The Scanned copies of relevant certificates must be uploaded for verification along with online application. In respect of residence certificate, the certificate should be obtained from the Revenue authorities clearly specifying the years.

4. RESERVATIONS:

Reservation for Scheduled Castes (S.C.) and Scheduled Tribes (S.T.):

A) Out of the seats available for admission by the University, 15% seats shall be reserved for candidates belonging to SC, 6% of seats shall be reserved for candidates belonging to Scheduled Tribes in each local area.

- i) In the event that if any seats reserved for S.T. not being filled up, they will be open to the candidates belonging to the Scheduled Castes and vice-versa.
- ii) In the event of the candidates from the SC and ST are not being available, these seats shall be allotted to the candidates under open competition.
- iii) Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Andhra Pradesh only which are specified by the Govt. of A.P from time to time shall be considered

B) RESERVATION FOR BACKWARD CLASSES:

29% of the available seats for admission in each local area by the University for shall be reserved for candidates belonging to Backward Classes as follows:

BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E*-4% (* Subject to further orders of the Government of A.P. / High Court).

If qualified candidates belonging to Back Ward Class of particular group are not available, the leftover seats can be adjusted for the candidates of next group. If qualified candidates belonging to Back Ward Classes are not available to fill up the 29% seats reserved for them, the left-over seats shall be treated as Open Competition seats and shall be filled up with candidates by merit.

C) **RESERVATION FOR WOMEN CANDIDATES:** 33 1/3% of seats are reserved for women candidates which are horizontal reservation.

5. SOCIAL STATUS CERTIFICATE:

The candidates belonging to Scheduled Castes, Scheduled Tribes and Backward Classes shall furnish a certificate in the prescribed proforma in support of their claims. The social status of Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be Scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997.

The candidates are informed that they will not be considered for the caste claimed by them unless they upload the latest **Integrated Community Certificate**, prescribed by the Government and issued by the Revenue Authorities (Vide G.O.Ms.No.58, Social Welfare (J) Department, dated. 12-05-1997) with barcode. (Annexure-II)

Note: The Social Reservation provided for BC's, SC's, ST's in the ratio of 29%, 15% and 6% respectively shall be vertical reservation.

6. RESERVATIONS UNDER THE SPECIAL CATEGORIES, PHYSICALLY CHALLENGED (PH) FOR ADMISSION INTO AYUSH COURSES:

NOTE:

- The reservation of seats under above special category is subject to the availability of seats in each category as the number of available seats in the BNYS Course are very less.
- The Reservation for Special categories mentioned above shall be provided on the basis of compartmentalized horizontal reservation for each category of OC, BC, SC and ST's.
- The guidelines of Govt. of India and Regulations of Ministry of AYUSH shall be observed in making admissions of persons with disabilities (Physically Handicapped) candidates.
- The Medical Board constituted by the Competent Authority will examine and assess the percentage of disability of differently abled candidates, who have applied seeking admission under PwD quota. The report of the Medical Board is final for considering a candidate under PwD quota as per rules.



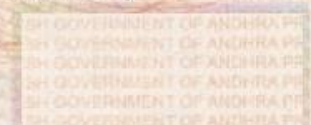

 - e. In case of Equality marks and age, the aggregate percentage of marks in all subjects of qualifying examination upto 2 decimal places shall be considered.

2. The merit order will be displayed by the Committee for Admissions after verification of all uploaded copies of relevant original certificates.
3. The selection of candidates and allotment of course / institution in respect of the seats shall be solely on the basis of merit order prepared by the admissions committee as per the prescribed marks obtained in the qualifying examination.

- 14.2 The Selection Committee shall select candidates in accordance with provisions of these regulations.
- 14.3 The Selection Committee shall have power to review its decision and can either admit or cancel the admission before the closure of admissions.

15. VACANCIES:

Vacancies if any, caused due to failure to join or cancellation of admissions or demise of the candidates etc., before the closure of admissions shall be filled by the Selection Committee in accordance with the Regulations.

16. JOINING TIME:

2. The above candidate is, therefore, a local candidate in relation to the area specified in Paragraph 3(1)(2)(3) of the Andhra Pradesh Educational Institution (Regulation of Admissions) Order 1974 as amended.

ANNEXURE-III

THE REGULATIONS FOR RE-ADMISSION AFTER BREAK OF STUDY FOR ALL THE UNDERGRADUATE AND POST GRADUATE DEGREE / DIPLOMA COURSES IN MEDICAL, DENTAL, INDIAN MEDICINE AND HOMOEOPATHY AND ALLIED HEALTH SCIENCE COURSES OFFERED BY DR. YSR UNIVERSITY OF HEALTH SCIENCES, VIJAYAWADA.

The regulation is subject to modification from time to time. In Annexure-II

DEFINITIONS:

- i. Break of study means any absence more than 3 months during the course of study.
- ii. 3 months for this purpose is a period of 90 days (ninety days) to be recorded from the date of absence irrespective of the number of days in one calendar month.
- iii. For all practical purpose only two types of break of study is allowed.
 - a. Less than 3 months of break (as per definition)
 - b. More than 3 months of break but less than the twice the number of years of study of a particular course.

Ex: For MBBS/BDS twice the number of years of study is 9 years

For B. Sc (Nursing) / Physiotherapy is 8 years.
- iv. If the candidate is on Break of study for two spells in an academic year of a particular course the candidate is deemed to have been discharged from the course of study. **One cannot apply for condonation of the break.**
- v. **Only two spells of break of study** for the entire duration of the course is permitted. During second spell of break of study, even if the break of study is less than **90** days, permission must be obtained from the university and that spell of Break shall also be counted as second spell of break.
- vi. For less than three months of break, the Principal/ Dean of the college can permit to rejoin in to the course under intimation to the university.
- vii. If the break of study is more than three months the candidate has to apply to the university through the Principal/Dean of the college. The University can give permission to the candidate to complete the course within **twice the years of the study** of the particular course.

Example 1: B. Sc Nursing student discontinues after 2 years of study and wants to join the course after 2 years of absence from study may be permitted to rejoin into the course since the candidate has 2 years of study to complete. If the candidate discontinues the course after 2 years of the study and wants to continue after 5 years of absence the candidate will not be permitted to continue the course since student will be finishing only after twice the number of years of the course (2 years

of study + 5 years of absence + remaining 2 years of the study) makes the student study for 9 years whereas according to the regulation students should not exceed twice the number of years of study in 8 years.

Example 2: MBBS. Student discontinue after 3 years of study want to join the course after 3 years of absence from study may be permitted to join into the course since the candidate have 1½year of study to complete. If the candidate discontinues the course after the 3 years of the study wants to continue after 5 years absence, the candidate will not be permitted to continue the course since, will be finishing only after twice the number of years of the course.

PROCEDURE FOR REJOINING:

- (i) The candidate having a break of study for more than three months but less than twice the years of the course shall apply for re-admission into the course in the prescribed form as in **Annexure II** by remitting the stipulated fee for condonation of Break of Study to the University Request to readmission: -

The Principal shall forward the application with specific remarks about the absence period and with an undertaking from the student that he/she is not involved in criminal cases during the absence period.

If any candidate is permitted by the Dean / Principal of the college concerned without the prior permission from this university, the re-admission to the course after **the break of study the period of such study shall not be considered as a recognized study and the candidate shall not be permitted to write the university examination based on such study Period.**

When the candidate is readmitted into the course and shall after fulfillment of the Regulations of this university to the course concerned be admitted to the examinations.

- ii) The period of break of study of the candidate for rejoining into the course shall be calculated from the date of first discontinuance of the course.
- iii) Only two spells of break of study will be allowed for the entire duration of the course.
- iv) If the name of the candidate has been registered in this University on the particular course of study but the candidate has not appeared for the university examination and subsequently if the candidate has entered on Break of Study for more than two years the candidate shall start the course afresh as Dr. YSR UHS regulations.
- v) If the candidate has not completed the course beyond twice the year of duration of course of study shall be discharged from the course immediately. This is applicable for all the years of study of Under graduate degree courses.
