In this regard, the Competent Authority has decided to consider the above said requests for exercising onetime web options as per the following schedule, in continuation to earlier notification dated.29.09.2023

**Instructions to the Candidates:**

- The eligible candidates present in the Provisional Final Merit list displayed on **09.08.2023 and in Addendum / Corrigendum** and who could not submit options in response to earlier notification dated.29.09.2023, should exercise only **ONE TIME OPTIONS FOR ALL DENTAL COLLEGES AS PER THEIR ORDER OF PRIORITY.**
- Candidates who have already submitted onetime options as per the office notification dated.29.09.2023 are not eligible to submit again. The onetime options already submitted before Phase-I as per the notification dated.29.09.2023 will be considered for all phases of counselling including mop-up counselling and for filling special category seats.
- The candidates who submitted single time options under this notification will be considered for the available vacancies after Phase-I counselling only.
- Area-wise Seat Matrix is displayed in the University Website for information to exercise the Web options.
- Candidates are advised to go through the prospectus and the Government Orders on Rules for UG admissions available before exercising web options.
- A candidate has to exercise options for all dental colleges in the order of priority.
- Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
- The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
- Candidates are instructed to take the print out of the saved options.
- No further notifications for exercising web options will be issued. All candidates have to exercise their one-time web options NOW only.
- The same options will be considered for all phases of counselling including mop-up counselling and for filling special category seats.
- The candidates are informed the rules of Phase-II of counselling will apply and cannot resign the seat.
- Other conditions of the earlier notification dated.29.09.2023 will remain same.
