In continuation to this office notification dated.13.10.2023, online application forms along with uploading scanned original certificates are invited from the eligible candidates (**who could not apply earlier and who are not holding any seat i.e. MBBS / BDS**) for admission into BDS Course **AGAINST STRAY VACANCIES, IF ANY** under MANAGEMENT QUOTA [Category B1, B2 and Category – C (NRI)] in Private Un-aided Minority Dental College and Non-Minority Dental Colleges affiliated to Dr. Y.S.R. University of Health Sciences for the academic year 2023-24. The applications of candidates who have already applied in response to this office notifications dated.19.07.2023(CQ), 03.08.2023 (MQ) & 13.10.2023 (Stray) will be considered as per eligibility and they need not apply again.

**1) ELIGIBILITY:**

Candidates who secured the Cut-Off marks and more in the NEET-UG 2023 conducted by NTA for the year 2023 and fulfilled the following eligibility criteria for admission into MBBS Course have to submit their online application by paying the non-refundable application and processing fee including verification fee through online and upload the relevant scanned original certificates/documents and images of photo / signature required for Management Quota seats.

**2) Educational Qualification:**

Candidates should have passed Intermediate (10+2) or its equivalent examination, i.e qualifying examination, securing not less than 50% of marks taken together in Physics, Chemistry, Biology (Botany, Zoology) / Bio-technology, 40% marks in case of OBC/BC/SC/ST, are eligible for admission into MBBS/BDS Courses and they have to fulfill other relevant conditions laid down in these regulations as per NMC (erstwhile MCI)/ Dental Council of India guidelines.

\*Lower percentile of marks for SC/ST/BC/PH is only for eligibility purpose and will not be applicable for reservation as there are no reservation quotas for these categories. Caste certificate issued by other state Governments will be considered for determining their eligibility for cut-off scores.

**3) MINIMUMAGE:**

Candidate should have completed 17 years of age as on 31-12-2023. Candidate who does not complete 17 years as on 31-12-2023 are not eligible and need not apply.

**5) INSTRUCTIONS TO THECANDIDATES:**

1. Who are eligible for stray vacancy round?
  - a. Eligible candidates who could not apply earlier and who are not holding any seat of either MBBS / BDS course.
  - b. Candidates who have already applied for Competent Authority Quota / Management Quota Seats in response to this University earlier notification dated.19.07.2023 & 03.08.2023 respectively are also eligible for stray vacancy counselling under Dr. YSR UHS subject to condition that the candidate should not hold any seat (MBBS or BDS) under Dr. YSR UHS both CQ and MQ / All India Quota / KNR University of Health Sciences, Telangana.
  - c. A list of eligible candidates for stray vacancy is placed in the University website. Such candidates need not apply again.
2. Who are NOT eligible for stray vacancy round?
  - a. Candidate joined / holding any seat (MBBS / BDS) under Dr. YSR UHS / All India Quota / KNR University of Health Sciences, Telangana / Other States are not eligible for stray vacancy round. Such candidates shall not apply for this notification.
  - b. If it is found that an ineligible candidate has applied, candidature of such candidates will not be considered for allotments. Application fee paid if any, will not be refunded.
3. The same application will be considered for all the rounds of stray vacancy counseling, if any, and subject to availability of vacancies.
4. In respect of Category-B2 seats, preference will be given to local candidates of Andhra Pradesh and if eligible candidates from Andhra Pradesh are not available, the same will be allotted to Category-B1 candidates based on Merit, Options and subject to availability of seats.

5. For complete details visit University website: <https://drysr.uhsap.in> and the candidates are advised to download Prospectus / Regulations and take a printout. Read these carefully to ensure your eligibility before applying.
6. Candidates **possessing qualification of the University / Board of an institution outside the** Andhra Pradesh State should submit Equivalence certificate issued by the Board of Intermediate Education of Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the College.
7. Candidates **possessing qualification of the University / Board of an institution outside INDIA** should submit Eligibility / Equivalence certificate issued by Association of Indian Universities, New Delhi and also Equivalence certificate issued by the Board of Intermediate Education, Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the college.
8. Application and Processing fee including verification fee: Rs.10,620/- (Rs.9000/-+Rs.1620/- (GST)) plus Bank charges extra can be paid through Debit card / Credit card / Net Banking /UPI.
9. **Mere applying under this notification does not confer any right to claim seat and the candidature is subject to availability of seats. Hence, the candidates are advised to take calculated decision before applying under this notification.**
10. The online application can be filled through any computer with internet connection or mobile with data connection. **(NOTE: preferably desktop or laptop)**
11. The Application and Processing fee including verification fee once paid will not be refunded or adjusted to a further date. The fee is non-refundable. Hence, candidates are advised to check their eligibility before applying.
12. The Provisional merit position will be displayed on the University website after verification of uploaded scanned original certificates.
13. Detailed notification regarding eligibility for exercising web options will be issued separately. Therefore, the candidates are advised to visit University website <https://drysr.uhsap.in> regularly for further notifications.
14. The Candidates are hereby informed that if they have secured admission in medical colleges of other States, joined the course and if they are involved in blocking the seats under management quota in Dr. YSR UHS, the university will initiate legal action and same will be inform to the National Medical Commission / Dental Council of India for further course of action.
15. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2023 Rank.
16. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
17. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
18. Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counsellings. No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
19. Scrutiny of uploaded Original Certificates shall be done by the University and concerned **departmental officials**. After scrutiny of application and certificates the merit list will be released. Candidates are advised to watch the university website regularly for further Notifications/ Instructions.
20. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
21. The candidate should compulsorily join in the allotted seat / college, if seat is allotted under this stray vacancy round and cannot resign the seat.

22. a) As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee Rs.3,00,000/- plus GST as applicable to the University by way of demand draft.

b) Request for withdrawal from the course / cancellation of admission, if any received from the candidate directly to the University, the same will not be entertained under any circumstances and no further correspondence will be entertained.
