In continuation to this Office Notifications, dt.21-07-2023, 19-08-2023, 30-08-2023, 31-08-2023, 01-09-2023, 12-09-2023, 20-09-2023 & 06-10-2023 Dr.YSR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-II counselling for **Non-Service candidates** for admissions into Competent Authority Quota (CQ) PG Medical Degree/Diploma courses available in the Government and Private Non-Minority and Minority Medical Colleges under Dr.YSR UHS and SVIMS, Tirupati for the academic year 2023-2024.

All the eligible Non-service candidates whose names are in the provisional final Merit Position/Corrigendum/Addendum notified in the University Website on 07-10-2023 & 09-10-2023 are only eligible to exercise web options as per the above dates and according to the Seat Matrix displayed in the website <http://drysr.uhsap.in>

**NOTE:** Allotment of seats to certain Petitioners in W.P.Nos.20112 of 2023 and W.P.No.20836 of 2023 are subject to the final orders of the Hon'ble High Court of Andhra Pradesh.

**UNIVERSITY FEE:**

- Candidates to whom seat is allotted have to pay Rs.23,600/- for downloading allotment letter. The payment is to be paid through payment Gateway <https://pgcq.ylsruhs.com/> by using Online payment method. (Debit Card/Credit Card/Internet Banking).**
- Candidates who have already paid the University fee of Rs.23,600/- in Revised Phase-I counselling are not required to pay the same.**

1	<p>The following candidates are not eligible for this Phase-II</p> <ol style="list-style-type: none"> <li>1. Candidates joined and continuing in Round-1 and Round-2 of All India Quota (AIQ)</li> <li>2. Allotted Candidates of Round-3 of All India Quota (AIQ)</li> <li>3. Candidates joined and continuing in the colleges of Telangana State</li> </ol> <p>Hence, the above said candidates should not exercise web options.</p>
2	<p>Eligibility for Exercising web options in this Phase-II Counselling</p> <p>The following candidates are eligible:</p> <ol style="list-style-type: none"> <li>a) Candidates who have joined/have been not allotted any seat in Revised Phase-I counselling.</li> <li>b) Those candidates who have been allotted a seat in Revised Phase-I but not reported/not joined from allotted seat at the allotted colleges. However, if a candidate has not joined/reported in the allotted seat of Revised Phase-I then that particular seat shall not be available for that candidate to exercise web options in this Phase-II counselling.</li> <li>c) Candidates who did not avail the Withdraw/Resign option in response this Office Notifications, dt.28-09-2023 &amp; 06-10-2023 and continuing in the Revised Phase-I allotted seat.</li> </ol>
3	<ol style="list-style-type: none"> <li>a) List of Not reported Non-service candidates is displayed in the University website, dt.09-10-2023.</li> <li>b) The list of Unfilled/vacant In-service seats are placed in the University website on 10-10-2023.</li> <li>c) As per G.O.Ms.No.88, HM&amp;FW (E1) Dept., dt.21-05-2014 of Govt. of Andhra Pradesh</li> </ol> <p>“After completion of the final Counseling for service seats, the unfilled service seats shall be identified for its original category in the seat matrix of the service seats and shall be added to the non-service seats before commencement of the second counseling for non-service seats”.</p>
4	<p>Candidates are advised to go through the Prospectus (placed in the University website on 21-07-2023) and the Government Orders on Rules of PG (Medical) admissions available before exercising web options. Candidates are also advised to go through the details about “MRC” concept which is exemplified below:</p> <p>Example:</p> <ol style="list-style-type: none"> <li>a) In a particular college MD(RD) seat is under “Open Category” in the seat matrix and a SC candidate is allotted that Open Category MD(RD) seat in Open Round Counselling of Phase-I as per his/her web options and NEET Rank merit order of the candidate. Now this candidate is shown as <b>Meritorious Reserved Candidate (MRC)</b>.</li> <li>b) The same SC candidate has slid to MD (General Medicine) SC category seat in the same college or another college during the Category Round of Phase-I Counselling <b>conducted on the same day</b>, then that MD(RD) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.</li> <li>c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation</li> <li>d) G.Os governing MRC and other regulations: <ol style="list-style-type: none"> <li>1. 5	<ol style="list-style-type: none"> <li>1. Candidates opting for PG(Medical) Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is interested to join as per eligibility.</li> <li>2. Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in the Revised Phase-I counseling to other seats as per their web options in this Phase-II counseling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.</li> <li>3. If a PG seat is allotted in this Phase-II counseling as per web options exercised by the candidate, the seat allotted in Revised Phase-I counseling will be automatically cancelled and allotted to the other candidate. Therefore the candidates are informed to exercise web options carefully.</li> </ol>

6	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. If they are not interested to join any subject or college then they should not exercise options for the same.
7	<p>Candidate can exercise web options from any place having internet facility One Time Password will be sent to the registered mobile number at the time of saving Web options.</p> <p>I) Selected Options can be slided either up or down, added and deleted.  II) Web options opted must be saved by the candidate.  III) Web options once submitted can not be Edited.  IV) Web options saved but not submitted until the cut off date and time will be Auto submitted.</p>
8	<p>1. The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.</p> <p>2. Candidates who were allotted a seat in Revised Phase-I counselling in any college of AP State, joined and slided to another college in AP in this Phase-II Phase counseling, should submit the tuition fee receipt, Custodian/acknowledgement of Original certificates issued by the earlier college for admission at the newly allotted college. The first college where the candidate initially joined in Revised Phase-I will transfer the tuition fee, Original certificates etc., to allotted college in this Phase-II.</p>
9	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.
10	<p>As per G.O.Ms.No.67, dt.21-04-2017 in the final phase of final counselling:</p> <p>A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,54,000/- (including 18% GST).</p>
11	The University fee and other fee once paid shall not be refunded under any circumstances.
