**PG (MEDICAL) STRAY VACANCY ROUND UNDER COMPETENT
AUTHORITY QUOTA SEATS – 2023-24**

Notification for exercising web options for admissions into Post Graduate Medical Degree/Diploma Courses against Stray Vacancy Round to be conducted by Dr. YSR UHS for the academic year 2023-2024 in the State of A.P. under Competent Authority Quota Post Graduate Medical Degree / Diploma courses, in Government and Private Un-aided Non-minority & Minority Medical Colleges affiliated to Dr. YSR UHS including SVIMS TIRUPATI (subject to availability of seats at the end of Mop Up round).

INSTRUCTIONS

1. Eligible Non-Service candidates whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates.
2. All the unfilled seats for Stray vacancies are converted as “**Unreserved Open General seats**”.
3. The following candidates are not eligible to exercise options under this Notification:
 - a) Candidates who have been allotted any PG (Medical) seat in any Phase including Mop Up rounds of CQ and MQ counsellings of Dr.YSR UHS, Vijayawada are not eligible to participate in Stray vacancy round.
 - b) Candidates who have not exercised/participated for web options in any Phase of CQ seats of Dr.YSR UHS are not eligible for stray vacancy round.
 - c) Candidate joined / holding any PG (Medical) seat under Dr. YSR UHS / All India Quota / KNR UHS, Telangana / Other States are not eligible for stray vacancy round.
 - d) Allotted Candidates of Round-3 of AIQ/Stray round of AIQ/Stray round of KNR UHS, TS are not eligible for stray vacancy round.
4. **IMPORTANT NOTE**: Candidates if allotted any seat in this Round should compulsorily join the course failing which candidates shall be debarred for one academic year i.e., 2024-25 for admissions into Medical Colleges in the State of Andhra Pradesh. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.
5. Not reported seats at the end of Mop Up counselling will be displayed in the University website. Hence, the candidates are therefore advised to exercise options for all the seats in all the colleges irrespective of the vacancies as per their priority if they are really interested to join the Seat.

6. Candidate can download the provisional allotment order on payment of University fee of Rs.23,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
7. The allotted candidates shall report at the allotted college immediately in view of NMC, New Delhi schedule. Hence, candidates are advised to keep in touch with University website for information on Stray allotments.
8. The University fee once paid shall not be refunded under any circumstances.
9. As per G.O.Ms.No.251, HM&FW (C1) Dept., dt.02-10-2022 each Non-service candidate admitted into PG (Medical) course in State Quota/Competent Authority Quota seats in Government Medical Colleges/Private Medical Colleges shall execute a bond to serve the Government of Andhra Pradesh compulsorily in APVVP/DME, A.P Hospitals for a period of one year after completion of PG(Medical) Degree course. If they violate the bond condition either by not joining or by not completing the stipulated service period of one year within a maximum period of 18 months after completion of the PG (Medical) Degree course, a penalty of Rs.40,00,000/- (Rupees forty lakhs only) on PG (Medical) Degree candidates shall be levied. The Principals shall obtain a bond in the prescribed proforma.
10. **TUITION FEE FOR PG MEDICAL:** The following is the **Tuition fee structure** for the academic year 2023-24 to be payable for the Competent Authority Quota seats in Private Un-aided Medical Colleges as per G.O.Ms.No.123, HM & FW (C1) Department, dated 10-08-2023 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.
