Notification for exercising web options for Mop-Up Round of web-based counseling for admission into BHMS/BAMS/ BUMS Courses under Competent Authority Quota Seats for the academic year 2023-24.

In continuation of earlier notification dated 16.10.2023, 10.11.2023 and **28.11.2023** the University hereby notifies the Mop-Up Round of web-based counselling for UG AYUSH (BHMS/BAMS/ BUMS) seats available under Competent Authority Quota in Government, Private Un-aided Non-Minority, Aided AYUSH Medical colleges (under Dr. YSR UHS) for the academic year 2023-24 in the state of Andhra Pradesh for the vacancies available if any after Phase – II counselling.

All the eligible candidates who are present in the Merit list notified in the website on **25.11.2023** are only eligible to exercise their options as per the seat matrix displayed on the **website: <https://drysr.uhsap.in>**

The seat allocation will be done as per the Procedure given in G.O.P.No.646, Education (w) dept. Dt.10-07-1979 as amended in G.O.Ms.No.42, Higher Education dept., Dt.18-05-2009 and as per the G.O. Ms No.131 HM&FW (R2) Dept., dt:25.04.2008 as amended in G.O.Ms.No.8, HM & FW(F2) Dept., dt.29.01.2021.

UNIVERSITY FEE: Candidates who are allotted with a seat, have to pay Rs. 8,600/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).

TUITION FEE: 1. Govt. Colleges: Fee as fixed by the Govt. of Andhra Pradesh.

2. Private Colleges: The selected candidates have to pay tuition fee of Rs.24,500/- per year for admission into UG AYUSH Courses as per orders of Government of Andhra Pradesh G.O.Ms.No.141 HM & FW(C2) Dept., dt.31.08.2023 & G.O.Ms.No.193 HM & FW(F2) Dept., dt.31.10.2023.

Instructions to the Candidates:

1. Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2023-24 notified by AACCC, New Delhi, Vide Ref. No. 11013/1/2023-EP-I, dt.21.11.2023 are not eligible to participate under this notification.
2. If it is found that the ineligible candidate participated in this counselling, candidature of such candidate will be cancelled and will be informed to the NCISM/NCH, Ministry of AYUSH, New Delhi.

3. The candidates who were allotted seat in 1st & 2nd Phase counselling are not eligible to participate in this Mop-Up Round counselling.
4. Fresh options will be obtained from all the eligible candidates. Same options will be considered for another Mop-Up Round if any.
5. The candidates who get allotment in this Mop-Up Round counselling should compulsorily join in the allotted college.
6. Candidate can give options on the web either from home or any other place having internet facility. One Time Password will be sent to the registered mobile at the time of registration and also at the time of saving Web options. The password consists of SIX letter code with English capitals A to Z.
7. A candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
8. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
9. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the **website:** <https://drysr.uhsap.in> for status of allotment.
10. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
11. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
12. **FOR BUMS** : As per F.No.11-76/2021-BUMS(Unani-UG Regl.) dated.28-02-2022 the following is the regulation on Eligibility for admission into BUMS course which is applicable from the academic year 2021-22:
 - a. The candidate shall have passed 10+2 or its equivalent examination from any recognised Board with physics, Chemistry and Biology and shall have obtained a minimum of 50%. Marks taken together in Physics, chemistry and Biology in the case of general category and 40% marks in the case of Scheduled Castes, Scheduled Tribes and other Backward classes: -

Provided that in respect of persons with disability candidate specified under the rights of persons with disabilities act, 2016 (49 of 2016) the minimum qualifying marks in the said examinations shall be 45% in the case general category and 40% in the case of Scheduled Casts, Scheduled Tribes and other Backward Classes.
 - b. Candidate shall have passed Urdu or Arabic or Persian language as on the subject in the 10th standard or in 12th standard.
 - c. Candidate who is not covered under clause(b) shall have to study Urdu language along with Arabic and Mantiq Wa Falsafa(Logic and Philosophy) as a subject during the First professional B.U.M.S. session.
 - d. The syllabus is applicable to the students admitted in the academic year session 2021-22 on wards 5 years or until further notification by NCISM, whichever is earlier (Ref.11-76/2020-Unani (U.G Syllabus) dt.29-03-2021.
14. **The University fee once paid shall not be refunded under any circumstances.**
