# **ORDER:**

In the G.O.4<sup>th</sup> read above, Government have framed Rules called "the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017".

- 2. In the reference 5<sup>th</sup> read above, the Registrar, Dr. YSR University of Health Sciences has furnished proposal for issuing amendments to the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 issued in the G.O. 1<sup>st</sup> read above.
- 3. The Government after careful examination of the proposals of the Registrar, Dr.YSR University of Health Sciences hereby makes the following amendments to the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 issued in G.O.  $4^{th}$  read above.
- 4. Accordingly, the following notification will be published in an Extraordinary issue of the Andhra Pradesh Gazette, Dated:28.04.2023 :

#### **NOTIFICATION**

In exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No.5 of 1983), the Government hereby make the following amendments to the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 issued in G.O.Ms.No.70, HM&FW (C1) Dept., Dt.03.05.2017 as subsequently amended.

#### **AMENDMENTS**

In the said rules, in Rule 2;

I. Under sub-heading "Seat Sharing and Admissions", for clause-(vii), the following shall be substituted, namely,-

"The 50% of the sanctioned Intake of the Management Quota seats shall be filled by the "Committee for Admissions" constituted by Dr.YSR University of Health and Sciences, Vijayawada with the eligible candidates on the basis of inter se merit among the applicants qualified in NEET-PG/NEET-MDS.

(a) Management Quota- Subcategory 1:-- 25% of the sanctioned intake of seats, course wise, in each of member institutions shall be filled by the candidates in General Merit based on the NEET ranking.

- (b) Management Quota- Subcategory 2:-- 15% seats out of total intake capacity, course wise, in each member institution shall be filled by foreign students/NRI/NRI sponsored candidates on the basis of inter se merit among the applicants qualified in NEET.
- (c) Management Quota- Subcategory 3:-- 10% seats out of total intake capacity, course wise, in each member institution shall be Institutional preference/In-service management quota seats filled on the basis of inter se merit among the applicants qualified in NEET.
- (d) Provided in case of fraction of 0.5 between Management Quota Subcategory-1 (S1) and Management Quota Subcategory-2 (S2), the fraction is to be rounded up to the figure 1 and shall be rotated between Subcategory-1 and Subcategory-2 seats in the alternate years starting from the academic year 2023-24 i.e., for the academic year 2023-24, if the seat is due to fraction of 0.5 shall be meant for Management Quota Subcategory-1 and in the next academic year 2024-25 the same seat due to fraction of 0.5 shall be meant for Management Quota Subcategory-2 by rotation and so on.
- (e) As per the discretion of the Competent Authority, possible number of Mop Up rounds of counselling are to be conducted by Dr.YSR University of Health Sciences for PG (Medical)/ PG (Dental) Management Quota Subcategory-1/Sub-category-2/ Sub-category-3 seats before the last date of admissions as per the NMC, New Delhi schedule.
- (f) No candidate shall be permitted to cancel/withdraw/resign from the PG (Medical) /PG (Dental) seat during Mop Up round counselling until closure of admissions. Students allotted seats in Mop Up Round counselling shall compulsorily join the college."
- II. Under sub-heading "Procedure for Grant of Admissions into PG [Medical, Dental] Courses under the Management Quota seats", for the paras 1 to 20 the following shall be substituted, namely,-
  - "1.The Competent Authority shall constitute a Committee consisting of three members i.e., one from the Government of Andhra Pradesh, one from Dr.YSR University of Health Sciences, Vijayawada and the other from APPMDCMA for the purpose of Counselling/Admission into Un-aided Non-Minority Medical and Dental Colleges. The entire procedure shall be done under the overall supervision of Dr.YSR University of Health Sciences, Vijayawada.
  - 2. The Convener, Admission / Counseling Committee shall issue notification in two National Newspapers, calling for application from NEET-PG/NEET-MDS qualified candidates for admission to management quota (Sub-Category 1) and Management quota (Subcategory 2 and 3) in PG Medical / Dental courses separately. The admission process and number of seats under management quota shall be displayed in the Association Website.
  - 3. He shall invite Online or Offline Applications in the form prescribed by it, from the NEET-PG NEET-MDS eligible candidates for participating in Centralized Admission Process (CAP) for seeking admission to the Courses to management quota (Sub-Category 1) and (Sub-Category 2 & 3) separately.
  - 4. He shall prepare a merit list from the eligible candidates who have applied to the Management Quota seats, online or offline, in the prescribed form for admission to Post Graduate Medical Courses and Post Graduate Dental Courses on the basis of the marks at percentile in the NEET-PG examination or NEET-MDS examination.
  - 5.The Convenor, Admission / Counselling Committee shall notify the Schedule of web counselling with date and time for each category of Management Quota Seats in the University website with entire due procedure.
  - 6. The Selected candidate will be issued Provisional Selection Intimation with a direction to report to the concerned Principal within the date specified.

- 7. If a candidate opts a seat and fails to pay the fee at respective institution, the seat will be treated as vacant and will be filled in the 2<sup>nd</sup> Counselling.
- 8. If a selected candidate fails to report to the Principal within the stipulated time, the Selection and Admission of the candidate will be cancelled automatically and the seat will be filled in the 2<sup>nd</sup> Counselling.
- 9. The allotted candidates shall report at the respective allotted colleges along with all necessary original certificates.
- 10. The Convenor, Admission / Counselling Committee shall notify the schedule of web options with date and time for 2<sup>nd</sup> and Mop Up rounds counselling in the University website.
- 11. The College Fee shall be paid in the form of crossed demand draft in the respective colleges.
- 12. The Candidates shall pay prescribed Non Refundable Application Fee, counseling fee and University Fee.
- 13. The Candidates are bound by the Regulations to be made by the Association with regard to Admission, Cancellation and Withdrawal from the Course.
- 14. The APMDCMA shall constitute a Grievance Redressal Committee composed of a Dean / Principal of a Medical / Dental College, one eminent person in public service and one member nominated by the university. Any grievance as to the determination of their merit and entitlement for admissions, cancellation of seats, refund of fees, return of documents, etc the students or the colleges concerned must approach the Grievance Redressal Committee headed by aPrincipal/Dean/Director of a Medical/Dental college and the decision of Grievance Redressal Committee shall be binding on both Parties.
- 15. All institutions shall display their fee structure in the college notice board and College Website.
- 16. The college shall pay stipend to the PG (Medical and Dental) students as per the NMC / DCI / Andhra Pradesh State regulations.
- 17. All the candidates admitted into management quota seats in unaided private medical/dental college, on completion of their postgraduate course shall work for one year as 'Senior Resident' in the institution where they pursued postgraduate course."

### **ORDER:**

In pursuance of the judgment of Hon'ble Supreme Court of India dt.12.08.2005 in Appeal (Civil) No.5041 of 2005 filed by P.A. Inamdar Vs. State of Maharashtra (AIR 2005 SC 3226), the Government of Andhra Pradesh hereby decided to make Rule for admission into Post Graduate Professional Courses in Medical and Dental Courses in Un-aided Minority Professional Institutions in the State of Andhra Pradesh.

2. The following notification shall be published in the extraordinary issue of the Andhra Pradesh Gazette, Dated.06.06.2023.

#### **NOTIFICATION**

In exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No.5 of 1983), the Government hereby make the following Rules for admission into Post Graduate Professional Courses in Medical and Dental Courses in Un-aided Minority Professional Institutions in the State of Andhra Pradesh (Admissions into Post Graduate Medical/Dental Courses) Rules, 2023:

#### 1. Short title, applicability and commencement:

- (i) These rules may be called the Andhra Pradesh Un-aided Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2023.
- (ii) They shall apply to all Un-aided Minority Professional Institutions imparting Post Graduate Professional Education in Medical and Dental courses for which admissions shall be made to the "Competent Authority Seats" and "Management seats" in such manner as prescribed herein.
- (iii) These Rules shall come into force from the academic year 2023-24.

#### 2. Definitions:

- 1. In these rules, unless the context otherwise requires;
  - i. "Act" means the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No. 5 of 1983)
  - ii. "Competent Authority" means the Vice Chancellor, Dr. YSR University of Health Sciences, Andhra Pradesh, Vijayawada.

(P.T.O)

- iii. "Committee for Admissions" means the Committee nominated by the Competent Authority to select and make allotment of candidates to Competent Authority Seats in Professional Institutions offering P.G. Medical and Dental Courses in the State for Admissions in accordance with the rules laid down.
- iv. "Common Entrance Test" means, National Eligibility Cum Entrance Test (NEET-PG/NEET-MDS) which will be the basis for admission of the candidates into the Post Graduate Courses concerned in various Un-aided Minority Professional Institutions in the State.
- v. "Competent Authority Seats" means the seats earmarked from out of the sanctioned intake of seats in each course and in each college to be filled by the "Committee for Admissions"
- vi. "Management Seats" means the seats earmarked from out of the sanctioned intake of seats in each course to be filled in such manner as may be prescribed by the Government or by the Committee of Admissions constituted.
- vii. "Institutions" means, unless otherwise specifically mentioned, all the Unaided Minority Professional Institutions imparting Professional Education in Medical and Dental courses.
- viii. "Qualified Candidate" in respect of seats to be filled by the 'Competent Authority' means the candidate who has appeared for the NEET-PG/NEET-MDS for Post Graduate course admission and has been assigned ranking in the Common merit list.
- ix. "Qualifying Examination" means the examination of the minimum qualification prescribed which entitles one to seek admission into the relevant Professional Post Graduate Course.

Words and expressions used but not defined in these rules shall have the same meaning as assigned to them in the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No. 5 of 1983) unless otherwise defined by the Government in Health Medical and Family Welfare Department or by the Competent Authority.

#### Seat Sharing and Admissions:

#### i) Competent Authority Quota seats (CQ):

The 50% of the sanctioned intake of the seats shall be filled by "Committee for Admissions" constituted by Dr.YSR University of Health Sciences based on merit as per ranking to be determined/assigned by the competent authority based on National Eligibility-cum-Entrance Test (NEET-PG/NEET-MDS), as the case may be, and as per Rules framed for the purpose in accordance with the NMC, New Delhi/Dr.YSR UHS, Vijayawada.

- ii) The seat matrix regarding the Competent Authority and Management quota(MQ) seats in each specialty in each Medical /Dental College shall be prepared by the University every year before counseling and any additional seats permitted by the NMC/DCI and the University will be included in the counseling process.
- iii) If there is only one seat available in a specialty in a college, the seat will go to Management quota for the starting year and alternated to the Competent Authority Quota for the next year and rotated so on.

- iv) Similarly, if there are 3 seats in a speciality in a college, one seat for Competent Authority quota and one seat for Management quota will be allotted and the 3rd seat will go to Management Quota for the starting year and alternated to the Competent Authority Quota for the next year and rotated so on.
- v) If in a specialty one seat in Degree and one seat in Diploma are available in a college, the Degree seat will be for Management Quota and Diploma seat will be for Competent Authority quota for the starting year and alternated to the Competent Authority Quota and Management Quota respectively for the next year and rotated so on.
- vi) The unfilled seats after final phase of counseling for Competent Authority Seats shall be surrendered to Management of respective colleges.
- (vii) The 50% of the sanctioned intake of the Management Quota seats shall be filled by the "Committee for Admissions" constituted by Dr.YSR UHS, Vijayawada with the eligible candidates on the basis of inter-se-merit among the applicants qualified in NEET-PG/NEET-MDS.
- a. Management Quota-Subcategory-1(S1): 25% of the sanctioned intake of seats, course wise, in each institution shall be filled by the candidates in General Merit based on the NEET ranking.
- b. Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET.
- c. Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each institution shall be Institutional preference/Inservice management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET.
- d. In case of fraction of 0.5 between Management Quota Subcategory-1(S1) and Management Quota Subcategory-2(S2), the fraction is to be rounded upto the figure 1 and shall be rotated between Subcategory-1 and Subcategory-2 seats in the alternate years starting from the academic year 2023-24 i.e., for the academic year 2023-24, if the seat is due to fraction of 0.5 shall be meant for Subcategory-1 and in the next academic year 2024-25 the same seat due to fraction of 0.5 shall be meant for Subcategory-2 by rotation and so on.
- e. As per the discretion of the Competent Authority, possible number of Mop Up rounds of counselings are to be conducted by Dr.YSR University of Health Sciences for PG (Medical)/PG(Dental) Management Quota Subcategory-1/Subcategory-2 / Subcategory-3 seats before the last date of admissions as per the NMC/DCI schedule.
- f. No candidate shall be permitted to cancel/withdraw/resign from the PG (Medical/Dental) seat during Mop Up round counseling until the closure of admissions as notified by NMC/DCI. Students allotted seats in Mop Up round counseling shall compulsorily join the college.
- g. A candidate who has joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat after the closure of admissions, the candidate shall be debarred for a period of three years for admissions into Post Graduate Medical Degree/ Diploma courses at the colleges in the State of Andhra Pradesh besides the payment of Rs.3,00,000/- and GST as applicable.

viii) On non-availability of Minority candidates in any of the categories in vii (a), (b) or (c), they can be filled with any other eligible candidates as prescribed by the NMC/DCI and the fee shall be on par with the category of students admitted under vii(c). In case of Minority candidates are not available then the seats can be filled with Non-minority candidates and the Non-minority candidates should not exceed 30% of the total seats.

# <u>Procedure for Grant of Admissions into PG [Medical, Dental] Courses under the Management Quota Seats:</u>

- 1. The Competent Authority shall constitute a "Committee for Admissions" for the purpose of Counselling/Admission into Un-aided Minority Medical and Dental Colleges. The entire procedure shall be done under the overall supervision of Dr.YSR YSR University of Health Sciences, Vijayawada.
- 2. The Convener, Admission/Counseling Committee shall issue notification in two National Newspapers, calling for applications from NEET-PG/NEET-MDS qualified candidates for admission to management quota (Sub-Category 1) and Management quota (Subcategory 2 and 3) in PG Medical/Dental courses separately. The admission process and number of seats under management quota shall be displayed in the University Website.
- 3. Online or Offline Applications are invited in the prescribed form from the NEET-PG or NEET-MDS eligible candidates for participating in Centralized Admission Process(CAP) for seeking admission to the Courses to Management quota (Subcategory-1,) and (Subcategory-2 and 3) seats. The candidates shall pay Non-Refundable Application fee, Counseling fee and University fee.
- 4. Merit list from the eligible candidates who have applied to the Management Quota seats shall be prepared and shall be placed in the University website, for admission to Post Graduate Medical Courses and Post Graduate Dental Courses on the basis of the marks at percentile in the NEET-PG examination or NEET-MDS examination.
- 5. The Convener, Admission /Counselling Committee shall notify the Schedule of web counseling with date and time for each category of Management Quota Seats in the University website.
- 6. The Selected candidate will be issued Provisional Selection intimation with a direction to report to the concerned Principal within the date specified.
- The allotted candidates shall report at the respective allotted colleges and the college fee shall be paid in the form of crossed demand draft in the respective colleges.
- 8. If a candidate opts a seat and fails to pay the fee at respective institution, the seat will be treated as vacant and will be filled in the 2nd Counseling.
- 9. If a selected candidate fails to report to the Principal within the stipulated time, the Selection and Admission of the candidate will be cancelled automatically and the seat will be filled in the 2nd Counseling.
- 10. The Convener, Admission/Counseling Committee shall notify the schedule of web options with date and time for 2nd and Mop Up rounds counselings in the University website.
- 11. All institutions shall display their fee structure in the college notice board and College Website.
- 12. The college shall pay stipend to the PG(Medical/Dental) students as per the NMC/DCI/Government of Andhra Pradesh regulations.

13. All the candidates admitted into Management Quota seats in un-aided Minority private Medical/Dental college, on completion of their postgraduate course shall work for one year as 'Senior Resident' in the institution where they pursued postgraduate course as per the Government Orders.

In the reference 3<sup>rd</sup> read above, the Registrar, Dr. YSR University of Health Sciences has furnished proposal that the President, Medicos Parents Association, Andhra Pradesh has submitted a representation to Government of Andhra Pradesh requesting to reserve 85% of the Post Graduate (Medical) seats in Private Medical Colleges to Local Candidates of Andhra Pradesh only. Accordingly, the Registrar, Dr.YSRUHS who examined the request, has furnished a proposal to provide 85% of the 25% of sanctioned intake of P.G seats (Subcategory 1) under Management quota to be reserved for local candidates of Andhra Pradesh State and remaining 15% seats to be opened to the candidates from all over the country by amending the G.O.1<sup>st</sup> read above.
- 3. The Government after careful examination of the proposal of the Registrar, Dr.YSR University of Health Sciences, hereby makes the following amendment to the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulations of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 issued in G.O. 1<sup>st</sup> read above and amended subsequently.
- 4. Accordingly the following notification shall be published in the next issue of the Andhra Pradesh Gazette:
