- 1) **Competent Authority (SELF-FINANCING) seats and Competent Authority (NRI Category) seats in new Government Medical Colleges permitted from the academic Year 2023-24 onwards;**
- 2) **MANAGEMENT QUOTA [Category-B1, B2 and Category-C(NRI)] seats in Private Un-aided Non-Minority and Minority Medical Colleges and Dental Colleges affiliated to Dr. YSRUHS; and**
- 3) **NRI Category seats in Sri Padmavathi Medical College for Women (Under SVIMS), Tirupati.**

Online Application forms along with uploading scanned original certificates are invited from the eligible candidates for **admission into MBBS and BDS Courses under Competent Authority (SELF-FINANCING) seats and Competent Authority (NRI Category) seats in new Government Medical Colleges permitted from the academic Year 2023-24 onwards; MANAGEMENT QUOTA [Category -B1, B2, & C(NRI)] in Private Un-aided Non-Minority/ Minority Medical and Private Unaided Non-Minority Dental Colleges affiliated to Dr. Y.S.R. University of Health Sciences and also for NRI seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati for the academic year 2023-24.**

1) ELIGIBILITY:

Candidates who secured the Cut-Off marks and more in the NEET-UG 2023 conducted by NTA for the year 2023 and fulfilled the following eligibility criteria for admission into MBBS and BDS Courses have to submit their online application by paying the non-refundable application and processing fee including verification fee through online and upload the relevant scanned original certificates/documents and images of photo / signature required for Management Quota seats.

Cut-off Scores in NEET-UG – 2023:

Category	Qualifying Criteria	Cut off score (out of 720)	Remarks
General category (OC / EWS)	50th Percentile	137	Candidates scoring equal to or more than this cut-off score have been declared as qualified.
SC / ST / BC & Persons with Benchmark Disability of SC / BC Categories (PwBD-SC / PwBD-BC)	40th Percentile	107	SC / ST / BC / SC-PwBD / BC-PwBD candidates scoring equal to or more than this cut-off score have been declared as qualified.
Persons with Benchmark Disability of ST Category (PwBD-ST)	40th Percentile	108	PwBD-ST candidates scoring equal to or more than this cut-off score have been declared as qualified.
Persons with Disability-General Category (OC/EWS)	45th Percentile	121	OC-PwBD candidates scoring equal to or more than this cut-off score have been declared as qualified.

NOTE: *LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC / ST / BC / OBC /PwBD IS ONLY FOR CUT-OFF SCORE TO DETERMINE ELIGIBILITY.

2) Educational Qualification:

Candidates should have passed Intermediate (10+2) or its equivalent examination, i.e. qualifying examination, securing not less than 50% of marks taken together in Physics, Chemistry, Biology (Botany, Zoology) / Bio-technology, 40% marks in case of OBC/BC/SC/ST, are eligible for admission into MBBS/BDS Courses and they have to fulfill other relevant conditions laid down in these regulations as per NMC (erstwhile MCI)/ Dental Council of India guidelines.

*Lower percentile of marks for SC/ST/BC/PH is only for eligibility purpose and will not be applicable for reservation as there are no reservation quotas for these categories. Caste certificate issued by other state Governments will be considered for determining their eligibility for cut-off scores.

3) MINIMUM AGE:

Candidate should have completed 17 years of age as on 31-12-2023. Candidate who does not complete 17 years as on 31-12-2023 are not eligible and need not apply.

4) ELIGIBILITY TO "B1 -15%" OF CATEGORY – B SEATS:

Candidates from all over the country are eligible for admission into "Cat-B1" seats under Management Quota in MBBS and BDS Courses as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. YSRUHS regulations and filled first by order of merit from the merit list displayed under the regulations prescribed.

5) ELIGIBILITY TO COMPETENT AUTHORITY (SELF-FINANCING) SEATS AVAILABLE IN NEW GOVERNMENT MEDICAL COLLEGES PERMITTED FROM 2023-24 ONWARDS:

- i) These seats shall be allotted to local candidates of two local areas of Andhra Pradesh i.e. by order of merit from the merit list displayed under these regulations.
- ii) ELIGIBILITY CONDITIONS IN RESPECT OF THE CANDIDATES WHOSE LOCAL STATUS IS ANDHRA PRADESH.

LOCAL CANDIDATE OF ANDHRA PRADESH MEANS

- a) Candidate who has studied 4 years in an educational institution preceding the qualifying examination in Andhra Pradesh.
(OR)
- b) Candidate who has studied the maximum period (4 years) in Andhra Pradesh out of 7 years of study period in educational institution preceding the qualifying examination.
(OR)
- c) If a candidate has not studied in educational institution but resided, then Candidate who has not studied in an educational institution but resided 4 years preceding the qualifying examination in Andhra Pradesh
(OR)
- d) Candidate who has not studied in educational institution but has resided in Andhra Pradesh the maximum period out of 7 years preceding the qualifying examination (of residence)

6) ELIGIBILITY TO "B2 - 85%" OF CATEGORY – B SEATS IN UN-AIDED PRIVATE NON-MINORITY MEDICAL COLLEGES AND DENTAL COLLEGES

- i) These seats shall be allotted to local candidates from Andhra Pradesh State only i.e. by order of merit from the merit list displayed under these regulations.
- ii) ELIGIBILITY CONDITIONS IN RESPECT OF THE CANDIDATES WHOSE LOCAL STATUS IS ANDHRA PRADESH.

LOCAL CANDIDATE OF ANDHRA PRADESH MEANS

- e) Candidate who has studied 4 years in an educational institution preceding the qualifying examination in Andhra Pradesh.
(OR)
- f) Candidate who has studied the maximum period (4 years) in Andhra Pradesh out of 7 years of study period in educational institution preceding the qualifying examination.
(OR)
- g) If a candidate has not studied in educational institution but resided, then Candidate who has not studied in an educational institution but resided 4 years preceding the qualifying examination in Andhra Pradesh
(OR)
- h) Candidate who has not studied in educational institution but has resided in Andhra Pradesh the maximum period out of 7 years preceding the qualifying examination (of residence)

7) ELIGIBILITY TO “CATEGORY-B” AND CATEGORY- C (NRI) SEATS IN UN-AIDED PRIVATE MINORITY MEDICAL COLLEGES DENTAL COLLEGES:

Management Quota “Category-B” & “Category-C (NRI)” seats in Minority Medical and Minority Dental Colleges will be allotted to Muslim Minority Candidates only. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Mop-up Phase of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.

8) ELIGIBILITY TO COMPETENT AUTHORITY (NRI CATEGORY) SEATS AVAILABLE IN NEW GOVERNMENT MEDICAL COLLEGES PERMITTED FROM 2023-24 ONWARDS

- i. Foreign Students / OCI Card Holders including PIO / NRI or Children / under Guardianship of NRI, who have been secured cut-off score and more in NEET UG -2023 are eligible for admission into MBBS and BDS Courses under **Competent Authority (NRI Category) seats in Govt. Medical Colleges** and eligibility shall be as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. YSRUHS regulations.
- ii. NRI seats shall be filled by order of merit from the merit list displayed as per the regulations as prescribed in the Prospectus notified.
- iii. The candidate should submit an affidavit through Annexure-II and required documents that he / she is NRI or Children / under guardianship of NRI.

9) ELIGIBILITY TO “CATEGORY – C” SEATS IN UN-AIDED PRIVATE NON-MINORITY / MINORITY MEDICAL COLLEGES AND DENTAL COLLEGES

- iv. Foreign Students / OCI Card Holders including PIO / NRI or Children / under Guardianship of NRI, who have been secured cut-off score and more in NEET UG -2023 are eligible for admission into MBBS and BDS Courses under “**Category-C (NRI)**” seats of Management Quota in Private Un-aided **Non-Minority and Minority Medical Colleges and Dental Colleges**; and NRI seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati and eligibility shall be as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. YSRUHS regulations.
- v. NRI seats shall be filled by order of merit from the merit list displayed as per the regulations as prescribed in the Prospectus notified.
- vi. The candidate should submit an affidavit through Annexure-II and required documents that he / she is NRI or Children / under guardianship of NRI.

10) NRI CATEGORY SEATS IN SRI PADMAVATHI MEDICAL COLLEGE FOR WOMEN (Under SVIMS), TIRUPATI:

Candidates opting for NRI Category seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati are informed to visit SVIMS Website: <http://svimstpt.ap.nic.in> for fee particulars for NRI Category Seats. The seats will be filled as per the Government Orders in this regard.

12) INSTRUCTIONS TO THE CANDIDATES:

1. The same application will be considered for all the rounds of the counseling including MOP-UP round counseling.
2. For complete details visit University website <https://drysr.uhsap.in> and the candidates are advised to download Prospectus / Regulations and take a printout. Read these carefully to ensure your eligibility before applying.
3. Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible for the management quota [Category B1, B2 & C (NRI)] seats, **but they have to submit separate online application** duly uploading the required scanned original certificates through <https://ugmq.ylsruhs.com>
4. The Application submitted only for Competent Authority Quota seats will not be considered for Management Quota seats.
5. Candidates **possessing qualification of the University / Board of an institution outside the Andhra Pradesh State** should submit Equivalence certificate issued by the Board of Intermediate Education of Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the College.
6. Candidates **possessing qualification of the University / Board of an institution outside INDIA** should submit Eligibility / Equivalence certificate issued by Association of Indian Universities, New Delhi and also Equivalence certificate issued by the Board of Intermediate Education, Andhra Pradesh, to the effect that the qualification possessed is equivalent to or higher than the Intermediate examination conducted by the Board of Intermediate Education of Andhra Pradesh, at the time of admission in the college.
7. **Application and Processing fee including verification fee:** Rs.10,620/- (Rs.9000/-+ Rs.1620/-(GST)) plus Bank charges extra can be paid through Debit card / Credit card / Net Banking / UPI.
8. The online application can be filled through any computer with internet connection or mobile with data connection. (**NOTE: preferably desktop or laptop**)
9. The Application and Processing fee including verification fee once paid will not be refunded or adjusted to a further date. The fee is non – refundable. Hence, candidates are advised to check their eligibility before applying.
10. The Provisional merit position will be displayed on the University website after verification of uploaded scanned original certificates.
11. Notification for exercising web options will be issued separately. Therefore, the candidates are advised to visit University website <https://drysr.uhsap.in> regularly for further notifications.

12. The Candidates are hereby informed that if they have secured admission in medical colleges of other states, joined the course and if they are involved in blocking the seats under management quota in Dr. YSR UHS, the university will initiate legal action and same will be inform to the National Medical Commission for further course of action.
13. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2023 Rank.
14. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
15. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
16. Registration along with uploading of Scanned Original certificates will be permitted only once irrespective of the number of times of exercising web options / Number of counseling. No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
17. Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates the merit list will be released. Candidates are advised to watch the university website regularly for further Notifications/ Instructions.
18. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
19. Management Quota "Category-B" & "Category-C (NRI)" seats in Minority Medical Colleges and Minority Dental Colleges will be allotted to Muslim Minority Candidates only. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Mop- up Phase of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.


