
**PUBLIC NOTICE**

2. It is clarified that the above said letters have not been issued by the Member/President, MARB. These letters are forged/fake and cannot be considered as valid permission form Medical Assessment and Rating Board, National Medical Commission.

3. The above facts are brought to the notice of all concerned and general public to not take any action based on the fake/forged letter. Appropriate action is being taken in the matter in accordance with the law.




