### **Notification for exercising web options for 2<sup>nd</sup> Phase of web based counseling for admission into BNYS (Bachelor of Naturopathy and Yogic Sciences) course for the academic year 2024-25**

In continuation of earlier Notification dated 30.09.2024, the University hereby notify the 2<sup>nd</sup> Phase of web -based counselling for admission into BNYS course for the academic year 2024-25 in the colleges affiliated to Dr.NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are eligible in the Final Merit list notified on the Website on **08.11.2024** are only to exercise their options as per the Seat Matrix displayed on the Website <https://drntr.uhsap.in>

**UNIVERSITY FEE:** Candidates who are allotted with a seat, have to pay Rs.8,600/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card/ Internet Banking).

**TUITION FEE:** The selected candidates have to pay tuition fee of Rs.24,500/- per year for admission into UG AYUSH Courses as per orders of Government of Andhra Pradesh G.O.Ms.No.141 HM & FW(C2) Dept., dt.31.08.2023 & G.O.Ms.No.193 HM & FW(F2) Dept., dt.31.10.2023.

#### **Instructions to the candidates:-**

##### **Information regarding Phase-II**

1. Eligible candidates as per Final Merit position are only eligible for exercising web options in Private Un-aided BNYS Colleges.
2. **Vacancy position is displayed on University website for the information of the students to exercise their options.**
3. **Fresh options will be obtained from all the eligible candidates.**
4. Candidate can give options on the web either from home or any other place having internet facility.
5. One Time Password will be sent to the registered mobile at the time of registration and also at the time of saving Web options.
6. The password consists of SIX letter code with English capitals A to Z.
7. Vacancies available for the Phase – II of counselling
  - a) Vacant seats after Phase – I - 23
  - b) Not Reported seats after Phase – I - 50

8. Conversions will be conducted in this 2<sup>nd</sup> Phase counselling for filling up of the unfilled vacancies if any as per the rules.
9. Candidates opting for BNYS degree course are informed that, there is no limit of

choices (number) for exercising web options. Candidates can exercise any number of options for available colleges if the candidates are interested to join as per eligibility.

10. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. If they are not interested to join any college then they should not exercise options for the same.
11. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of web options schedule.
12. **Options:**
  - a. The eligible candidates present in the Final Merit list displayed on **08.11.2024** should exercise options.
  - b. A candidate has to exercise options for the interested colleges in the order of priority.
  - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.

Candidates are instructed to take the print out of the saved options.

13. The allotment of seats is as per G.O.Ms.No.8, dt.29-01-2021, merit list and order of priority of options given by the candidate.
14. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website <https://apuhs-ugadmissions.aptonline.in/UGBNYS/Home/StudentLogin> for status of allotment.
15. The selected candidates have to download the provisional allotment order on payment of University Registration Fee through payment gateway and report to the Principal of the allotted college on or before the date specified in the allotment order.
16. Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee of Rs. 8,600/-.
17. The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
18. The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
19. If not allotted any seat in Phase-I: Candidates who have not been allotted any seat in the Phase-I of counselling will be considered for available vacancies in Phase-II of counselling with fresh Options.
20. If not reported at the allotted college: The candidates who do not report at the allotted college in the Phase-I counselling, will be allowed to participate in the Phase-II counselling with fresh options, provided that the candidates have no right to claim earlier Phase-I allotted seat again under Phase-II counselling.
21. If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the reallocated college with downloaded allotment order along with Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
22. Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II, but should download the allotment order if there is a change in Phase-II.

23. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent phases of counselling, the original certificates will be sent to the college concerned by the college to where the candidate has slide from.

**Information regarding Phase-III**

24. If not allotted any seat in Phase-II : Candidates who have not been allotted any seat in the Phase-II of counselling will be considered for available vacancies in Phase-III of counselling with fresh Options.
25. If not reported at the allotted college : The candidates who do not report at the allotted college in the Phase-II counselling, will be allowed to participate in the Phase-III counselling with fresh options, provided that the candidates have no right to claim earlier Phase-II allotted seat again under Phase-III counselling.
26. If the joined candidates of Phase-II slides to other college during Phase-III of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order alongwith Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
27. Candidates getting upgraded in Phase-III of Counselling will not have any claim on previous allotments, i.e., Phase-II seat as the vacancies resulting from upgradation are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.
28. **The University fee and other fee once paid shall not be refunded under any circumstances.**
