In continuation to the reference cited above, I am, by direction, to inform that the Phase-II of Web based counselling for admissions into **BDS seats under Management quota** for the Academic Year 2024-25 is completed and allotments are released on **02.11.2024** to the selected candidates.

The candidates can download allotment order through online after paying respective requisite fee as detailed below: The last date for reporting at the allotted colleges by **04.00 PM on 03-11-2024**.

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for UG Dental admissions. The Original certificates of the candidates were not verified by the University.

I therefore, request you to constitute an admission Committee internally at college level for verification of the original certificates of the allotted candidates at the time of admission at college and ensure that the candidate has fulfilled the eligibility criteria as per Dental Council of India Regulations / University Regulations.

The "Committee" to be constituted at the colleges shall verify all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is specified vide Annexure- I.

Further, I request you to freeze the data of Not joined/Reported candidates by **04.00 PM on 03-11-2024** through the following link https://apuhs-ugadmissions.aptonline.in/MBBSMQ/Home/Home duly following the instructions of the Service Provider.

While admitting the candidates, the following guidelines are to be followed:

1. Selected candidates have to report to the Principal of the allotted college before the last date and time for joining as specified on the allotment order with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.

2. Tuition Fee:

As per G.O.Ms.No.503 HM & FW, (C1) Department, Dt.06-08-2024, the following is the tuition fee in respect of the Category-B & C seats in Private Un-aided Minority and Non-Minority Dental Colleges in Andhra Pradesh per annum for 4 years.

- Candidates shall check their final allotment in Phase-II web based counseling and take the print out of allotment letter from the web and report to the respective colleges on or before the date specified on the Provisional allotment letter.
 - a. Candidate who has already joined and now slid to another college is deemed to be relieved from the previous college and who have paid university fee in the Phase-I need not pay again and shall report to the Principal of newly allotted college with the following documents.
 - i. Allotment letter of phase-II counseling
 - ii. Custodian certificate issued by the previous college
 - iii. Admission letter issued by the previous college affiliated to Dr.NTR UHS and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission. The candidate also informed to intimate the Principal of earlier college about the allotment in phase-II counseling through mail / mobile.
 - b. Fresh allotments: Candidates who are allotted seat in the phase-II have to download the allotment order from the portal by paying University fee Rs.10,600/- through payment gateway and report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
- The original certificates of the candidates who got fresh allotment will be verified at the college and incase of any discrepancy the provisional allotment will be cancelled and action will be initiated as per University regulations.
- 3. If the candidate slides to other college during phase-II of counselling, the original certificates will be sent to the newly allotted college by the previous college.
- Any candidate already joined in a seat under Competent Authority Quota Phase-I / II or Management Quota Phase-I seat in AP can slide to a seat in this Phase-II counselling. In such case, the tuition fee already paid for the CQ Phase-I / II or MQ Phase-I is to be returned to the candidate by the respective
- 5. The Principals of the colleges where the candidates already joined under Phase – I /II CQ or Phase-I MQ seats of A.P and now allotted a seat in another college in this Phase–II shall relieve the candidates by giving relieving order.
- Any candidate allotted a seat and joined in this Phase-II MQ can slide to a seat under Competent Authority Quota Phase-III of Andhra Pradesh or Phase-III MQ. In such case, the tuition fee already paid for the earlier seat is to be returned to the candidate by the respective college.
- The Principals of the colleges where the candidates join in this Phase-II MQ and later slides to a seat under Competent Authority Quota Phase-III or Management Quota Phase-III of Andhra Pradesh shall relieve such candidates by giving relieving order.

The above instructions should be followed strictly, in order to meet the time schedule for BDS course as per Govt. of India / DCI norms.
