GENERAL INSTRUCTIONS

1) Eligible Candidates

- i) Eligible candidates who are already found in the Final Merit Position under Management Quota displayed on 15-09-2024, 02.11.2024 and 02.12.2024 are eligible to participate in the final round under Special Stray Vacancy Round-II provided that the candidates should not hold any seat in the previous phases of Counselling of All India Quota / State Quota / Deemed University.
- ii) Eligible candidates have to exercise web options for Stray Vacancy Round-II as per their College-wise priorities. The allotments will be as per the prioritized options exercised by the candidates.

2) Not Eligible Candidates:

- a. Candidate who is not found in the Final Merit List of Management Quota of Dr. NTR University of Health Sciences, A.P., Vijayawada
- b. Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling / Deemed University in all Phases including Special Stray Vacancy Rounds.
- c. Candidates who have been allotted BDS seats by Dr. NTRUHS in Phase-III/Stray Vacancy Round of Dr. NTRUHS Counselling (both CQ & MQ) Including Special Stray Vacancy Rounds.
- d. Candidates found in the list shared by Medical Counselling Committee (MCC) after Special Stray Vacancy Round.

- 3) Other terms and conditions regarding Security Deposit amount of Rs.2,00,000/- for BDS Course and Web options as notified in this office Notice on 21.11.2024 will remain same.
- 4) Candidates will receive the message regarding allotment of seats, if seat is allotted.
- 5) Candidates who are allotted seat under Special Stray Vacancy Round of counselling have to report to the allotted college **COMPULSORILY** with all original certificates, provisional allotment order, copy of final application and pay the tuition fee, college fee, such candidate cannot resign the seat allotted.
- 6) The University fee once paid shall not be refunded / adjusted to future date under any circumstances.
- 7) Dr. NTR University of Health Sciences does not entertain or support seat blocking / cancellation of BDS seats.
- 8) In case any student is involved in seat blocking, legal action will be initiated against such candidate as per rules.
- 9) Decision of the Competent Authority is final in all aspects.
