In continuation to this office notification dated.04-09-2024 and notice dated 28-09-2024, the following is herewith notified in connection with Phase-III web-based counseling for admission into MBBS course under Competent Authority Quota seats for the Academic Year 2024-25 for information of the candidates who have exercised one-time options.

General Instructions:

- Candidates are advised to go through the Instructions on Counselling Procedure posted in University website on 27.08.2024.
- Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website for status of allotment.
- Selected candidate has to report to the Principal concerned or before the date notified in Provisional allotment order.
- Classes already commenced from 14.10.2024 for MBBS Course, 2024-25.
- University Fee:** Candidate can download the provisional allotment order on payment of University Fee Rs.10,600/- through payment gateway. The students can view the college wise list of selected candidates in the website. Candidates who allotted in the Phase-I or Phase-II and paid university fee need not pay again.
- Fresh allotment during Phase-III:** Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee of Rs.10,600/- along with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.

8. The University fee once paid shall not be refunded or adjusted to future date under any circumstances.
9. If the joined candidate of Phase-I/Phase-II slides to other college during Phase-III of counselling, the original certificates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order and custodian certificate issued by the previous college under Dr. NTRUHS and to pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
10. Verification of original certificates will be conducted at the college during admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University regulations.
11. **There will be no upgradation or Free Exit after Phase-III of counselling.**
12. **Candidates allotted seat under Competent Authority in Phase-III will not be allowed to opt for Phase-III of Management Quota counselling and further counsellings.**
13. Dr. NTR University of Health Sciences does not entertain or support seat blocking/cancellation of MBBS seats.
14. In case any student is found involved in seat blocking, legal action will be initiated against such candidate.
