**ADMISSIONS INTO MBBS COURSE UNDER COMPETENT AUTHORITY**  
**QUOTA FOR THE ACADEMIC YEAR 2024-25**

**NOTICE**

In continuation to the Phase-III results declared on 26<sup>th</sup> of October, 2024 and Notice dated.27.10.2024, the following is hereby informed

1. On 22<sup>nd</sup> of October, 2024, this university has received Letter of Permission (LOP) for enhancement of seats from 150 to 200 in respect of Government Medical College (RIMS), Srikakulam.
2. As per procedure after contributing 15% seats to All India Quota, remaining 42 seats were added to State Quota and allotments were released accordingly on 26.10.2024.
3. On, 28-10-2024, the Medical Counselling Committee (MCC) has clarified that request to include **08 seats of AIQ at Government Medical College, Srikakulam Andhra Pradesh** could not be acceded and informed that this year the college can contribute the 08 AIQ seats in State UG counselling and next year i.e 2025 double the number of seats i.e **16 seats may be contributed to All India Quota counselling to compensate for current academic year i.e 2024**. This is an onetime measure that cannot be regarded as precedent.
4. In view of the clarification received from the MCC, as the facility of upgradation in State Quota is only upto Phase – III, the Competent Authority has decided to conduct revised Phase – III after adding 8 seats at GMC, Srikakulam duly protecting the merit while giving upgradation as per rules which are applicable for Phase – III of counselling.
5. While doing so, next year, i.e., 2025, double the number of seats i.e., **16 seats will be contributed to All India Quota counselling to compensate for current academic year i.e 2024**.
