The petitioners have been declared not eligible in view of their physical disability, not conforming to the regulations in the selection criteria fixed by the official respondents.

2. In this regard, petitioner in W.P.No.19456 of 2024, namely Konda Vishnu Raghu Vardhan Reddy, was held to be ineligible on account of the fact that he suffered from "Left side Hemiparesis" and was held not fulfilling the NEET criteria on account of the fact that both upper limbs were not functionally competent. With a view to question the correctness of the assessment made by the Regional Medical Board of Rajiv Gandhi Government General Hospital, Chennai, which issued the certificate, dated 03.08.2024, learned counsel for the petitioners placed reliance upon a

certificate issued by the Dr. N.T.R. University in which the petitioner was held to be eligible on the ground that the extent of disability in the case of the said petitioner was only 45%, which would make the petitioner eligible.

3. However, on the previous date of hearing, learned counsel for the University, Mr. G. Vijaya Kumar, had stated that the petitioner would not be eligible and that the University was conducting yet another medical test so that the real picture could be seen.

4. The medical examination, it appears, has been conducted in which this time the petitioner in W.P.No.19456 of 2024 has been held to be not eligible on account of the fact that the petitioner did not meet the criteria of functionally competent both upper limbs, as per the Medical Council of India (for short "MCI") Gazette.

5. Learned counsel for the petitioners stated that the assessments made by the Medical Board are incorrect and have not assessed the extent of disability on the touchstone of the criteria fixed by the National Medical Council (for short "NMC") and that the Certificate of Disability issued by the Medical Board had not specifically reflected the basis for arriving at the conclusion that the petitioner was not eligible. It was further stated that the Medical Board had to specifically go into the question of sensation, range of motion as also the strength of the upper limbs.

6. Insofar as the petitioner in W.P.No.19463 of 2024, namely Nikhila Sree Vyakaranam is concerned, the N.T.R. University on re-assessment of the physical incapacity has found her to be eligible under the PwD Quota. This would make her eligible for consideration against the seats available under the State Quota.

7. However, learned counsel for the NMC, Mr. S. Vivek Chandra Sekhar, and learned Deputy Solicitor General of India, Mr. Pasala Ponnarao, would

submit that the candidates cannot be held eligible for admission under the All India Quota on the basis of her certificate issued by an institute other than the institutes which have been recognized as competent to medically assess the extent of physical disability.

8. It is stated that the list of institutes which have been identified are contained in Appendix-VII of the Information Bulletin issued by the National Testing Agency (NTA).

9. On a perusal of the Appendix-VII, there are sixteen institutes which have been identified, which are situated at far off distances from the place where the students are residing. Considering the fact that any Medical Assessment Report is also susceptible to errors, as we have found out in the case of Ms. Nikhila Sree Vyakaranam, where the N.T.R. University of Health Sciences finds the petitioner eligible although the recognized institute Regional Medical Board of Rajiv Gandhi Government General Hospital, Chennai, had found her to be ineligible, we deem it appropriate to have all the three petitioners in W.P.Nos.19456, 19463 and 19800 of 2024, be medically examined by a Board of Doctors constituted at All India Institute of Medical Sciences (AIIMS), Mangalagiri, from the specialties of Orthopedics, Neuro-Sciences and Physical Medicine and Rehabilitation.

10. The candidates shall appear for examination before the Medical Board to be constituted by the AIIMS, Mangalagiri by 20.09.2024.

11. The report shall be made available to learned Deputy Solicitor General of India by 23.09.2024.

12. List the matter on 24.09.2024.

13. In the meantime, Ms. Nikhila Sree Vyakaranam shall be considered in the PwD category against the seats in State Quota.

14. We further make it clear that if there are any other candidates, who claim to be similarly situate, they may also approach the N.T.R. University of Health Sciences, which may refer them to the same Medical Board for examination.
