1) **REGULATIONS**:

The following are the Regulations for admission of students into MBBS / BDS Courses for the academic year 2024-25 applicable to the following categories:

- 1) Competent Authority (Self-financing) seats and Competent Authority (NRI Category) seats in new <u>Government Medical Colleges</u> permitted from the academic Year 2023-24 onwards;
- 2) <u>MANAGEMENT QUOTA</u> [(Category-B and Category-C(NRI)] seats in Private Un-aided Non-Minority and Minority Medical Colleges and Dental Colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada;
- 3) <u>NRI Category seats</u> in Sri Padmavathi Medical College for Women (<u>Under SVIMS</u>), Tirupati.

As per the NMC (Erstwhile MCI)/DCI Rules, the admissions into these courses will be made through separate counsellings with common application.

2) NUMBER OF SEATS:

- i) The List of Medical & Dental Colleges and No. of Seats available under Competent Authority (Self-financing); Competent Authority (NRI Category); Category-B1 & B2 and Category –C (NRI)) is given in the Annexure - I.
- ii) The admissions into the colleges are subject to the permission by the Government of India / NMC/ DCI and granting of affiliation by Dr. N.T.R. University of Health Sciences for the academic year 2024-25.
- iii) The candidates should have qualified in NEET UG 2024 exam by securing cut off marks and more.
- iv) The Rank and Score in NEET UG 2024 shall be the basis for the selection into MBBS and BDS Courses subject to these regulations.

3) SEAT SHARING:

1) Government Medical Colleges permitted from 2023-24 onwards

(i) As per G.O.Ms.No.107, HM & FW (C1) Department, dated.19.07.2023, after allocation of 15% of seats to All India Quota and out of the remaining seats, the Competent Authority (Self-Financing) category and Competent Authority (NRI Category) shall be as follows :-

a) Competent Authority (Self-financing):

35% of the seats shall be Competent Authority (Self-Financing) category

b) Competent Authority (NRI Category):

15% of the seats shall be Competent Authority (NRI Category).

2) Un-aided Private Non-Minority Medical and Dental Colleges:

i)CATEGORY - B- 35% OF INTAKE

Category-B seats (35% of Intake) are further categorized as B1 and B2as follows :-

a) B1 -15% of Category – B seats are open to the candidates from all over the Country and filled first by order of merit from the merit list of displayed under these regulations.

b) B2 -85% of Category – B seats shall be allotted to local candidates from Andhra Pradesh State only i.e. by order of merit from the merit list displayed under these regulations.

<u>NOTE:</u> In case of a fraction of 0.5 between Category-B1 and Category-B2 seats, the fraction is to be rounded up to the figure one and shall be rotated between 'B1' and 'B2' Category seats in the alternate years starting from the academic year 2023-24 i.e. for the academic year 2023-24, if the seat due to fraction of 0.5 shall be meant for Category-B1 and for the academic year 2024-25, the said seat due to fraction of 0.5 shall be meant for Category-B2 by rotation and so on.

For Example:

For the academic year 2023-24, the seat due to fraction of 0.5 between the seats of Category-B1 and Category-B2, the same shall be allotted to Category-B1, and

For the academic year 2024-25, the seat due to fraction of 0.5 between the seats of Category-B1 and Category-B2, the same shall be allotted to Category-B2.

II) CATEGORY-C (NRI) -15% OF INTAKE.

<u>NOTE:</u> In case of a fraction of 0.5 between Category-B and Category-C seats, the fraction is to be rounded upto the figure one and shall be rotated between 'B' and 'C' Category seats in the alternate years starting from the academic year 2023-24 i.e. for the academic year 2023-24, if the seat due to fraction of 0.5 shall be meant for Category-B and for the academic year 2024-25, the said seat due to fraction of 0.5 shall be meant for Category-C by rotation and so on."

For Example:

For the academic year 2023-24, the seat due to fraction of 0.5 between the seats of Category-B and Category-C (NRI), the same shall be allotted to Category-B, and

For the academic year 2024-25, the seat due to fraction of 0.5 between the seats of Category-B and Category-C (NRI), the same shall be allotted to Category-C(NRI).

• The above provisions on fraction of 0.5 under Management Quota seats were issued by the Govt.of Andhra Pradesh vide following Government Orders:

G.O.Ms.No.58, HM & FW (C1) Dept., dt.28.04.2023 (Un-aided Minority Colleges) G.O.Ms.No.59, HM & FW (C1) Dept., dt.28.04.2023 (Un-aided Non-Minority Colleges)

4) <u>ELIGIBILITY:</u>

i) CANDIDATES WHO SECURED THE CUT-OFF MARKS AND MORE IN THE NEET-UG 2024 AND FULFILLED THE FOLLOWING ELIGIBILITY CRITERIA FOR ADMISSION INTO <u>MBBS /</u> <u>BDS</u> COURSES HAVE TO SUBMIT THEIR ONLINE APPLICATION BY PAYING THE NON-REFUNDABLE APPLICATION AND PROCESSING FEE INCLUDING VERIFICATION FEE THROUGH ONLINE AND UPLOAD THE SCANNED CERTIFICATES / DOCUMENTS REQUIRED FOR ADMISSION UNDER THESE REGULATIONS.

Candidates should secure the following cut-off scores and more in NEET UG-2024 conducted by NTA for the year 2024-25 to apply:

Under Graduate Medical and Dental courses:

<u>NOTE</u>: *LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC/ST/BC/OBC /PwBD IS ONLY FOR CUT OFF SCORE TO DETERMINE ELIGIBILITY.

ii) Candidates who got registered as Persons of Indian Origin (PIO) / Overseas Citizen of India (OCI) Cardholders on or after 04.03.2021 are eligible for admission only against any Non-Resident Indian seat or any supernumerary seat; and shall not be eligible for admission against any seat reserved exclusively for Indian Citizens.

5) EDUCATIONAL QUALIFICATION :

Candidates should have passed Intermediate (10+2) or its equivalent examination, i.e qualifying examination, securing not less than 50% of marks taken together in Physics, Chemistry, Biology (Botany, Zoology) / Bio-technology, 40% marks in case of OBC/BC/SC/ST, are eligible for admission into MBBS/BDS Courses and they have to fulfill other relevant conditions laid down in these regulations as per NMC (erstwhile MCI)/ Dental Council of India guidelines.

*Lower percentile of marks for SC / ST / BC / PwBD is only for eligibility purpose and will not be applicable for reservation as there are no reservation quotas for these categories. Caste certificate issued by other state Governments will be considered for determining their eligibility for cut-off scores.

6) MINIMUM AGE:

Candidate should complete 17 years of age by **31-12-2024**. Candidate who do not complete **17** years as on **31-12-2024** are not eligible and need not apply.

7) ELIGIBILITY TO "B1 -15%" OF CATEGORY – B SEATS:

Candidates from all over the country are eligible for admission into "Cat-B1" seats under Management Quota in MBBS and BDS Courses as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. NTRUHS regulations and filled first by order of merit from the merit list displayed under these regulations.

8) <u>ELIGIBILITY TO COMPETENT AUTHORITY (SELF-FINANCING)</u> <u>SEATS AVAILABLE IN NEW</u> <u>GOVERNMENT MEDICAL COLLEGES PERMITTED FROM 2023-24 ONWARDS:</u>

- These seats shall be allotted to local candidates of two local areas of Andhra Pradesh State
 i.e. by order of merit from the merit list displayed under these regulations.
- ii) ELIGIBILITY CONDITIONS IN RESPECT OF THE CANDIDATES WHOSE LOCAL STATUS IS ANDHRA PRADESH.

LOCAL CANDIDATE OF ANDHRA PRADESH MEANS

a) Candidate who has studied 4 years in an educational institution preceding the qualifying examination in Andhra Pradesh.

(OR)

b) Candidate who has studied the maximum period (4 years) in Andhra Pradesh out of 7 years of study period in educational institution preceding the qualifying examination.

(OR)

c) If a candidate has not studied in educational institution but resided, then Candidate who has not studied in an educational institution but resided 4 years preceding the qualifying examination in Andhra Pradesh

(OR)

d) Candidate who has not studied in educational institution but has resided in Andhra Pradesh the maximum period out of 7 years preceding the qualifying examination (of residence)

9) <u>ELIGIBILITY TO <u>"CATEGORY - B2 SEATS IN UN-AIDED PRIVATE NON-MINORITY MEDICAL</u> <u>COLLEGES AND DENTAL COLLEGES</u></u>

- i) These seats shall be allotted to local candidates from Andhra Pradesh State only i.e. by order of merit from the merit list displayed under these regulations.
- ii) ELIGIBILITY CONDITIONS IN RESPECT OF THE CANDIDATES WHOSE LOCAL STATUS IS ANDHRA PRADESH.

LOCAL CANDIDATE OF ANDHRA PRADESH MEANS

e) Candidate who has studied 4 years in an educational institution preceding the qualifying examination in Andhra Pradesh.

(OR)

f) Candidate who has studied the maximum period (4 years) in Andhra Pradesh out of 7 years of study period in educational institution preceding the qualifying examination.

(OR)

g) If a candidate has not studied in educational institution but resided, then Candidate who has not studied in an educational institution but resided 4 years preceding the qualifying examination in Andhra Pradesh

(OR)

h) Candidate who has not studied in educational institution but has resided in Andhra Pradesh the maximum period out of 7 years preceding the qualifying examination (of residence)

10) <u>ELIGIBILITY TO "CATEGORY–B" AND CATEGORY- C(NRI) SEATS</u> IN UN-AIDED PRIVATE MINORITY MEDICAL COLLEGES DENTAL COLLEGES:

Management Quota "Category-B" & "Category-C (NRI)" seats in Minority Medical Colleges and Minority Dental Colleges will be allotted to Muslim Minority Candidates only. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Stray Phase of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.

11) <u>ELIGIBILITY TO COMPETENT AUTHORITY (NRI CATEGORY) SEATS AVAILABLE IN NEW</u> <u>GOVERNMENT MEDICAL COLLEGES PERMITTED FROM 2023-24 ONWARDS:</u>

- i. Foreign Students / OCI Card Holders including PIO / NRI or Children / under Guardianship of NRI, who have been secured cut-off score and more in NEET UG -2024 are eligible for admission into MBBS and BDS Courses under Competent Authority (NRI Category) seats in Govt. Medical Colleges and eligibility shall be as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. NTRUHS regulations.
- ii. NRI seats shall be filled by order of merit from the merit list displayed under these regulations.
- iii. The candidate should submit Declaration and required documents that he / she is NRI or Children / under guardianship of NRI.

12) <u>ELIGIBILITY TO "CATEGORY – C" SEATS IN UN-AIDED PRIVATE NON-MINORITY /</u> MINORITY MEDICAL COLLEGES AND DENTAL COLLEGES

- i. Foreign Students / OCI Card Holders including PIO / NRI or Children / under Guardianship of NRI, who have been secured cut-off score and more in NEET UG -2024 are eligible for admission into MBBS and BDS Courses under "Category-C (NRI)" seats of Management Quota in Private Un-aided Non-Minority and Minority Medical Colleges and Dental Colleges; and NRI seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati and eligibility shall be as per National Medical Commission (erstwhile MCI) / Dental Council of India / Dr. NTRUHS regulations.
- ii. NRI seats shall be filled by order of merit from the merit list displayed under these regulations.
- iii. The candidate should submit Declaration and required documents that he / she is NRI or Children / under guardianship of NRI.

13) <u>NRI CATEGORY SEATS IN SRI PADMAVATHI MEDICAL COLLEGE FOR WOMEN (UNDER</u> <u>SVIMS), TIRUPATI:</u>

Candidates opting for NRI Category seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati are informed to visit SVIMS Website: <u>http://svimstpt.ap.nic.in</u> for fee particulars for NRI Category Seats. The seats will be filled as per the Government Orders in this regard.

- ii) The Application submitted for Competent Authority Quota seats will not be considered for Management Quota seats.

- iii) The candidate should fill the online application form available in the Website with the data required-for and upload the scanned Certificates/Documents in support of their claim through internet.
- iv) The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after reading the Prospectus by keeping all the Certificates ready to enter the correct data and uploading of the scanned Original Certificates/ Documents, Photo and Signature after payment of fee through online.
- v) The candidate should furnish correct information in the online application form and upload scanned original certificates. The applications with incorrect information, invisible documents will not be considered and automatically rejected. If it is found that the candidate has furnished false information or uploaded fake or forged documents at any stage of admission or after closure of admissions, the University will take action that deems fit as per rules against such candidate including cancellation of seat/ admission, in case already admitted, without any notice and action will be taken legally.
