NOTICE TO THE CANDIDATES FOR SPECIAL STRAY VACANCY ROUND OF WEB-BASED COUNSELING FOR ADMISSION INTO MBBS COURSE UNDER COMPETENT AUTHORITY QUOTA SEATS FOR THE ACADEMIC YEAR 2024-25

Keeping in view of the NEET-UG Special Stray Vacancy Round Schedule- 2024 notified on 16.11.2024 by the Medical Counselling Committee (MCC), O/o DGHS, Ministry of Health & Family Welfare Dept., Govt. of India, the Competent Authority for admissions under State Quota has decided **to conduct Special Stray Vacancy Round of web-based Counselling for admission into MBBS Course under Competent Authority Quota seats** for the academic year 2024-25 duly implementing the rules as applicable to Stray Vacancy Round.

With regard to the legal issue involved in vacant seat at KMC, Kurnool, the Division Bench of the Hon'ble High Court of Andhra Pradesh, Amaravati while dismissing Writ Petition No.23760 of 2024 filed by Ms. Mandlem Shaik Saniya Azra, observed at Para -15 as follows: -

“15. In the circumstances, we do not find any irregularity in the reduction of reserved category seats in Kurnool Medical College. Consequently, the petitioner cannot be accommodated in BC-E category seats in Kurnool Medical College.”

In view of the above and in exercise of powers conferred under the Regulation of Admissions into Under Graduate Medical & Dental Professional Courses applicable to Government Colleges, Un-aided Minority / Non-Minority Professional Institutions in the State of Andhra Pradesh, the Competent Authority hereby notify the following schedule and rules / procedure in connection with **Special Stray Vacancy Round of web-based Counselling for the available vacancies for admission into MBBS Course in the colleges affiliated to Dr. NTRUHS under the Competent Authority Quota seats** for the academic year 2024-25:-

1. The details of seats available for Special Stray Vacancy Round of counselling under Competent Authority Quota,2024-25 :-

General Instructions:

1. Eligible Candidates

- Eligible candidates who are already found in the Final Merit Position under Competent Authority Quota displayed on 11-09-2024 and exercised onetime web options are eligible to participate in the Special Stray Vacancy Round, provided that the candidates should not hold any seat in the previous phases of Counselling of All India Quota / State Quota / Deemed University.

2. Not Eligible Candidates:

- a. Candidate who is not found in the Final Merit List of Competent Authority Quota of Dr. NTR University of Health Sciences, A.P., Vijayawada
 - b. Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling/ Deemed University.
 - c. Candidates who have been allotted seats (MBBS / BDS) by Dr. NTRUHS in all Phases of Dr. NTRUHS Counselling under Competent Authority Quota.
 - d. Candidates who have been allotted seats (MBBS / BDS) by Dr. NTRUHS from Phae-III onwards of Dr. NTRUHS Counselling under Management Quota.
 - e. Candidates who have been allotted seats (MBBS / BDS) by Dr. NTRUHS in Stray Vacancy Rounds of Dr. NTRUHS Counselling (both CQ & MQ).
 - f. Candidates who have been allotted seats on 23.11.2024 under UG All India Quota in Special Stray Vacancy Round by MCC.
3. Candidates will receive the message regarding allotment of seats, if seat is allotted.
 4. Candidates who have been allotted seats under Special Stray Vacancy Round of counselling shall report at the allotted college **COMPULSORILY** within the reporting schedule by downloading the allotment order on payment of University fee of Rs.10,600/- along with all original certificates and pay the tuition fee to complete the admission process, such candidate cannot resign the seat allotted.
 5. The University fee once paid shall not be refunded / adjusted to future date under any circumstances.
 6. Dr. NTR University of Health Sciences does not entertain or support seat blocking / cancellation of MBBS seats.
 7. In case any student is involved in seat blocking, legal action will be initiated against such candidate as per rules.
 8. Decision of the Competent Authority is final in all aspects.
