Sub:- Dr.NTR UHS - ADMISSIONS - Conduct of Web based counseling for admission into MBBS course for the academic year 2024-25 under Competent Authority Quota - Release of allotments of Phase-III counselling - Certain instructions issued - Regarding.

I am by direction to inform that, the 3rd Phase of web counselling for UG MBBS seats under Competent Authority Quota is completed on 26-10-2024 and candidates have to report at the respective Medical Colleges on or before <u>02.00 PM on 28-10-2024</u>.

In view of the MCC schedule, all the Principals are requested to treat SUNDAY (27-10-2024) as working day for the purpose of reporting of allotted candidates under Competent Authority Quota, Phase-III of Counselling.

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for UG Medical admissions. The Original certificates of the candidates were not verified by the University.

I therefore, request you to constitute an admission Committee internally at college level for verification of the original certificates of the allotted candidates at the time of admission at college and ensure that the candidate has fulfilled the eligibility criteria as per NMC (MCI) Regulations / University Regulations.

The "Committee" to be constituted at the colleges shall verify all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation found while verifying the original certificates which are as follows, with regard to eligibility should be brought to the notice of the University immediately:

- a) Educational qualification as per NMC
- b) Minimum age i.e. 17 years as on 31st December, 2024
- c) Category (caste)
- d) Local area
- e) EWS (Economically Weaker Section)

The list of documents to be verified at the time of admission is specified vide Annexure- I.

You are further requested to admit the candidate duly following the admission procedure and on production of original certificates and verification of allotment order of the candidates with the collegewise list available in the Link https://apuhs-ugadmissions.aptonline.in/MBBS/Home/StudentLogiin and to follow the instructions enclosed herewith strictly. You are also informed to upload the reported/not reported candidates data on the above website by 02.30 PM on 28-10-2024 without fail.

Instructions:-

1. Candidates will receive the message on the registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website: https://drntr.uhsap.in for status of allotment.

- Candidates shall check their final allotment in Phase-III web based counseling and take the print out of allotment letter from the web and report to the respective colleges on or before the date specified on the Provisional allotment letter.
 - a. Candidate who has already joined and now slid to another college is deemed to be relieved from the previous college and who have paid university fee in the Phase-I & Phase-II need not pay again and shall report to the Principal of newly allotted college with the following documents.
 - Allotment letter of 3rd phase counseling
 - · Custodian certificate issued by the previous college
 - Admission letter issued by the previous college affiliated to Dr.NTR UHS and pay the
 tuition fee to complete the admission process, failing which the candidate will lose the
 admission. The candidate also informed to intimate the Principal of earlier college
 about the allotment in 3rd phase counseling through mail / mobile.
 - b. <u>Fresh allotments:</u> Candidates who are allotted seat in the 3rd phase have to download the allotment order from the portal by paying University fee Rs.10,600/- through payment gateway and report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
- The original certificates of the candidates who got fresh allotment will be verified at the college and incase of any discrepancy the provisional allotment will be cancelled and action will be initiated as per University regulations.
- 4. If the candidate slides to other college during 3rd phase of counselling, the original certificates will be sent to the newly allotted college by the previous college.
- 5. Certain candidates who have reported under Phase-I/Phase-II allotments of Self-Financing / NRI category seats in new Government Medical Colleges / category B seats & category C (NRI) seats in Private Medical Colleges /SVIMS, Tirupati are allotted seat under this Competent Authority Quota of Phase-III counselling as per their options. Desirous candidates may exit from earlier reported Phase-I/Phase-II MQ seat and may report before the Principal concerned of the college under Phase-III CQ allotment within the date specified in allotment letter. In such cases, the Principals are requested to relieve the candidate who has reported under Phase-I/Phase-II MQ seat and again got allotment under this Phase-III CQ seat.
- 6. There will be no upgradation or Free Exit after Phase-III of counselling.
- Candidates allotted seat under Competent Authority in Phase-III will not be allowed to opt for Phase-III of Management Quota counselling and further counsellings.
- 8. The University fee once paid shall not be refunded under any circumstances.
