In continuation to the references cited above, I am, by direction, to inform that the Phase-III of Web based counselling for admissions into MBBS course for the academic year 2024-25 under the following category of seats is completed and allotments are released on 30-10-2024 to the selected candidates.

- 1) Competent Authority (Self-financing) seats and Competent Authority (NRI Category) seats in new Government Medical Colleges permitted from the academic Year 2023-24 onwards,
- 2) Management Quota [(Category-B1, B2 and Category-C(NRI)] seats in Private Un-aided Non-Minority and Minority Medical Colleges and Dental Colleges affiliated to Dr. NTRUHS
- 3) NRI Category seats in Sri Padmavathi Medical College for Women (Under SVIMS), Tirupati.

The candidates can download allotment order through online after paying respective requisite fee as detailed below: The last date for reporting at the allotted colleges by **02.00 PM on 02-11-2024**.

The selected candidates for MBBS course in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati have to pay the tuition fee at the college at the time of admission. Visit SVIMS Website: <http://svimstpt.ap.nic.in> for details of other fee particulars.

3. Candidates shall check their final allotment in Phase-III web based counseling and take the print out of allotment letter from the web and report to the respective colleges on or before the date specified on the Provisional allotment letter.
  - a. Candidate who has already joined and now slid to another college is deemed to be relieved from the previous college and who have paid university fee in the Phase-I or Phase-II need not pay again and shall report to the Principal of newly allotted college with the following documents.
    - i. Allotment letter of 3<sup>rd</sup> phase counseling
    - ii. Custodian certificate issued by the previous college
    - iii. Admission letter issued by the previous college affiliated to Dr.NTR UHS and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission. The candidate also informed to intimate the Principal of earlier college about the allotment in 3<sup>rd</sup> phase counseling through mail / mobile.
  - b. **Fresh allotments:** Candidates who are allotted seat in the 3<sup>rd</sup> phase have to download the allotment order from the portal by paying University fee Rs.10,600/- through payment gateway and report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
4. The original certificates of the candidates who got fresh allotment will be verified at the college and incase of any discrepancy the provisional allotment will be cancelled and action will be initiated as per University regulations.
5. If the candidate slides to other college during 3<sup>rd</sup> phase of counselling, the original certificates will be sent to the newly allotted college by the previous college.
6. Any candidate already joined in a seat under Management Quota Phase-I or Phase-II seat in AP can slide to a seat in this Phase-III counselling. In such case, the tuition fee already paid for the MQ Phase-I or Phase-II is to be returned to the candidate by the respective college.
7. The Principals of the colleges where the candidates already joined under Phase – I /II of MQ seats of A.P and now allotted a seat in another college in this Phase–III shall relieve the candidates by giving relieving order.

The above instructions should be followed strictly, in order to meet the time schedule for MBBS course as per Govt. of India / NMC norms.
