In view of the above and subject to availability of vacancies that may arise due to non-joining under Phase-III allotments released on 30.10.2024, common online Application form along with uploading scanned original certificates are invited from the eligible interested candidates (**who could not apply earlier**) for **admission into MBBS Course** under **Competent Authority (SELF-FINANCING) seats and Competent Authority (NRI Category) seats in new Government Medical Colleges** permitted from the academic Year 2023-24 onwards; **MANAGEMENT QUOTA [Category - B1, B2, & C(NRI)]** in Private Un-aided Non-Minority/ Minority **Medical Colleges** affiliated to Dr. N.T.R. University of Health Sciences and also for **NRI seats in Sri Padmavathi Medical College for Women** (under SVIMS), **Tirupati** for the academic year 2024-25.

The same application will be utilized for next phases of BDS Course under **MANAGEMENT QUOTA [Category - B1, B2, & C(NRI)]** in Private Un-aided Non-Minority / Minority **Dental Colleges** affiliated to Dr. N.T.R. University of Health Sciences, Vijayawada.

Subject to eligibility, the candidates who have already paid and registered under Management Quota but could not upload relevant documents earlier, can also now upload for Stray vacancy round under this notification.

1) ELIGIBILITY:

Candidates who secured the Cut-Off marks and more in the NEET-UG 2024 conducted by NTA for the year 2024 and fulfilled the following eligibility criteria for admission into MBBS and BDS Courses have to submit their online application by paying the non-refundable application and processing fee including verification fee through online and upload the relevant scanned original certificates / documents and images of photo / signature required for Management Quota seats.

Cut-off Scores in NEET-UG – 2024:

Category	Qualifying Criteria	Cut off score (out of 720)	Remarks
General category (OC / EWS)	50 th Percentile	720-162	Candidates scoring equal to or more than this cut-off score have been declared as qualified.
Persons with Disability-General Category (OC/EWS)	45 th Percentile	161-144	OC-PwBD candidates scoring equal to or more than this cut-off score have been declared as qualified.
SC / ST / BC & Persons with Benchmark Disability of BC / SC / ST Categories (PwBD-BC / PwBD-SC/ PwBD-ST)	40 th Percentile	161-127	SC / ST / BC / SC-PwBD / BC-PwBD / PwBD-ST candidates scoring equal to or more than this cut-off score have been declared as qualified.

NOTE: *LOWER PERCENTAGE / PERCENTILE OF MARKS FOR SC / ST / BC / OBC / PwBD IS ONLY FOR CUT-OFF SCORE TO DETERMINE ELIGIBILITY.

2) Educational Qualification:

Candidates should have passed Intermediate (10+2) or its equivalent examination, i.e. qualifying examination, securing not less than 50% of marks taken together in Physics, Chemistry, Biology (Botany, Zoology) / Bio-technology, 40% marks in case of OBC/BC/SC/ST, are eligible for admission into MBBS/BDS Courses and they have to fulfill other relevant conditions laid down in these regulations as per NMC (erstwhile MCI)/ Dental Council of India guidelines.

*Lower percentile of marks for SC/ST/BC/PH is only for eligibility purpose and will not be applicable for reservation as there are no reservation quotas for these categories. Caste certificate issued by other state Governments will be considered for determining their eligibility for cut-off scores.

3) MINIMUM AGE:

Candidate should complete 17 years of age by 31-12-2024. Candidate who do not complete 17 years as on 31-12-2024 are not eligible and need not apply.

6) INSTRUCTIONS TO THE CANDIDATES:

- Subject to the conditions laid down in the Information on Counselling Procedure, the same application will be considered for all the rounds of stray vacancy counseling.
- The Application submitted for Competent Authority (Convenor) Quota seats **WILL NOT BE** considered for Management Quota seats.
- The online application must be filled from a desktop or laptop with internet connection.
- The Application and Processing fee including verification fee including late fees, if any once paid will not be refunded or adjusted to a further date. **The fee is non-refundable. Hence, interested candidates are advised to check their eligibility before applying.**
- The Provisional Final merit position will be displayed on the University website after verification of uploaded scanned original certificates.

6. WEB OPTIONS FOR STRAY VACANCY ROUND(S)

Subject to vacancies arise, if any, the candidates those who are will to join under Stray Vacancy Round of Counselling, may exercise **options for interested category and colleges.**

Further, subject to vacancies arise, if any, after completion of Stray Vacancy Round-1, schedule for exercising web options for Stray Round-2 will be notified in the University website. Hence, the candidates are advised to get in touch with University website for updates.

- If the candidate is allotted a seat under this notification, he / she has to report in the allotted college compulsorily.**
- The Candidates are hereby informed that if they have secured admission in medical colleges of other states, joined the course and if they are involved in blocking the seats under management quota in Dr. NTR UHS, the university will initiate legal action and same will be informed to the National Medical Commission for further course of action.
- Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2024 Rank.
- The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
- An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
