1. The candidates of other States are not eligible for the Competent Authority Quota seats if they do not satisfy Local status/Non-Local status as per G.O.P.NO. 646, Education (W) Department, Dated 10th July, 1979 of Government of Andhra Pradesh (Presidential Order)

In view of Revised Cut-off Scores of NEET MDS-2024 after lowering of qualifying percentiles released by NBE, New Delhi notification dated 18-09-2024 issued in accordance with the Ministry of Health & Family welfare, Govt. of India Letter No.V.12025/84/2024-DE, dated 17-09-2024, Dr.NTR UHS invites Online applications from the eligible candidates for admission into vacant/un-filled seats of Post Graduate Dental Degree/Diploma Courses under Competent Authority Quota seats in Government and Private un-aided Non-Minority Dental Colleges in the State of Andhra Pradesh for the academic year 2024-25.
- 3. Candidates who have already applied for 2024-25 and are listed in the CQ Merit List do not need to reapply. All other application requirements notified in the earlier Notifications/Prospectus, dt.20-07-2024 shall remain unchanged.**
